NOTE 1 – DESCRIPTION OF PLAN

The following description of the CH Reynolds Electric, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only summarized information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established in 2001 by CH Reynolds Electric, Inc. (the “Company” or “Employer”) to provide benefits to all eligible employees, as defined in the Plan document. The Plan is currently designed and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration

The Company has appointed a 401(k) Committee to manage the operation and administration of the Plan. The Company has contracted with Reliance Trust Company to act as the custodian and trustee and ADP Retirement Service, a third-party administrator to process and maintain the records of participant data and Merrill Lynch, Pierce, Fenner & Smith Inc., as an investment advisor and consultant.

Eligibility

Employees of the Company who are over 21 years old are eligible to participate in the Plan.

Participant Contributions

Each year, participants may elect to contribute a specified dollar amount or percentage of their eligible compensation, not to exceed effective deferral limits imposed by the Internal Revenue Service (IRS). Participants may elect to have the Company contribute up to 90% of their eligible pre-tax or Roth after-tax compensation up to the amount allowable under the Plan document and current income tax regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer Contributions

The Company may make matching contributions and/or discretionary nonelective contributions under the Plan subject to certain eligibility requirements, as defined in the Plan. For the year ended December 31, 2024, the Company matched 50% of each eligible participant's contribution up to a maximum of 6% of the participant's compensation. There were no discretionary nonelective Employer contributions made for the year ended December 31, 2024.

Participant's Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, and allocations of the Plan's earnings and administrative expenses as well as Company's contributions, if any. The benefit to which a participant is entitled is that which can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions, plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts, plus changes in investment values related thereto, are based on years of continuous services. as described below.

Participants vest in the Company's matching and nonelective contributions based on the following schedule:

Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the custodian. Employer contributions are invested in the same manner as employee elective deferrals.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in all accounts. Loans are secured by the participant's vested balance. Such notes bear interest at the prime rate in the Wall Street Journal plus 1% and must be repaid to the Plan within a five-year period unless the note is used for the purchase of a principal residence in which case the maximum repayment period is thirty years. A participant may have 3 loans outstanding from the Plan at any time. Outstanding notes at December 31, 2024 carry interest rates ranging from 4.25% to 9.5%, and mature through 2029. Outstanding notes receivable from participants at December 31, 2023 carry interest rates ranging from 4.25% to 9.5%, and mature through 2028.

Payment of Benefits

Upon termination of service, death, disability, or retirement, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account, equal installment payments over the period of the life expectancy of the participant or the life expectancy of the designated beneficiary, or direct trustee to trustee rollovers. The Plan allows for the automatic lump sum distribution of participant vested account balances that do not exceed \$5,000.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes. The participant may only take withdrawal hardship distributions from elective deferrals.

Forfeited Accounts

Participants' accounts are Forfeited if the Employer contribution portion of a participant' account has not fully vested at the time of termination. These forfeited amounts are first used to pay administrative expenses of the Plan, then to reduce Company contributions into the Plan. Per the amendment of the plan on November 1, 2024, forfeitures of amount attributable to Employer contributions will be used to reduce any Employer contribution on a per payroll period basis. As of December 31, 2024 and 2023, there were forfeited non-vested accounts of \$89,560 and \$26,749, respectively. In 2024, \$33,624 of forfeitures were used to reduce Employer contributions.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Management fees charged to the Plan for investments in registered investment companies are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable from participants as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Income Taxes

The Plan has adopted a non-standardized form of a pre-approved plan document. The pre-approved plan has received an opinion letter from the Internal Revenue Service ("IRS") as to the non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

NOTE 3 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified the completeness and accuracy of:

- Investments and notes receivables from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Assets reflected in the supplemental Schedule H, 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies (mutual funds)

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from participants are managed by an affiliate of Reliance Trust Company, the custodian of the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION OR MODIFICATION

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and is subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant’s interest in the Plan.
