**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Michiana Hematology Oncology 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Michiana Hematology Oncology (the "Company" or "Employer") who have two months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may elect to contribute up to 90% of their pretax annual compensation, as defined in the Plan, with a total amount not to exceed maximum limits allowed by the Internal Revenue Code. The Plan allows for participant deferral "catch-up" contributions in excess of legal limits for participants who have attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Each year the Company makes a discretionary match of employees' salary deferral amounts. The match for the 2024 plan year was 50 percent of the first 5 percent of base compensation that a participant contributes to the Plan. Additional discretionary profit sharing amounts are contributed to the Plan as determined by Plan management. The Company did not make additional profit-sharing contributions for the 2024 plan year. Participants must be employed as of the last day of the Plan year and have worked a minimum of 1,000 hours to be eligible for employer matching contributions and profit sharing contributions. Plan participants direct the investment of their contributions and the employer matching contributions and profit-sharing contributions into the various investment options offered by the Plan.

Investment Options: Participating employees may select the investment funds in which contributions to their accounts are invested and may choose to allocate and reallocate amounts credited to their accounts among all or any combination of the investment funds. Earnings on the investment funds are allocated among the accounts of the participants that have elected to invest in each such fund.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting for the discretionary match and nonelective profit sharing contributions are based on years of continuous service. A participant vests in the discretionary match contributions beginning after two years and is fully vested after four years of continuous service. A participant vests in the nonelective profit sharing contributions beginning after two years and is fully vested after six years of continuous service. The non-vested balances are forfeited upon termination of service.

Payment of Benefits: Participants may withdraw, in the form of a single lump-sum distribution, all or some of the vested account balance upon termination of employment, attainment of age 59½, death or disability. Benefit amounts under \$1,000 are automatically distributed to participants.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's matching and/or profit-sharing contributions (b) Plan earnings and (c) forfeitures and charged with any withdrawals and an allocation of administrative expenses. Income and realized and unrealized gains and losses on investments are allocated to the participant accounts on each valuation date based on the earnings of the directed investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Notes Receivable from Participants: Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates that are determined by the trustee of the Plan. Principal and interest are paid through payroll deductions.

Forfeitures: Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. Forfeitures of \$35,935 were used to reduce employer contributions paid to the Plan during 2024. Forfeitures available to reallocate to participants or offset future matching contributions, as of December 31, 2024 and 2023 were \$36,431 and \$925, respectively.

Plan Termination: Although it has not expressed any intent to do so, the employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants shall become fully vested.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Subsequent Events: Plan management has performed their analysis of subsequent events for recognition and disclosure through September 23, 2025, the date these financial statements were available to be issued.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for various investments. The underlying investment are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Participant loans are reported at their outstanding balance, as the fair value of the loans is not practicable to estimate due to restrictions placed on the transferability of the loans. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to all investments held directly by the Plan.

*Mutual funds and exchange traded funds:* The fair values of mutual fund and exchange traded funds are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

*Collective trust:* The fair value of interest in the collective trust are based upon the net asset value per unit as reported by the fund manager of such fund after an adjustment to reflect all investments at fair value, including direct and indirect interests in the fully benefit-responsive contract, as reported in the audited financial statements of the fund as of the Plan's financial statement date. The collective trust provides for daily redemptions by the Plan, with no advance notification requirement or redemption restrictions.

*Self Directed Accounts:* Accounts primarily consist of common stock, mutual funds, and collective trusts. The fair value of common stocks and mutual funds are determined by obtaining quoted prices from a nationally recognized securities exchange (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Plan sponsor has adopted a prototype plan document sponsored by ADP, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service dated October 6<sup>th</sup>, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has not been issued an individual determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Reliance Trust Company is the Plan's custodian and, therefore, these transactions and the Plan's payment of custodial fees and investment management fees to the Plan's custodians qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also reflect party-in-interest transactions.
