Note 1 – Description of Plan

The following brief description of the Shelor Automotive Group 401(k) Plan & Profit Sharing Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Shelor Motor Mile Inc. and its subsidiaries, Food First LLC, DLR Group LLC, Calfee Park Baseball Inc., Jackson Park Inn Inc., Motor Mile Graphics LLC, and Shah Development LLC, (the “Company”) who have completed six months of service and are 18 years of age or older. Participants are automatically enrolled at 5% with 1% annual automatic increases, up to 15% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Starting January 1, 2024, employees who work at least 500 hours for two consecutive years of service are eligible to participate under the SECURE 2.0 Act effective January 1, 2026.

Contributions

Participants may contribute a percentage of their compensation as pre-tax deferrals and Roth contributions to the Plan, and may also contribute amounts representing distributions from other qualified plans, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company’s matching contribution is discretionary. The Company may also make an additional discretionary contribution. The Company did not contribute to the Plan during 2024 or 2023. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in discretionary employer contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Notes from Participants

Participants may borrow from their account the lesser of a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, as defined by the Plan. Loan terms range from 1 to 5 years, unless the note is for purchase of a primary residence, in which case the term may exceed 5 years. The loans are secured by the balance in the participant’s account and bear interest at market rates. At December 31, 2024, interest rates ranged from 4.25% - 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments. Mandatory distributions are required for vested balances of \$1,000 or less when a participant separates from service. In-service distributions are allowed at age 59 ½.

Administrative Expenses

Plan fees and administrative expenses are paid by the Company on a discretionary basis. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

Forfeitures

Forfeitures may be used to pay Plan expenses and reduce employer contributions, and any remaining forfeitures will be allocated to participants. There were \$2,250 and \$-0- in forfeited non-vested accounts at December 31, 2024 and **December 31, 2023**, respectively. There were no forfeitures used during the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Interest Bearing Cash

The Plan maintains interest bearing cash within the self-directed brokerage account. The amount of interest bearing cash as of December 31, 2024 and 2023 was \$257,689 and \$55,951, respectively.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through September 29, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available.

Level 1 Fair Value Measurements Including Self-Directed Account

The fair values of mutual funds and money market accounts, exchange traded funds, and corporate stocks held in the self-directed account are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the common collective fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The common collective fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

Note 4 – Investment Contracts

In 2024 and 2023, the Plan had investments in the Invesco Stable Value Retirement Fund. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for the fund for 2024 and 2023 was approximately 2.88% and 2.75%, respectively. The percentage of contributions allocated to the fund was determined by the participants.

Note 5 – Related-Party Transactions

Certain employees of the Plan’s Sponsor provide administrative and accounting services to the Plan at no additional cost to the Plan. These employees are also participants of the Plan.

Certain Plan investments are managed by Reliance Trust Company (Reliance). Reliance is the trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. Reliance provides certain administrative services to the Plan pursuant to a Services Agreement between the Company and Reliance. Reliance receives revenue from mutual fund and collective trust fund service providers for services Reliance provides to the funds. If the revenue received by Reliance from such mutual fund or collective trust fund service providers exceeds the amount owed under the Services Agreement, Reliance remits the excess to the Plan in full with no amounts used to offset administrative fees. Such amounts may be allocated to the accounts of the participants. During 2024, no funds were used to pay Plan expenses from the revenue credit account.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan has adopted a prototype plan sponsored by ADP, LLC. The Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has obtained the most recent favorable opinion letter from the IRS dated October 6, 2020. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
