Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Notes To Financial Statements

Note 1: Description Of Plan

The following description of the Keymark-Kasson & Keller, Inc. 401K Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted August 1, 1985 and is a defined contribution 401(k) plan established to provide retirement benefits for employees of Keymark Ventures, Inc. and Kasson & Keller, Inc. and participating affiliates (the Companies). Eligible employees become participants in the Plan following three months of eligible service and attainment of age 18, as defined in the Plan agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 50% of eligible compensation as defined by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain Internal Revenue Code limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make matching contributions equal to a discretionary percentage, of the participant's salary reductions, to be determined by the Companies. The Plan also includes a Safe Harbor Matching contribution equal to 100% of the Participant's Elective Deferrals not to exceed 4% of the Participant's Compensation.

Participants' accounts - Each participant's account is credited or charged, as applicable, with the participant's contribution, allocations of the Companies' contributions, if any, earnings (losses), payments, forfeitures, withdrawals, expenses, or other distributions made to or from such accounts during the period. Allocations are based on participant earnings or account balances in accordance with the terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions, rollover contributions, safe harbor contributions, and investment earnings thereon. A participant's vested interest in the Companies' discretionary contributions, if applicable, is defined by the Plan document and is based on the number of years of continuing service. A participant is 100% vested after six years of credited service.

Payment of benefits - On termination of service or separation of service, due to death, disability, or retirement, a participant or their beneficiary will be entitled to receive a distribution of their total vested account balance. Benefits will be paid in accordance with the terms of the Plan.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are made in accordance with the terms of the Plan.

Note 1: Description Of Plan (Continued)

Plan termination - Although they have not expressed any intention to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, each participant's account will become fully vested and be distributed in accordance with the Plan Agreement.

Forfeited accounts - At December 31, 2024 and 2023, the Plan had forfeitures from terminated, non-vested participant accounts of \$295 and \$267, respectively. These amounts can be used to offset Plan expenses or reduce employer contributions. During the years ended December 31, 2024 and 2023, forfeitures, which include earnings, were used to pay plan expenses and reduce employer contributions to the Plan in the amount of \$2,075 and \$3,478, respectively.

Note 2: Summary Of Significant Accounting Policies

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes To Financial Statements

Note 2: Summary Of Significant Accounting Policies (Continued)

Dividend income is recorded when earned based on the ex-dividend date. Interest is recorded when earned on the accrual basis. Purchases and sales of securities are reflected on a trade date basis. Gains or losses on sales of securities are based on the actual cost of the securities sold. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a prototype non-standard profit-sharing plan which has received an opinion letter, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on net assets available for benefits or changes in net assets available for benefits.

Note 3: Investments

The statements of net assets available for benefits as of December 31, 2024 and 2023, the investment activities included in the statements of changes in net assets available for benefits for the years then ended and the accompanying notes to the financial statements (other than the assignment of levels) were prepared in part or entirely from information certified by Reliance Trust Company, the Trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments and notes receivable from participants of \$16,867,574 and \$13,211,605 at December 31, 2024 and 2023, respectively, and related investment income of \$1,803,369 and \$1,678,430 for the years ended December 31, 2024 and 2023, respectively.

Note 4: Fair Value Measurements

Mutual Funds: Valued based on quoted market prices.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

Effective September 1, 2025, the Plan was amended to allow for Roth elective deferrals.
