Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Behavior Frontiers, LLC 401(k) Plan employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Behavior Frontiers, LLC 401(k) Plan, (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Eligibility

The Plan is a defined contribution plan that includes all employees who are at least the age of 18 and have completed six-months of eligible service. The participant enters the Plan on the first day of the month following the completion of eligibility requirements.

The Plan was established and became effective September 30, 2007, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may make pre-tax elective deferrals or Roth elective deferrals from his or her annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant does not direct contributions, the contributions are credited to the Fidelity Freedom Index fund based on the age of the participant (the default investment fund). The Plan Sponsor may contribute 50 percent of the first 4 percent of base compensation that a participant contributes to the Plan. The matching Sponsor contribution is invested as directed by the participant. Contributions are subject to certain IRS limitations.

If the participant does not complete a salary deferral agreement for elective deferrals within 30 days after becoming eligible, the Plan Sponsor will automatically withhold 2% of eligible earnings and contribute the amount to the Plan as pre-tax elective deferrals. Automatic contributions will be invested in the default investment fund.

Participant Accounts

Each participant’s account is credited with participant elective deferrals, Plan Sponsor matching contributions as well as Plan earnings. Participants’ accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Administrative fees for certain services or transactions requested by the participant may be charged directly to the participant’s account.

Vesting

Vesting is based upon years of continuous service. Participants are always 100% vested in elective deferral, safe harbor, and rollover contributions. A participant is 100% vested after three years of credited service for matching contributions.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

A participant becomes 100% vested in the participant's total account balance if termination is due to death, disability or attaining the age of 65.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range up to 5 years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of published prime rate plus two percent.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or to receive installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$109,848 and \$97,863, respectively. These accounts will be used to reduce Employer Contributions or pay Plan administrative expenses. For the year ended December 31, 2024, Employer Contributions were not reduced by forfeiture account funds. For the year ended December 31, 2024, administrative fees totaling \$115,690 were paid from the forfeitures account. The employer/sponsor of the Plan absorbs all administrative costs of the Plan not covered by the forfeiture account. For the year ended December 31, 2024, the employer/sponsor did not pay any administrative fees on behalf of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. At December 31, 2024, and 2023, the Plan did not have fully benefit-responsive investment contracts.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest rates on loans are at the published prime rate plus two percent. No allowance for credit losses has been recorded at December 31, 2024, and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For the years ended December 31, 2024, and 2023, there were no excess contributions.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan and are included in these financial statements. Fees related to the administration of notes receivable and distributions from/to participants are charged directly to the participant's account and are included in administrative expenses. Investment expenses, at the fund level, are included in net appreciation/depreciation of fair value of investments. Investment advisory services provided to the Plan or its participants are paid by the Plan. For the year ended December 31, 2024, investment advisory fees were \$28,076 and are include in "Loan and administrative expenses" on the accompanying statement of changes in net assets available for benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Generally Accepted Accounting Principles (GAAP) are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan Sponsor directly pays any fees related to the Plan's operations, except for fees initiated by a participant (i.e. loan request and withdrawal) or fees paid from the forfeiture account. As described in Note 2, for the year ended December 31, 2024, the Plan paid \$115,690 in administrative fees from the forfeiture account. For the year ended December 31, 2024, the employer/sponsor did not pay any administrative fees on behalf of the Plan.

NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended November 19, 2009, November 18, 2010, April 1, 2019, and again on August 11, 2023, to remain in compliance with applicable laws and regulations of the Department of Labor and Internal Revenue Service.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's annual tax return generally remains open for examination for the three preceding years.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire account balance.

NOTE 7 – ADMINISTRATION OF PLAN ASSETS

Certain administrative and accounting functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

NOTE 8 – RISKS AND UNCERTANTIES

The Plan invests, at the direction of the participants, in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and 2023, net appreciation or depreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 10 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciling differences from the financial statements to form 5500.

NOTE 11 – SUBSEQUENT EVENTS

Subsequent events were evaluated through September 28, 2025, which is the date the financial statements were available to be issued.
