

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
  - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**1. Description of Plan**

The Seven-Eleven (Hawaii), Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) was initially adopted in January 1990. The Plan was amended at various dates since adoption to reflect changes in the applicable laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The following description of the Plan provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

Principal provisions of the Plan are as follows:

**Plan Amendments**

The Plan was amended, effective January 1, 2008, to be a safe harbor plan. The amendment affected the Plan’s employer contribution and vesting provisions. The Plan was amended and restated at various dates, the latest effective January 1, 2023, to reflect changes in the applicable laws and regulations and did not significantly impact the terms of the Plan.

These amendments and restatements occurred during the 2018 through 2023 plan years and served to update the Plan’s disability claims procedures, administration of hardship distributions, and the adoption of interim provisions included in the Setting Every Community Up for Retirement Enhancement (“SECURE”), Coronavirus Aid, Relief, Economic Security, and SECURE 2.0 Acts.

**Eligibility**

Employees of the Company shall become eligible to participate in the Plan upon completing one year of service of at least 1,000 hours.

**Contributions – Employer**

The Company makes a safe harbor matching contribution equivalent to 100% of the first 3% of deferrals made by eligible participants and 50% of the next 2% of deferrals made by eligible participants per plan period, in accordance with provisions of the Plan.

**Contributions – Participants**

Contributions by employees are voluntary and shall not exceed the maximum allowable under the Internal Revenue Code (“IRC”). At the administrative committee’s discretion, rollover contributions may be accepted from another qualified plan. The Plan gives employees the right to direct the investment of funds held in their participant accounts.

**Allocation to Accounts**

Separate elective, matching, safe harbor, and rollover contribution accounts are maintained for each participant, as applicable. Each account is credited with the participant’s share of contributions and allocation of income or loss as defined. The benefit to which a participant is entitled is based on the participant’s vested account balance.

**Vesting**

Participants are fully and immediately vested in the balance of their elective, safe harbor, and rollover contribution accounts. Such balances are not subject to forfeiture.

Benefits in the matching contribution accounts vest 20% annually commencing after two years with full vesting after six years of service.

These accounts become fully vested and nonforfeitable upon (1) the participant attaining age 65 or becoming deceased or disabled while employed by the Company; or (2) the complete discontinuance of employer contributions to the Plan.

**Withdrawals by Active Participants**

Subject to the approval of the plan administrator, participants may make withdrawals from their elective accounts and the vested portion of their matching contribution accounts to satisfy a financial hardship, as described in the Plan.

**Payment of Benefits**

Participants may receive benefits in a lump sum distribution or a direct rollover as outlined by the plan document.

**Forfeited Accounts**

At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

**Participant Loans**

Subject to the approval by the administrative committee, participants may borrow up to 50% of their vested account balances. The amount of any new loan shall not exceed \$50,000, reduced by the participant's highest outstanding loan balance during the preceding 12 months. All loans are secured by the participant's account balance, bear a reasonable rate of interest, and have a definite repayment schedule.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions or terminate the Plan at any time subject to the provisions of ERISA. If the Plan is completely or partially terminated, participant interests in their matching contribution account shall become fully vested.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The Plan prepares its financial statements under the accrual method of accounting.

**Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options in investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Fair Value Measurements**

The Plan measures the fair value of assets and liabilities as the price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market participants at the measurement date. The fair value hierarchy distinguishes between independent observable inputs and unobservable inputs used to measure fair value, as follows:

- **Level 1** – Quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.
- **Level 2** – Inputs other than quoted market prices included within Level 1 that are observable for an asset or liability, either directly or indirectly.
- **Level 3** – Unobservable inputs for an asset or liability reflecting the reporting entity's own assumptions. Level 3 inputs should be used to measure fair value to the extent that observable Level 1 or Level 2 inputs are not available.

The level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. The Plan has several pooled separate account investment funds under its group annuity contract with John Hancock Life Insurance Company (U.S.A) ("John Hancock") available for participants to direct their investments in. Investments in pooled separate accounts are valued on a per unit basis as determined by John Hancock, which reflects the market value of the investments comprising the separate pooled funds on the last business day of the plan year. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investment will sell for an amount different from the reported net asset value.

There were no unfunded commitments or restrictions on the participants' ability to redeem their investments in the pooled separate accounts at December 31, 2024 and 2023.

The Plan presents in the statement of changes in net assets available for benefits, the net increase in fair value of pooled separate accounts, which consists of realized gains or losses and the unrealized appreciation or depreciation from pooled separate accounts.

**Contributions**

Contributions from participants are recorded in the period the Company makes payroll deductions from plan participants.

Contributions from the Company accrue based on defined provisions in the plan document.

**Payment of Benefits**

Benefits are recorded when paid. There was \$8,313 of benefits paid in 2025 to participants who elected to withdraw funds in 2024. There was \$13,654 of benefits paid in 2024 to participants who elected to withdraw funds in 2023.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when received. Related fees are recorded as benefits paid to participants when paid. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan is reclassified as a distribution based upon the terms of the plan document. There were no notes receivable from participants outstanding as of December 31, 2024 or 2023.

**Income Taxes**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Subsequent Events**

The Plan has reviewed all events that have occurred from January 1, 2025 through September 30, 2025, the date that the financial statements were available for issuance, for proper accounting and disclosure in the financial statements.

**3. Investments**

The plan administrator continued to elect the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained a certification from John Hancock, the trustee of the Plan, that all of the following information provided by the trustee is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- All investments reported in the statements of net assets available for benefits at December 31, 2024 and 2023.
- Net increase in fair value of pooled separate accounts presented in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- All information contained in the supplemental schedule.

**4. Tax Status**

The Plan is relying upon an opinion letter dated June 30, 2020 issued by the Internal Revenue Service ("IRS"), under the IRS's preapproved plan program that the Plan constituted a qualified trust under Section 401(a) of the Internal Revenue Code ("IRC") and is therefore exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended and restated since receiving the advisory letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

**5. Related-Party Transactions**

The Plan's investments in pooled separate accounts are managed by John Hancock. John Hancock is the recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for plan administration services amounted to \$79,709, for the year ended December 31, 2024.
