Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024

1. Description of the Plan

The following description of the Associated Insurance Management, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the benefit of all full-time employees and eligible part-time employees of Associated Insurance Management, LLC (the Company or the Plan Sponsor) and its subsidiaries. New full-time employees, or scheduled part-time employees achieving 1,000 hours of service, are immediately eligible to participate.

The Associated Insurance Management, LLC Plan Committee (the Committee) is responsible for the general administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a/ Principal Trust Company (Principal), a member of Principal Financial Group (PFG), is the trustee and record keeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make pretax contributions, through payroll deductions, up to the maximum amount allowed by law, but in no event more than \$23,000 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the year can contribute up to an additional \$7,500 under the "Catch-up" provision, provided their 401(k) elective deferral meets the annual IRS limit of \$23,000 by year-end. Participants are also able to make after tax Roth contributions to their 401(k) accounts, in the same way a pretax contribution is made and the same limits apply. Under no circumstances can the combined amount of both the pretax and after-tax contributions exceed \$23,000 for 2024, and if applicable, \$7,500 for the Catch-Up provision.

The Plan provides for a safe harbor non-elective contribution equal to 3% of each eligible participant's compensation. For 2024, the Company approved a matching contribution equal to 100% of the participant's elective deferral contribution up to 2% of each participant's compensation.

The Company may make a discretionary profit-sharing contribution, subject to certain limitations as defined by the Internal Revenue Service (IRS). For 2024, the Company did not make discretionary profit-sharing contributions.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, earnings or losses, and administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions, employer and employee, plus actual earnings or losses thereon.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 (not to exceed 50% of their vested account balance). Loan repayment terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates at regional banks for similar loans. Principal and interest are paid ratably through biweekly payroll deductions. If the loan is not repaid, it will automatically be treated as a distribution to the participant after 3 months. Terminated employees can also choose to continue loan payments through ACH payments made directly to the recordkeeper instead of defaulting to a plan distribution.

Payment of Benefits

On termination of service, death, disability, retirement, or attainment of age 59½, a participant may receive a lump-sum amount up to the value of the participant's vested interest in his or her account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

1. Description of the Plan (continued)

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping, plan consulting and investment advisor, audit and trustee fees. The trustee either charges a fee to each participant against their invested assets or applies the fees pro-rata to the Plan participants.

Expenses relating to the purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which expenses relate. Loans and withdrawal fees are paid directly by the participant; all other administrative expenses of the Plan are paid by the Plan Sponsor.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The vesting provisions are unchanged in the event of a Plan termination.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is withheld.

Payment of Benefits

Benefits are recorded when paid. There were no outstanding benefit requests as of December 31, 2024.

2. Summary of Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest, which approximate fair value. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Valuation of Investments and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the consideration received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price).

Investments in mutual funds are stated at fair value based on quoted redemption values on the last business day of the plan year. The common/collective trust fund is valued at net asset value (NAV) using the practical expedient.

Purchases and sales of securities are recorded on a trade-date basis, and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought, sold and held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

3. Investments

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and interest and dividends, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal, the trustee of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities. The types of financial instruments included in Level 1 are mutual funds.

Level 2 – Inputs are other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active or observable inputs other than quoted price that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk). There are no financial instruments that are included in this category at December 31, 2024 or 2023.

The level in the fair value hierarchy within which fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. Our assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the financial instrument.

^(a) This category includes a common/collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions, unless payments are being delayed to all fund unit holders; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund. In addition, in accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Mutual funds are recorded at fair value at the NAV of shares held by the Plan at year end. The NAV of mutual funds are based on quoted prices in active markets that are publicly available. As such, mutual funds are generally categorized as Level 1 of the hierarchy.

5. Expenses

Certain expenses incurred on behalf of the participants, such as loan application fees, are paid via a reduction in the participant's account. Any fees received from individual mutual funds as part of revenue-recapture agreements are allocated to the Plan and used to offset Plan expenses. The Plan received \$21,865 during 2024 to offset Plan expenses, including investment advisor fees and other service fees.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Income Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. The Plan Administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

7. Income Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

The Plan holds outstanding loans with its participants. These transactions qualify as party-in-interest transactions, however are exempt from the prohibited transaction rules under ERISA.

9. Subsequent Events

Management has assessed material subsequent events through September 30, 2025, the date the financial statements were available to be issued.
