Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Amsdell Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Amsdell Companies 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Amsdell Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering all employees of Amsdell Companies LLC (the “Company”), who are twenty-one years of age or older and have ninety days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute up to the maximum allowable amount permitted by the Internal Revenue Code and as defined by the Plan. Unless the participant elects a different percentage or elects not to participate in the plan, the Company automatically withholds two percent from the employee’s pay and contributes this amount to the plan as deferral contributions. The Company automatically increases this percentage by one percent annually, up to a maximum of eight percent of pay. The Company provides a discretionary matching contribution which amounts to 25% of the first six percent of pay that a participant contributes to the Plan.

Participant accounts

Each participant’s account is credited with the participant’s elective contributions, allocations of the Company’s matching contributions and earnings on those contributions and charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options

Participants may direct their contributions to any or all of the investment options offered by the Plan. Participants may change their allocation of contributions or transfer money between investment options any time during the year.

Vesting

Participants are immediately vested in their elective deferrals plus the actual earnings thereon. Vesting in the Company’s matching contribution plus actual earnings thereon is based on years of continuous service. All participants are 100% vested after 1 year of credited service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of benefits

Upon termination, a participant is entitled to receive his or her vested account balance either as a lump sum distribution, in installments or as a life annuity. Participants may receive in-service distributions after reaching age 59 ½.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The foregoing notwithstanding, the amount of such loan shall not exceed 50% of the amount of the participant's vested account. Note transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. The note term is limited to five years. The notes are secured by the balance in the participant's account and bear interest at a rate determined at the time the note is taken based on the rates available for similar loans from commercial lending institutions. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeited non-vested accounts are first used to pay plan expenses and then used to reduce future employer contributions. During the year ended December 31, 2024, there were no employer contributions that were reduced from forfeited non-vested accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,057 and \$2,061, respectively.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

Direct costs that are incurred with respect to the Plan, such as recordkeeping, administrative expenses and custodian and investment advisory fees, are paid by the Plan. Expenses that relate solely to a specific participant, may be assessed against the specific participant.

NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN - UNAUDITED

The custodian (The Principal Life Insurance Company) of the Plan holds the Plan's investments and executes all investment transactions. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets (held at end of year) are based solely on information provided and certified to be complete and accurate by the custodian. The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the information summarized below has not been audited.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts, collective investment trusts and mutual funds managed by Principal Life Insurance Company. The Principal Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as allowable party-in-interest transactions under ERISA.

NOTE 6 – FAIR VALUE MEASUREMENTS

The Fair Value Measurement Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB codification guidance are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – valued at the net asset value (NAV) based on the market value of its underlying investments. The NAV is not a publicly quoted price in an active market but it is available to current investors. The NAV is the basis for current transactions and the pooled separate account can be redeemed at NAV as of the measurement date. The pooled separate accounts are deemed to have a readily determinable fair value.

Collective investment trusts (not fully benefit-responsive) – valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – INCOME TAX STATUS

The custodian of the Plan has received an advisory letter from the Internal Revenue Service stating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and that any employer adopting the form of this plan will be considered to have a plan qualified under Section 401 of the IRC. Therefore, the Plan is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
