## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the United Cerebral Palsy Association of the North Country, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) pension plan covering substantially all employees of United Cerebral Palsy Association of the North Country, Inc. (the Association) who have at least one year of service in which 1,000 hours were worked and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Association sponsors and administers the Plan. Reliance Trust Company (Reliance) is the custodian of the Plan's assets. Transamerica Retirement Solutions, LLC (Transamerica) is the record-keeper of the Plan.

#### **Contributions**

Each year, participants may elect to contribute a percentage of their annual wages on a pre-tax basis to the Plan. Participants age 50 and over are also permitted to make additional "catch-up" contributions. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (the Code). Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans.

The Association made discretionary contributions to the Plan of approximately 5% of each eligible participant's compensation in 2024 and 2023. Eligible participants must be employed at the Association at the end of the year and in the Plan at the date of contribution. The Plan was amended in 2022 to exclude bonuses from compensation for purposes of calculating the Association's contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Association's contributions and an allocation of Plan earnings/losses on contributions. Allocations of earnings/losses and administrative expenses are based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings/losses thereon. Vesting in the Association's contributions plus earnings/losses thereon is based on years of service. Participants are 20% vested in the Association's contribution after two years of service. Vesting increases in increments of 20% for each additional year of service thereafter until 100% vesting occurs after six years.

#### **Participant Loans**

Participant loans are not permitted by the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### **Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, or deferred annuity.

The normal retirement age is the date upon which a participant reaches age 65. Participants may also receive hardship distributions under certain circumstances, as defined. All account balances less than \$5,000 are automatically paid out in a lump sum.

### **Forfeitures**

The non-vested portion of terminated participant account balances is subject to forfeiture. Forfeitures are used to reduce employer contributions to the Plan. Forfeitures of approximately \$46,800 and \$16,700 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures at December 31, 2024 and 2023 were \$46,000 and \$11,300, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

### **Risks and Uncertainties**

The Plan's underlying investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the accompanying financial statements.

### **Fair Value of Financial Instruments**

GAAP establishes a framework for measuring fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly, are considered level 2 measurements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value of Financial Instruments (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Registered investment companies:* Valued at the net asset value of shares held at year end based on quoted prices in active markets.

There were no changes in the valuation techniques during 2024 and 2023.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

### **Allowance for Credit Losses**

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions, therefore management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 or 2023.

### **Benefit Payments**

Benefits are recorded when paid.

### **Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid by participants.

### **Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that may affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 4. STABLE VALUE FUND

The Plan is invested in a fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company. Transamerica Financial Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest rate was at an average of 2.05% and 1.65% during 2024 and 2023, respectively.

As described in Note 2, because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The stable value fund is not considered a guaranteed interest contract and there is no stated minimum or maximum interest rate. Contract charges may reduce the return. Prior to January 1<sup>st</sup> and July 1<sup>st</sup>, the effective annual rate of interest is established for the corresponding six-month period. Although plan participants generally may withdraw assets from the stable value fund without restrictions, Transamerica Financial Life Insurance Company may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

## 6. PARTY IN INTEREST TRANSACTIONS

Reliance is the custodian of the Plan's assets. Transamerica is the recordkeeper of the Plan. Therefore, transactions between Reliance, Transamerica and the Plan qualify as party in interest transactions.

## 7. INCOME TAXES

The volume submitter plan has obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Association has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

## 9. RECONCILIATION TO FORM 5500

The classification of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, differs between these financial statements and Form 5500. However, the total changes in net assets available for benefits for the years then ended agrees between these financial statements and Form 5500.

## 10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
