In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement

resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024

1. Plan Description

The following description of the Lear Corporation Salaried Retirement Program (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan established to encourage and facilitate systematic savings and investment by eligible salaried employees of Lear Corporation (the Company) and may, from time to time, cover certain salaried employees of the Company's wholly owned U.S. subsidiaries and certain of the Company's less than wholly owned U.S. subsidiaries and affiliates. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), applicable to defined contribution pension plans.

Eligibility

Generally, full-time, U.S. salaried employees are eligible to participate in the Plan as soon as administratively practicable following commencement of employment. Generally, part-time, U.S. salaried employees who have completed 1,000 hours of service in the one-year period following commencement of employment, or during any calendar year commencing thereafter, are eligible to participate in the Plan effective as of the January 1 or July 1 following the one-year period in which they complete 1,000 hours of service.

Contributions

The Plan allows for standard before-tax contributions and for catch-up before-tax contributions. Catch-up contributions are available to employees who are eligible to contribute to the Plan and who have attained (or will attain) age 50 before the close of the Plan year. Both before-tax contributions and catch-up contributions contain a Roth 401(k) (Roth) contribution feature that allows participants to contribute to the Plan on an after-tax basis in lieu of all or a portion of before-tax contributions. The Plan also contains an in-Plan Roth conversion feature that allows participants to convert non-Roth funds to a Roth account within the Plan. The aggregate amount of before-tax, Roth and catch-up contributions may not exceed 75% of eligible compensation, as defined, subject to certain limitations.

Notes to Financial Statements (continued)

1. Plan Description (continued)

If an eligible employee first hired on or after December 10, 2008, fails to elect to make contributions under the Plan and fails to opt out of making contributions under the Plan following his or her hire or rehire date, such employee will be deemed to elect a 6% before-tax contribution. On June 1 of each year, automatically enrolled employees' deferral percentages will be increased by 1%, unless the participant opts out of such increases or the participant's deferral percentage reaches 10%. In the event that a participant has not elected investment directions for his or her contributions, such contributions are invested in the default fund that is designated by the Plan administrator and intended to serve as a qualified default investment alternative.

The Plan provides eligible salaried employees, excluding former Ford Favesa employees, with a Company matching contribution of 100% of the first 3% of compensation contributed to the Plan, plus 50% of the next 3% of compensation contributed to the Plan, subject to certain limitations. Eligible salaried employees must be actively employed on the last business day of the semiannual period or must have died or retired during such semiannual period. Former Ford Favesa employees are subject to a modified matching contribution schedule. Catch-up contributions are not matched.

The Company may make a discretionary matching contribution on an annual or semiannual basis in an amount as determined by the Company, in its sole discretion. No such contributions were made for the year ended December 31, 2024.

The Company also makes Pension Savings Plan (PSP) contributions based upon the age and service of each eligible salaried employee as of January 1. PSP contributions are made on a semiannual basis for periods ending on June 30 and December 31, based upon the eligible compensation earned during the relevant semiannual period. Eligible salaried employees must be actively employed on the last day of the semiannual period or must have died or retired during such semiannual period. For the year ended December 31, 2024, PSP contributions were \$24,273,389 and ranged from 3% to 12% of compensation.

Participants direct the investment of their contributions into investment options offered by the Plan. Company contributions are invested in the same funds and in the same proportions as participant contributions. In the event that a participant has not elected investment directions, company contributions are invested in the default fund that is designated by the Plan administrator and intended to serve as a qualified default investment alternative.

Notes to Financial Statements (continued)

1. Plan Description (continued)

Participant Accounts

Each participant's account is credited and/or debited with (a) the participant's contributions, (b) company contributions, (c) withdrawals and distributions, (d) the participant's share of earnings and/or losses associated with his or her investment options and (e) allocation of any administrative expenses that are paid from the Plan's trust fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Benefits

Participants vest immediately in their participant contributions and actual earnings thereon, if any.

Participants generally vest in the Company's contributions and actual earnings thereon, if any, at a rate of 20% per year and are 100% vested after completion of five years of service or upon termination of employment due to disability (as defined in the Plan document), death or the attainment of age 65 at or prior to termination of employment.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, in accordance with the Plan's provisions. Expenses relating to purchases, sales or transfers of the Plan's investments are generally charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan may be paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Plan Forfeitures

If a participant terminates employment, any non-vested amounts are forfeited. Forfeited amounts are retained in the Plan and are used to reduce future company contributions and/or pay the expenses of the Plan. Effective December 17, 2024, forfeited amounts will only be used to reduce future company contributions. There were \$735,891 and \$295,234 of unallocated forfeitures included in the Plan's assets as of December 31, 2024 and 2023, respectively. In 2024, unallocated forfeitures of \$1,672,160 were used to reduce company contributions.

Distributions of Benefits

Benefits due upon death, termination, withdrawal or disability are paid in a lump sum or installments for up to 20 years, as applicable, and are based on vested amounts in the participants' accounts. In addition, terminated participants with benefits due in excess of \$7,000 (\$5,000 prior to July 1, 2024) may defer distribution of such benefits until April 1 of the calendar year subsequent to the calendar year in which the participant attains age 70½ or age 73 for participants who attained age 70½ on or after January 1, 2020.

In accordance with the Setting Every Community Up for Retirement Enhancement Act of 2019, for participants who die after December 31, 2019, the entire balance of the participants' accounts must be distributed within ten years. There are exceptions for (a) a surviving spouse, (b) a child who has not reached the age of majority, (c) a disabled or chronically ill person or (d) a person not more than ten years younger than the participant.

Participants may elect to make a withdrawal of certain components of their account balance during employment. A participant may withdraw up to 100% of the vested value of (a) certain components of his or her account on or after the attainment of age 59½; (b) any pension savings plan account after attainment of age 65; (c) his or her rollover account and, to the extent applicable, after-tax contribution account; or (d) certain components of his or her account by requesting a hardship withdrawal due to certain immediate and heavy financial needs of the participant. Other withdrawal options and/or forms of benefit payment may be available with respect to participants who were covered under certain plans that were previously merged into the Plan.

Participant Loans

Participants may borrow from the Plan a minimum of \$1,000 up to a maximum of the lesser of (a) \$50,000, reduced by the highest outstanding balance of all other Plan loans to the participant during the one-year period ending on the day before the date such loan was made, or (b) 50% of his or her vested account balance. Interest is payable based on the annual prime rate as published by *The Wall Street Journal* on the first business day of the month immediately preceding the month the loan is originated, plus one percentage point. Repayment of any loan is generally made through employee payroll deductions over a period of five years or less. Generally, a participant's loan shall be considered to be in default if no payment is made by the last day of the calendar quarter following the calendar quarter in which the payment was due. If the participant is age 59½ or older upon default and upon the participant's request, the unpaid loan balance can be offset by an equal

amount of the participant's account and shall be treated as a withdrawal from the Plan. If the participant is under age 59½, to the extent the unpaid loan balance is attributable to amounts that are available for in-service withdrawal, the amounts available for in-service withdrawal shall be treated as a withdrawal from the Plan and shall be used to offset the unpaid loan balance. If any portion of the unpaid loan balance cannot be satisfied by these terms, such portion shall be treated as a deemed distribution.

Plan Termination

Although it has not expressed the intent to do so, the Company may discontinue its contributions or terminate the Plan at any time, subject to the provisions of ERISA and the Internal Revenue Code (the Code). In the event of complete discontinuance of company contributions or the total or partial termination of the Plan, the accounts of the participants affected by such actions shall become 100% vested and nonforfeitable.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator determines the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts stated at contract value) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements and Note 5 for further discussion of the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

As of December 31, 2024 and 2023, the net assets of the Plan are held by the Lear Corporation Salaried Retirement Program Trust; the trustee of the Plan is Empower Trust Company, LLC (Empower or Trustee); and the custodian of the self-directed brokerage accounts maintained under the Plan is Charles Schwab Bank.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in the fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Trustee of the Plan. The fair value of the underlying investments of the self-directed brokerage accounts was not certified by the Trustee.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

4. Fair Value Measurements (continued)

The fair value of the Plan's assets is measured on a recurring basis. The following is a description of the valuation technique and input used for the general type of assets measured at fair value by the Plan:

Market: This approach uses prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Mutual funds: Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Collective investment trusts: Valued at the NAV as provided by the administrator of the fund.

Pooled separate accounts: Valued at the NAV in a private market as provided by the administrator of the fund.

Self-directed brokerage accounts: Accounts primarily consist of common stock, exchange traded funds, mutual funds, money market funds and cash. Common stock and exchange traded funds are valued at the closing pricing on the active markets in which the individual securities are traded. Mutual funds and money market funds are valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end. The accounts also contain U.S. government and corporate obligations, which are valued using independent pricing services with inputs that are principally derived from or corroborated by observable market data.

5. Fully Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract with New York Life Insurance Company (NYL Insurance) that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

NYL Insurance maintains the contributions in a pooled separate account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value. For example, withdrawals due to events initiated by the Company,

including, but not limited to, total or partial termination of the Plan, group layoffs or early retirement incentives, may result in a penalty if these withdrawals exceed limitations defined in the contract. The Company believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. NYL Insurance may not terminate the contract at any amount less than contract value.

NYL Insurance is contractually obligated to pay the principal and any interest and dividends that have been credited to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed not less frequently than quarterly nor more frequently than daily for resetting.

6. Risks and Uncertainties

The Plan's exposure to a concentration of credit risk is dependent upon the funds selected by the participants. Investment securities are exposed to various risks and uncertainties, such as interest rate, market volatility and credit risks, as well as economic changes, political unrest and regulatory changes.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Income Tax Status

The Plan received a determination letter from the Internal Revenue Service (the IRS) dated September 21, 2021, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this IRS determination, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

7. Income Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Related-Party and Party-in-Interest Transactions

The Plan holds investments managed by Empower, the Trustee of the Plan. The transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

9. Subsequent Events

Management evaluated subsequent events for the Plan through August 25, 2025, the date that the financial statements were available to be issued.
