Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of Morristown Drivers Service, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from Morristown Drivers Service, Inc. (the “Plan Sponsor”).

General

The Plan is a defined contribution plan and is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). All employees, other than highly compensated employees, as defined by the Plan Document, who have completed 60 days of qualifying services and are 21 years of age or older, are eligible to become participants in the Plan. Eligible employees are allowed to enter the Plan on the first day of the month following the date eligibility requirements are met.

Contributions

Participants may make contributions to the Plan up to 100% of their pre-tax or post-tax annual compensation, as defined in the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change the investment options previously elected at any time.

The Plan Sponsor may make discretionary matching contributions up to 4% of participants’ eligible compensation, and only salary deferrals up to 6% of participants’ eligible compensation are considered for matching contributions. For 2024, the Plan Sponsor elected to make matching contributions equal to 50% of the employee’s contributions up to 5% of the participant’s eligible compensation.

Cash contribution receivables, if any, are unsecured.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant’s relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their elective salary deferral contributions, rollover contributions from other qualified plans, and related earnings thereon. Vesting in the Plan Sponsor's discretionary matching contributions plus related earnings thereon is based on years of vesting service, in which the participant completes 1,000 hours of service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiaries) shall receive a lump sum amount equal to the vested value of his or her account. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions in accordance with the Internal Revenue Code (IRC). In-service hardship withdrawals are also available in certain circumstances.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or plan expenses. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Agreement. During 2024, administrative expense were reduced by \$6,527 from forfeited non-vested accounts. The forfeiture account, which is included in the Plan's assets, totaled \$3,513 and \$6,573 as of December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and the IRC.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investments

Transamerica Life Insurance Company (Transamerica) holds the Plan's investments in various pooled separate accounts and a fully benefit-responsive contract. The investments, with the exception of its fully benefit-responsive contract, are stated at fair value. Fully benefit-responsive contracts are valued based on contract value. Net appreciation or depreciation in the fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. This includes all investments bought or sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient, would be the recorded amount of such investment.

Excess Contributions Payable

Amounts payable to participants totaling \$8,088 as of December 31, 2024, for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

Benefit Payments

Benefits are recorded when paid.

2. Significant Accounting Policies

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by ERISA Services, Inc. that received a favorable opinion letter from the IRS dated June 1, 2021, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and interest income from the Transamerica Stable Value Core Option and net realized and unrealized appreciation in the fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

The Plan has two investments, the American Funds International Growth and Income and the Janus Henderson Enterprise pooled separate accounts, that represents 21% and 20%, respectively, of net assets available for benefits as of December 31, 2024. The Plan has one investment, the Janus Henderson Enterprise pooled separate account, that represents 22% of net assets available for benefits as of December 31, 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820, *Fair Value Measurements*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued using their daily net asset value (NAV) practical expedient based on the NAV of the underlying mutual funds or securities that are publicly quoted and available.

There have been no changes in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

* In accordance with Subtopic 820-10, the Plan's interest in the pooled separate accounts is measured at fair value using the NAV per share (or its equivalent) practical expedient and has not been classified in the fair value hierarchy. The NAV is determined by Transamerica and is based on the fair value of the underlying assets held by the funds. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

For investments measured at NAV practical expedient, participant-initiated redemption is permitted daily with no restrictions or notice periods. There are no unfunded commitments as of December 31, 2024 and 2023.

6. Stable Value Core Option Account

The Plan invests in a fully benefit-responsive traditional investment contract held in the Transamerica Stable Value Core Option Account. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The effective rate of interest is established every January 1 and July 1 and is based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. Stable Value Core Option Account (continued)

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA or premature termination of the contract. The Plan administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without consent of the issuer.

7. Other Related Party and Party-in-Interest Transactions

Certain investments are held and managed by Transamerica; therefore, these transactions qualify as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
