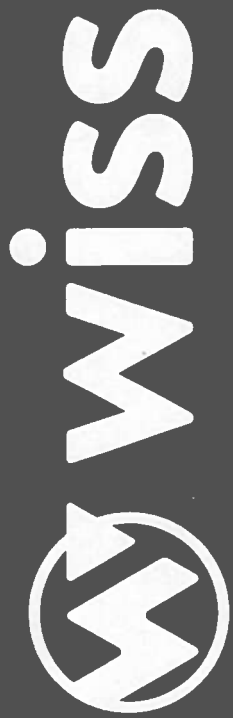

## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of  
Kawasaki Rail Car, Inc. 401(k) Investment Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Kawasaki Rail Car, Inc. 401(k) Investment Retirement Plan (the "Plan"), an employee benefit plan subject to Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTES TO FINANCIAL STATEMENTS**

**Note 1 - Description of Plan:**

The following description of the Kawasaki Rail Car, Inc. (the “Company” and “Plan Sponsor”) 401(k) Investment Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* - The Plan, which was adopted as of June 1, 1989, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Plan Administration* - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Fidelity Management Trust Company (“Trustee”), who is responsible for the custody and management of the Plan’s assets.

*Eligibility* - Employees of the Company are considered eligible to participate in the Plan after completing three months of service. There is no minimum age requirement. Eligible employees exclude employees covered by a collective bargaining agreement, leased employees and non-resident aliens who do not receive any earned income from the Company which constitutes United States source income.

*Participants’ Contributions* - Participants’ contribution is subject to an annual limit of the lesser of 15% of pretax annual compensation, as defined in the Plan, or \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500. Participants may change their contribution amounts quarterly, in February, May, August and November and may change their investment allocation options or holdings at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may revoke their election to contribute to the Plan at any time during the Plan year. Participant contributions are made through voluntary payroll deductions elected by each participant.

*Employer Contributions:*

- **Matching Contributions** - The Company makes non-discretionary matching contributions to the Participants’ accounts, in an amount equal to a maximum of 6% of the participant’s eligible compensation. There is no employer match on catch-up contributions for participants that are over age 50.
- **Discretionary Contributions** - The Company may decide to make a discretionary nonelective employer contribution on behalf of eligible participants to the Plan. Pursuant to the Plan document, this contribution is allocated based on each active participant’s compensation as it bears to total compensation of all eligible participants. There were no discretionary contributions made to the Plan for the year ended December 31, 2024.

*Vesting* - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus earnings thereon is based on years of continuous service. Company contributions vest 20% for each year of service and are fully vested in five years.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and an allocation of (i) the Plan's earnings on his or her specific investments, (ii) employer's matching contributions and (iii) employer's discretionary contributions, if any. Allocations of Plan earnings are based on each participant's account balance while the Company's contribution allocations are based on each participant's compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Payment of Benefits** - On termination of service due to death, disability, retirement or other reason, a participant or their elected beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants in the Plan may make in-service or hardship withdrawals from their account balances subject to the provisions of the Plan.

The amount of any taxable withdrawal that is not rolled into an Individual Retirement Account or another qualified employer retirement plan will be subject to Federal and state income taxes. A 10% Internal Revenue Code ("IRC") early withdrawal penalty tax may apply to the amount of the withdrawal if the participant is under the age of 59 ½ and does not meet one of the IRC exceptions.

**Forfeitures** - Forfeitures resulting from non-vested portions of participants' account balances are used to reduce future employer contributions under the Plan and expenses incurred in connection with the administration and management of the Plan and trust fund. During the year ended December 31, 2024, forfeited participant accounts of \$91,534 were added to prior years' unused accumulated forfeitures. For the year ended December 31, 2024, \$88,068 of accumulated forfeitures was applied to reduce employer contributions. As of December 31, 2024 and 2023, there is a balance of \$50,393 and \$46,927 of accumulated forfeitures (including earnings thereon) that are expected to be used to reduce future employer's matching contributions and Plan expenses.

**Note 2 - Summary of Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan include administrative and recordkeeping services. Fees related to the administration of notes receivable from participants and annual participant fees are charged directly to the participant's account and are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Professional fees of the Plan are paid by the Company.

**Payment of Benefits** - Benefits are recorded when paid.

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

**Subsequent Events** - The Plan administrator has reviewed and evaluated all events and transactions from December 31, 2024 through September 22, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

**Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common collective trust:* Investments in regulated investment companies or other trust pooled funds are valued at the net asset per share/unit on the valuation date. The net asset value is used as a practical expedient to estimate fair value. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price. (See Note 5.)

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

**Note 5 - Common Collective Trust:**

The Plan invests in investment contracts through its common collective trust ("CCT"). The CCT's fair value is a relevant measure attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the fund invests primarily in fixed income corporate and government agency bond funds and wrap contracts issued by third-parties. Redemptions are allowed for participants daily, however, in unusual market conditions, the trustee of the CCT in its sole discretion may impose restrictions on issues and redemptions of units. There are no unfunded commitments as of December 31, 2024 and 2023.

**Note 6 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investments in four funds comprise approximately 47% of total investments at December 31, 2024. The Plan's investments in three funds comprised approximately 37% of total investments at December 31, 2023.

**Note 7 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest loan balance in the last 12 months or 50 percent of their vested account balance. Loan terms can range from 1-5 years or up to 10 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at rates of 4.25% - 9.50%. Principal and interest is paid ratably by the participant through weekly payroll deductions.

**Note 8 - Party-in-Interest Transactions:**

The Trustee manages certain investments of the Plan, and these transactions may qualify as party-in-interest transactions. Additionally, the Trustee provides administrative and recordkeeping services to the Plan; therefore, these transactions qualify as party-in-interest. The fees paid by the Plan for the administrative and recordkeeping services for the year ended December 31, 2024 were \$152,216. The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

**Note 9 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

**Note 10 - Tax Status:**

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTES TO FINANCIAL STATEMENTS**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**Note 11 - Prohibited Transactions:**

During the Plan year ended December 31, 2024, the Company remitted late participant contributions to the Plan totaling approximately \$1,183,436. As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which the amounts are withheld from wages. During 2025, the Company will self-correct the late contributions for the Plan year under audit and make additional contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays, in the amount of \$1,584.

During the Plan year ended December 31, 2023, the Company remitted late participant contributions to the Plan totaling \$814,096. During 2025, the Company will self-correct the late contributions for the Plan year under audit and make additional contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays, in the amount of \$782.

During the Plan year ended December 31, 2022, the Company remitted late participant contributions to the Plan totaling \$539,144. During 2025, the Company will self-correct the late contributions for the Plan year under audit and make additional contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays, in the amount of \$456.
