A. DESCRIPTION OF PLAN:

The following description of the Wonton Food, Inc. 401(K) Plan (the Plan) provides only general information. Plan participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all eligible employees of Wonton Food, Inc. (the Company) who are not subject to a collective bargaining agreement. Employees are eligible to participate in the Plan upon attaining the age of 21 and completing 6 months service. Eligible employees are automatically enrolled to defer 3% of the compensation as of the date they become a participant, unless they choose a different percentage or choose not to defer. If the employee does not choose a different percentage, the percentage will automatically increase each January 1<sup>st</sup> by 1% up to a maximum of 6%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Employees may contribute a percentage of their compensation, the maximum of which is set by law. The limit is \$23,000 for calendar year 2024. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 for 2024. Employer matching contributions are equal to 100% of the employee's elective deferral contributions which are not over 1% of the compensation plus 50% of the elective deferral contributions which are over 1% of the compensation, but are not over 6% of the compensation.

3. Participant's Accounts

Participant accounts are credited with the participants' contributions, the company's contributions and allocations of plan earnings less an allocation of administration expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be paid from the participant's vested account. Participants may direct contributions to be invested in any of the investments offered by the Plan.

4. Vesting

The participant's contribution plus any rollover amounts from another plan and earnings thereon are fully vested. Employer contributions and earnings thereon in a participant's account become vested after completion of two years of service or upon death, becoming totally disabled or normal retirement.

5. Note Receivable from Participants

Participants may borrow from their plan accounts an amount equal to at least \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Notes receivable are considered a directed investment of participants' accounts under the Plan. All payments of principal and interest by participants on a note are credited to the participant's account. Repayment will normally be made through payroll deductions.

6. Payment of Benefits

On termination of service due to death or retirement, a participant, or their beneficiary upon death of the participant, may choose to have their vested account paid under any of the optional forms available under the plan if the value of the participant's vested interest in the account is greater than \$5,000. If the vested interest is less than \$5,000, the account balance may only be distributed in a single sum.

7. Forfeiture accounts

Forfeited balances of terminated participants' non-vested accounts are used to offset future employer matching contributions, if any, unless used to pay administrative expenses. \$8,659 and \$3,896 were allocated to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. There were no unallocated forfeitures outstanding as of December 31, 2024 and 2023.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following are the significant accounting policies followed by the Plan:

1. Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

2. Investments and Income Recognition

The plan investments are stated at fair value in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's realized gains (losses) on investments bought and sold as well as changes in unrealized gains (losses) on investments held during the year.

3. Payment of Benefits

Benefits are recorded when paid.

4. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in net assets available for benefits during the applicable reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

C. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee of the plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, Note D, the supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

E1. FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. ASC 820 describes three levels of inputs that may be used to measure fair value:

Level I: Quoted prices in active markets for identical assets or liabilities.

Level II: Observable inputs other than Level I prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or inputs that are observable or corroborated by observable market data for substantially the full term of the assets or liabilities.

Level III: Unobservable inputs supported by little or no market activity and that reflect the reporting entity's own assumptions about the exit price, including assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

E1. FAIR VALUE MEASUREMENTS:

Fair value estimates are made at a specific point in time, based on available market information and other observable inputs. In some cases, the fair value estimates cannot be substantiated by comparison to independent markets. In addition, the disclosed fair value may not be realized in the ultimate settlement of the financial asset as these values do not represent any premium or discount that could result from selling an entire holding of a particular financial asset at one time. Other expenses that would be incurred in an actual sale or settlement are not included in the amounts disclosed.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

MUTUAL FUNDS

Mutual Funds are quoted market prices for shares held by the Plan at year end.

COLLECTIVE INVESTMENT TRUSTS AND POOLED SEPARATE ACCOUNTS

At December 31, 2024 and 2023, the Plan's investments included units of collective investment trusts ("CIT") and Pooled Separate Accounts ("PSA"), which provide long term investors with an asset allocation strategy designed to provide a strategic portfolio of diversifying asset classes. The CIT and PSA are valued at the net asset value ("NAV") of units held by the Plan at year end as a practical expedient. The NAV represents the value at which the units of the CIT and PSA may be purchased or redeemed. Valuation of the CIT and PSA occurs, at a minimum, each day the CIT and PSA are open for contributions and redemptions. Unit values are determined by dividing the CIT or PSA's net assets by the number of units outstanding on the valuation date. Redemptions are permitted on a daily basis and are executed based on the CIT or PSA unit value determined on that day. There were no unfunded commitments related to the CIT and PSA as of December 31, 2024 and 2023. The PSA has a transfer restriction of once every 30 day period. The CIT and PSA investments have not been categorized in the fair value hierarchy.

**E1. FAIR VALUE MEASUREMENTS:**

In accordance with Subtopic 820-10, the Plan's investments in the CIT and PSA were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E2. PRINCIPAL GUARANTEED OPTION:**

Principal Guaranteed Option ("PGO") is a guaranteed general account-backed, stable value group annuity contracts that can provide a conservative foundation of the retirement program's investment line-up. A rate of interest contractually guaranteed by Principal Life is credited to participant account balances. This net crediting rate is after the deduction of 0.45% for fees for administrative and recordkeeping services provided to the plan. Currently, this net crediting rate is a 4.40% effective annual rate, until May 31, 2025. The rate will be reset June 1, 2025, and semiannually thereafter.

The PGO provides that benefit-responsive distributions for underlying securities may be withdrawn at contract value. Benefit-responsive distributions are generally defined as a withdrawal on account of a participant's retirement, disability, or death, or participant-directed transfers in accordance with the terms of the Plan. The PGO meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

An employer-level liquidation or employer initiated transfer of the plan's interest in the Principal Guaranteed Option would be paid out in 6 installments. If accelerated payment is requested instead of the 6 installments, there would be an early termination charge starting at 0% and up depending on the time it is requested and the calculation for market value adjustment. If the plan is moving to a recordkeeper that can't enforce the equity wash and accept the installment transfers, a 10% surrender charge will also apply if the cumulative investment transfer amount from the Principal Guaranteed Option exceeds \$50,000 and the cumulative investment transfer percentage exceeds 25% of the plan's interest in the contract during the 3 month period immediately preceding the employer-level surrender of the plan's interest in the contract.

**F. RELATED-PARTY TRANSACTIONS:**

Certain Plan investments are held in investments managed by the Plan trustee, and therefore, these transactions qualify as exempt party-in-interest transactions. Participant loans are also considered party-in-interest transactions.

**G. PLAN TERMINATION:**

The Company expects to continue the Plan indefinitely, but reserve the right to terminate the Plan in whole or in part at any time upon giving written notice to all parties concerned. The account of each participant shall be 100% vested and nonforfeitable as of the effective date of the complete termination of the Plan.

**H. TAX STATUS:**

The Plan operates under a prototype plan of Principal Life Insurance Company. The prototype plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since its adoption, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified, and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

J. SUBSEQUENT EVENT:

Subsequent events have been evaluated for recognition in the December 31, 2024 financial statements through October 1, 2025, the date on which the financial statements were available to be issued.
