The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the Populus Financial Group, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established by Populus Financial Group, Inc. ("Company" or "Plan Sponsor"), under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and is available to all eligible employees, as defined by the Plan document, who are 21 years of age or older. Employees are eligible to participate in the Plan on the first day of the month following 3 months of service.

Contributions

Each year, participants may contribute up to 50% of pretax or Roth annual eligible compensation, as defined in the Plan, not to exceed the maximum amounts allowable by Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Employees who do not wish to contribute to the plan may terminate contributions to the Plan at any time. The Company's matching contribution rate was 25% of employee deferrals for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The participant determines the investment fund allocation of elective and matching contributions. Contributions may be allocated entirely to one fund or to a combination of funds or accounts. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their voluntary contributions and the investment earnings thereon. Employer contributions and any investment earnings thereon vest 100% after two years of credited service.

Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant (or the participant's beneficiary, if applicable) may elect to receive the value of the participant's vested account interest. The form of payment is a lump sum distribution.

Required minimum distributions cannot be deferred later than April 1 of the year following the year in which an employee attains the age of 73, beginning in 2023. These required minimum distributions may be taken as a lump sum or in installments.

Upon demonstrating immediate and heavy financial need, as defined in the Plan document, hardship withdrawals are permitted.

Notes Receivable From Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance. Only one note may be outstanding at any time and only one note may be made per Plan year. The note must be repaid within five years, unless the note is taken for the purchase of a primary residence, in which case the repayment period can be up to ten years. The notes are secured by the remaining balance in the participant's account. The notes bear interest at rates that are commensurate with local prevailing rates at the date of issuance as determined monthly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

The forfeited nonvested portion of the employers' contributions and related earnings of terminated employees are used to reduce future employer matching contributions and to pay other fees in accordance with the Plan document. Forfeitures applied toward employer matching contributions were \$102,760 for the year ended December 31, 2024. Plan assets included unallocated forfeitures of \$166,194 and \$173,027 at December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting as required by accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on investments, in the statement of changes in net assets available for benefits.

Guaranteed Interest Fund

The Guaranteed Interest Fund is the Plan's fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company ("Great-West") for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, the contract value of the Guaranteed Interest Fund approximated fair value, as the insurance company is obligated to pay the contract value no later than 90 days from the date the Plan provides notice to discontinue and the plan pays interest at guaranteed crediting rates that are determined in advance. As contract value approximates fair value, no contract value adjustment was presented in the Plan's financial statements. Contract value represents contributions made under the contract, plus earnings at the guaranteed crediting rates, less losses, participant withdrawals, and administrative expenses. The Guaranteed Interest Fund is carried at contract value because that is the amount equal to the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. There are no events probable of occurring that would limit the Plan's ability to transact at contract value.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as deemed distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase in benefits paid to participants. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15 of the subsequent year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain costs and expenses incurred with regard to the purchase, sale or transfer of investments and initiation of loans are paid by the Plan. Investment advisory fees and audit expenses for portfolio management are paid directly from fund earnings; they are included in investment expense ratios. All other administrative expenses are generally paid by the Company and are excluded from these financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The fair value of these investments is determined by the closing price as reported by the fund. Shares held in mutual funds traded on national securities exchanges are valued at their daily net asset value ("NAV") as of year-end. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D - GUARANTEED INTEREST FUND

The Guaranteed Interest Fund was maintained by Great-West in 2024 and 2023. Great-West holds the contributions in a general account and is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. The contract is directly between the Plan and Great-West in 2024 and 2023. The

repayment of principal and interest credited to participants is a financial obligation of Great-West. Given these provisions, Great-West considers this contract to be benefit responsive.

The contract with Great-West does not have any restrictions that limit the Plan's ability to collect the full contract value. Great-West may not terminate the contract or require the Plan to settle at an amount different than the contract value.

Great-West determines the contract value of the fully benefit-responsive investment contract, which is the best estimate of fair value. Contract value represents contributions made under the contract, plus earnings, less losses, participant withdrawals, and administrative expenses.

NOTE E - INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Trust Company ("Custodian") has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds managed by Empower Retirement and a guaranteed income fund issued by the Great-West Company d/b/a Empower Retirement, which qualify as party-in-interest transactions. In addition, certain fees paid to the Plan Custodian for investment management services are incorporated into the expense ratios of the individual mutual funds. The Plan has notes receivable from participants, which qualify as parties-in-interest to the Plan and are exempt from prohibited transaction rules.

NOTE G - TAX STATUS

The Plan operates under a prototype plan document and has received a favorable opinion letter, dated March 31, 2014, from the Internal Revenue Service ("IRS") stating that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code ("the Code"). The Plan has been amended since that date, however, the Plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the Code, and therefore believes the Plan is qualified and tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - PLAN TERMINATION

While the Plan Sponsor has not expressed any intent to terminate the Plan, it has the right to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the Plan and participants would become 100% vested in their employer contribution.

NOTE I - RISKS AND UNCERTAINTIES

The Plan provides for various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
