INDEPENDENT AUDITOR'S REPORT

To Committee Members and Participants of the

Opinion

We have audited the accompanying financial statements of Messer Construction Co. Health Care Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (cash basis) of Messer Construction Co. NOTES TO FINANCIAL STATEMENTS (CASH BASIS) AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Messer Construction Co. Health Care Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more information.

General — The Plan was established November 1, 1990, and most recently amended January 2024. Certain Plan assets are held in a voluntary employees’ beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Benefits — The Plan is a health care benefit plan covering substantially all full-time employees of the Messer Construction Co. (the “Company”). The Plan provides for hospitalization, medical, and prescription drug benefits.

Stop Loss Coverage — The Plan maintains stop-loss insurance policy coverage to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Effective January 1, 2024, the Plan renewed its agreement with its commercial insurance provider (the “Re-insurer”) to provide individual stop-loss insurance coverage. Under this arrangement, the Re-insurer reimburses the Plan for each participant’s covered claims that exceed \$500,000 per calendar year. The stop-loss policy provides for 100% reimbursement of eligible claims above the attachment point, with no annual or lifetime reimbursement limits. The plan does not carry any aggregate stop-loss insurance. The Plan is self-funded for all participant covered claims, except for amounts eligible for reimbursement under the individual stop-loss policy. Reimbursements from the Re-insurer of \$872,149 during 2024 are presented as stop-loss claims on the statement of changes in net assets available for benefits.

Self-insured Benefits — All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements.

Contributions — Contributions are made by the Company in amounts determined by the Plan Administrator to meet funding requirements. Contributions to the Plan are deposited with a trustee for the payment of benefit claims, which are made by a third-party administrator. Employees of the Company contribute to the Plan based on individual or dependent participation. These contributions may be modified periodically.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The Plan maintains its accounts and records on the cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Accordingly, investments are stated at cost, revenues are recognized when received, and benefit claims and expenses are recognized when paid.

Use of Estimates — The preparation of financial statements (cash basis) requires Plan management to make estimates on benefit obligations (See Note 3). Actual results could differ from those estimates.

Insurance Premiums and Administrative Fees — Insurance premiums paid to the Re-insurer and expenses incurred in the administration of the Plan are paid by the Plan as provided in the Plan Document. Indirect administrative expenses are covered by the Plan Sponsor.

Subsequent Events — The Plan has evaluated subsequent events through July 28, 2025, the date that these financial statements (cash basis) were available for issuance, to determine if either recognition or disclosure of significant events or transactions is required.

3. BENEFIT OBLIGATIONS

As of December 31, 2024 and 2023, the estimated liability for claims incurred but not reported approximated \$1,198,899 and \$918,719, respectively.

4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a checking account managed by Fifth Third Bank. Fifth Third Bank is the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

5. PLAN TERMINATION

Although it has not expressed intent to do so, the Company may terminate the Plan at any time. In the event of such termination, the Company shall have no obligation under the Plan beyond paying the difference between the claims incurred, plus expenses of the Plan due up to the date of termination and the funds available in the trust to pay such claims and expenses.

6. FEDERAL INCOME TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant of Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained an exemption letter dated June 1, 1992, from the Internal Revenue Service, and the Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements (cash basis).

Plan management evaluates tax positions taken by the Plan and recognizes by disclosure in the financial statements if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements (cash basis). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. CREDIT RISK CONCENTRATIONS

The Plan maintains cash balances in banks related to plan disbursements. These balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. As of December 31, 2024, the uninsured portion of this balance was \$4,880,991.
