

1. **Description of the Plan** The following description of the VIKA Companies, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of VIKA Companies, LLC and its affiliates (collectively, the "Company") who are at least 21 years old and who have completed three months of service, except for nonresident aliens, resident aliens and employees covered by a collective bargaining agreement. Employees may enter the Plan semi-annually on the first day of January or July, subsequent to satisfying the eligibility requirements. With respect to any Company contributions, participants are eligible upon attaining age 21 and may enter the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for discretionary matching contributions. There were no discretionary matching contributions for the year ended December 31, 2024. The Plan allows for discretionary non-elective contributions by groups, defined as: Group 1 - Principals, Group 2 - Principal Associates, Group 3 - Vice Presidents, Group 4 - Senior Associates, Group 5 - Associates, and Group 6 - all other employees. Participants must be employed on the last day of the Plan year and have at least 1,000 hours of service to receive an allocation of any discretionary matching or non-elective contributions. During the year ended December 31, 2024, the Company made discretionary non-elective contributions of three percent of a participant's eligible compensation for all groups. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as the Company's discretionary non-elective contributions, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary non-elective contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year by group. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of benefits:** Benefits are payable upon retirement at age 65, early retirement at age 59 1/2, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum payments.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company discretionary matching and non-elective contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$30,069 and \$11,731, respectively. Accounts forfeited from Company contributions will be used to reduce future discretionary contributions or reallocated among remaining eligible participant accounts. During the year ended December 31, 2024, no forfeited amounts were reallocated among remaining eligible participant accounts, and \$30,590 was used to reduce the discretionary non-elective contributions. Employer contributions receivable as of December 31, 2024 and 2023 is presented net of any forfeitures applied.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prevailing market rates. Principal and interest are paid through payroll deductions.

### 2. Significant accounting policies

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan administration fees, are charged directly to the participant's account and are included in administrative expenses.

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary non-elective contributions are recognized in the period the related eligible compensation is paid to the participant.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through September 18, 2025, which is the date the financial statements were available to be issued.

**3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

**4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of the underlying assets in the account, less the liabilities.

The fair value of the collective trust funds is based on the NAV on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

(a) In accordance with ASC 820, certain investments that were measured at net asset value per share (or its equivalent) as of December 31, 2024 and 2023 have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Investments in all collective trust funds (\$15,558,394 and \$14,191,484 at December 31, 2024 and 2023, respectively) can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. Withdrawals from the Principal Stable Value Fund initiated by the Company require twelve months notice. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. Investments in all pooled separate accounts (\$13,346,286 and \$11,055,979 at December 31, 2024 and 2023, respectively) can be redeemed immediately at the current net asset value based on the fair value of the underlying assets, except for investments in the Principal U.S. Property Separate Account. A withdrawal limitation was implemented on July 1, 2022 for this account. If a participant chooses to request a distribution from this account, the payment will be delayed. There are no other withdrawal limits, redemption frequency limits or redemption notice periods for the pooled separate accounts. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

#### 5. Risks and uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

- 6. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"). Principal is the trustee and recordkeeper as defined by the Plan. In addition, the Plan pays certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as exempt party-in-interest transactions.
- During 2024, the Company failed to remit to the trustee certain employee contributions and loan repayments totaling \$1,408 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions.
- During 2023, the Company failed to remit to the trustee certain employee contributions totaling \$2,076 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Company made corrective contributions to the Plan in 2024 to compensate affected participants for lost earnings on the delinquent remittances.
- 8. Tax status** The Plan is a pre-approved plan of Principal Life Insurance Company which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
