Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Purple Wave, Inc. Note 1: Description of the Plan

The following description of the Purple Wave, Inc. Retirement Plan (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2007, is a defined contribution plan. An employee becomes eligible immediately after following the attainment of age 19 and/or date of hire. Employees eligible for deferrals are also eligible for company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

Employee Contributions

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers money market and mutual funds as investment options for participants. The Plan also offers target date fund choices which are pre-determined allocations of the available mutual funds.

The Plan may accept a proper rollover from another qualified plan.

Employer Contributions

The Plan includes a safe harbor employer contribution of 100% of the first 3% of employee compensation, plus an additional 50% on the next 2% of employee compensation.

At the end of the Plan year, Purple Wave, Inc. (the Company), at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has not elected to provide a discretionary contribution for 2024 and 2023. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in both their voluntary contributions and employer's matching contributions, plus actual earnings thereon. For discretionary profit sharing contributions and any prior matching contributions, the Plan provides for vesting of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions. Generally, the loan term may not exceed five years.

At the end December 31, 2024 and 2023 there were no loans in default within the Plan.

Payment of Benefits

Distributions are made upon death, disability, retirement, or termination of employment. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum or, if subject to required lifetime required minimum distribution payments, substantially equal payments. In-service distributions are permitted from the participant's account upon attaining age 59^{1/2}.

Forfeitures

As outlined in the Plan, forfeitures of the profit sharing contributions due to the non-vested portion may be used to pay plan expenses or applied to reduce contributions of the employer. Amounts forfeited due to vesting during the year ended December 31, 2024 and 2023 were \$0.

Total forfeiture balance at December 31, 2024 and 2023 was \$1,740 and \$4,189, respectively. This forfeiture balance is present due to a payroll duplication at year-end December 2020. In 2024, \$3,616 of forfeitures were used to pay plan expenses. In 2023, \$2,688 of forfeitures were used pay plan expenses.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants' account. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by Fidelity Management Trust Company (the Custodian) as of the Plan's year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy, gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

Note 3: Fair Value Measurements (Continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds

Valued at the NAV per \$1 share. The fund's portfolio is comprised of short-term, or less than one year, securities representing high-quality, liquid debt and monetary instruments. Investors can purchase shares of money market funds through mutual funds, brokerage firms and banks.

Note 4: Related Party and Party in Interest Transactions

The Company absorbs the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. As the Plan does not reimburse the Company for the cost of such services they are not included in these financial statements.

Certain Plan investments are managed by the Custodian for which they are paid fees. Investment related expenses are included in the net appreciation of fair value of investments. These transactions qualify as exempt party-in-interest transactions.

The Company provides administrative services on behalf of the Plan. Additional party-in-interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, investment fees paid to Economic Group Pension Services, Inc. and advisor fees to Strategic Advisors, Inc. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Company has adopted a prototype Plan document that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which states the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Reconciliation of Financial Statements to Form 5500

The financial statements amounts reconcile with the annual Form 5500 filing to the Internal Revenue Service.

Note 9: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including net appreciation in fair value of the investments and interest and dividends for the years ended December 31, 2024 and 2023 were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian of the Plan.

Plan investments were in the custody of the Custodian. These assets consist primarily of shares in various mutual funds.

Note 10: Subsequent Events

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued.
