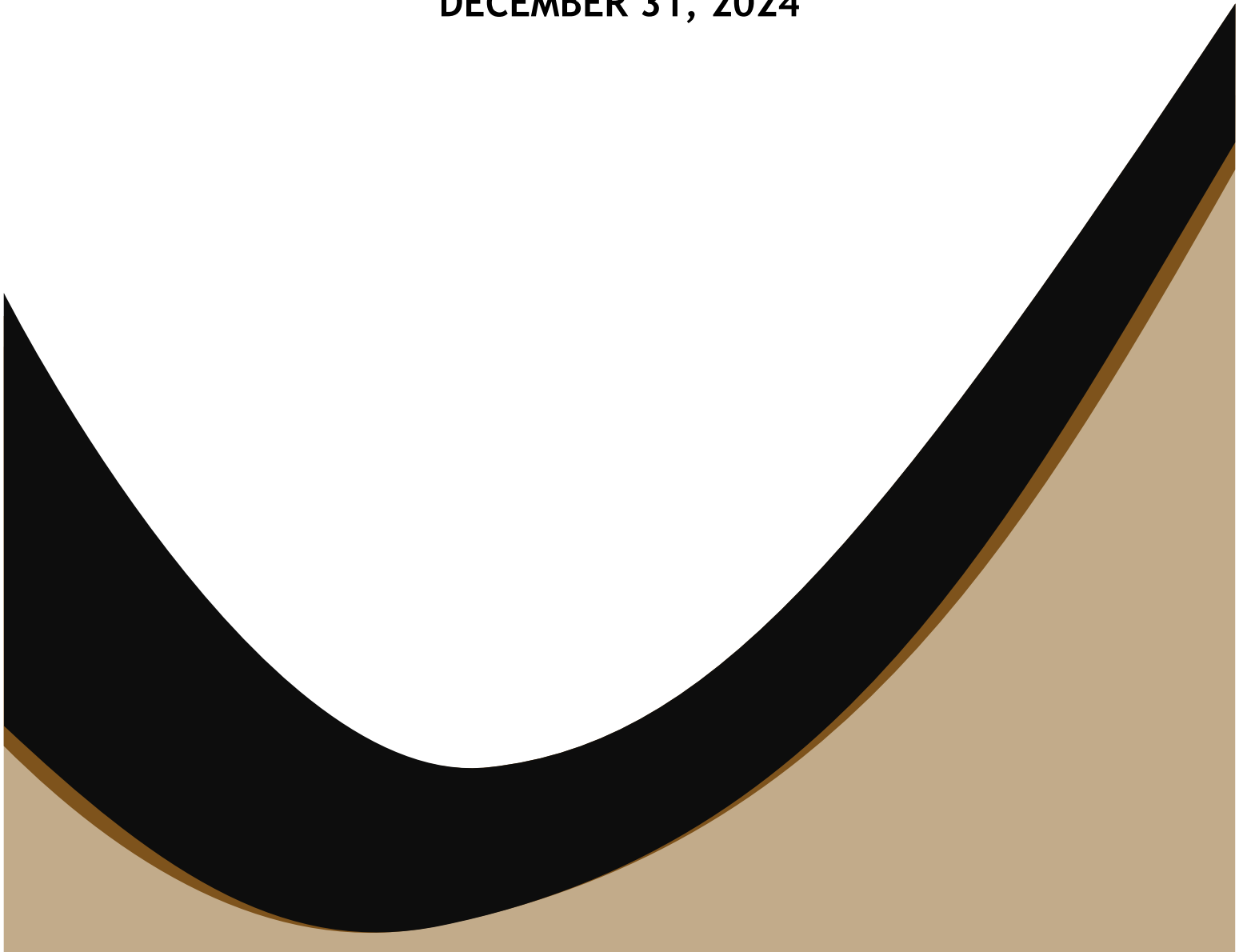

**INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Atlas World Group, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Atlas World Group, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1**  
**DESCRIPTION OF PLAN**

---

The following description of the Atlas World Group, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan was established December 1, 1998, for the benefit of all nonunion employees of Atlas World Group, Inc. (the Company) who have attained the age of 18. Eligible participants are automatically enrolled in the Plan with a 3% deduction from their compensation, unless they affirmatively decline to participate or elect a different deferral percentage. The Plan is a defined-contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In February 2020, the Company acquired TopHat Logistical Solutions, which maintained its own defined-contribution plan: TopHat Logistical Solutions 401(k) Plan (the Predecessor Plan). The assets held within participants' accounts and the notes receivable from participants under the Predecessor Plan were transferred to the Atlas World Group, Inc. Retirement Plan on January 2, 2024. The total net assets available for benefits that were transferred from the Predecessor Plan totaled \$680,564, of which \$663,821 represents participant and employer contributions and \$16,743 represents the balances of notes receivable from participants. These transfers are reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Contributions:**

Participants may contribute up to 75% of eligible compensation up to limits prescribed in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes a safe harbor matching contribution equal to 100% of each eligible participant's contribution up to 6% of each participant's eligible compensation upon the participant's election to participate. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant accounts:**

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:**

Participants are immediately vested in both their voluntary contributions and the Company's matching contributions plus actual earnings thereon.

**Notes receivable from participants:**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rate is established at the loan origination date and is not adjusted in any future period. The note must be repaid over a period not to exceed 5 years or up to 10 years if the loan is for the purchase of the participant's principal residence. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:**

Benefits are paid in a single cash lump sum, unless an alternate form of payment is specifically elected in accordance with the plan agreement. A lump-sum payment is required if the participant's account balance is \$5,000 or less. A participant may make a complete or partial hardship withdrawal of the vested amount held in his or her account. The withdrawal must be necessary in light of immediate and heavy financial needs of the participant. In-service non hardship withdrawals are allowed once a participant reaches age 59 ½.

A summary of the Plan's significant accounting policies follows:

**Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments valuation and income recognition:**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Payment of benefits:**

Benefits are recorded when paid.

**Administrative expenses:**

Administrative expenses are paid by the Plan. The Plan's trustee provided approximately \$10,000 to cover these costs during the year ended December 31, 2024. Certain transaction expenses are charged directly to the account of the participant on whose sole behalf the expense is incurred. Investment related expenses are included in net appreciation in fair value of investments.

**INFORMATION CERTIFIED AND PROVIDED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (TRP), the trustee of the Plan.

**NOTE 4**  
**FAIR VALUE MEASUREMENTS**

---

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

**Level 1 fair value measurements:**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**NOTE 5**  
**GUARANTEED INVESTMENT CONTRACTS**

The Plan invests in the TRP Stable Value Fund (a common/collective trust), which holds guaranteed investment contracts and is reported at contract value. Contract value represents contributions made, plus interest at the contract rate, less funds used to pay participant benefits. There are no limitations on guarantees on the contracts.

**RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by TRP. TRP is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

Notes receivable from participants and the related interest income are considered related party transactions.

**NOTE 7**  
**PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8**  
**TAX STATUS**

---

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated December 23, 2010, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
