## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
of the Balon Corporation 401(k) Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Balon Corporation 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Balon Corporation 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

**General** – The Plan is a defined contribution plan covering substantially all full-time employees of Balon Corporation, Viking Forge, and SFO Capital. These companies are affiliated through common ownership and are herein referred to as the “Plan Sponsor.” Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) is the Plan’s trustee and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). TriStar is the Plan’s third party administrator, and Infinitas is the Plan’s investment advisor.

**Eligibility** – Employees who are at least 18 years of age and who have worked 60 days may enter the Plan on the first day of the next calendar quarter, or any date after that.

**Contributions** – Employees may elect to contribute to the Plan up to 100% of their annual earnings as 401(k) deferrals (pre-tax) or Roth (after-tax) contributions, subject to certain Internal Revenue Code (“IRC”) provisions. The Plan also allows “catch up” contributions for participants beginning in the year that the participant reaches the age of 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan’s auto-enrollment deferral feature enrolls all newly eligible participants into the Plan at a rate of 6%, unless the participant affirmatively elects another amount, or declines to participate. Participants who are automatically enrolled in the Plan will have their contribution rate increased at a rate of 1% each year on January 1<sup>st</sup>, up to a maximum amount of 15%.

The Plan Sponsor makes safe-harbor matching contributions equal to 100% of the salary deferral that does not exceed 1% of compensation plus 50% of salary deferrals over 1% and up to 6% of compensation that a participant contributes to the Plan. The safe-harbor match is calculated and remitted to the Plan every payroll; however, a true-up contribution is calculated based on earnings for the year.

The Plan Sponsor may also make a discretionary matching contribution and/or a profit-sharing contribution to the Plan. There were no discretionary contributions made to the Plan for 2024. All contributions are subject to certain limitations, as outlined in the Plan document.

**Investments** – Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a pooled separate account, and a common collective trust as investment options for participants.

**Participant Accounts** – Each participant’s account is credited with the participant’s voluntary contribution, the Plan Sponsor’s contributions, and allocations of Plan earnings or losses, as defined by the Plan document. The benefit to which a participant is entitled is the benefit provided by the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings or losses thereon. The safe-harbor matching contribution is fully vested after two years of credited service.

Prior to October 1, 2018, participants vested in employer matching and discretionary contributions plus actual earnings or losses thereon based on years of service as follows:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Effective October 1, 2018, the Plan was amended to modify the vesting schedule for employer discretionary contributions plus actual earnings or losses thereon as follows:

1 year	10%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**Forfeitures** – Upon termination of a participant’s employment with the Plan Sponsor, the nonvested portion of the Plan Sponsor’s matching and discretionary contributions are used to reduce future Plan Sponsor contributions. Forfeited nonvested accounts were \$0 and \$13 at December 31, 2024 and 2023, respectively. Forfeitures of approximately \$43,700 were used to reduce employer contributions in 2024.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. Note terms typically require repayment within five years. The notes are secured by the balance in the participant’s account and typically bear interest at a rate equal to 2% above prime rate as published in the *Wall Street Journal* as of the date of the note. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participants’ vested interest in his/her account, or installments (for required minimum distributions) over a certain period. However, if the vested account does not exceed \$5,000, the Plan permits only a lump sum distribution.

**Plan Expenses** – Recordkeeping and trustee fees generated by participant withdrawal and loan transactions are reflected in the financial statements as administrative expenses. All other expenses of the Plan are paid for by the Plan Sponsor and are excluded from these financial statements.

**Termination of the Plan** – Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Company and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management’s Review** – Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued, and there were no subsequent events that required adjustment or disclosure.

## 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies at December 31, 2024 and 2023.

Mutual Funds – Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account and Common Collective Trust – Principal calculates a unit value (similar to a NAV) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any. The NAV is available to current investors via the Principal employer website, or when Plan participants access their account values. The NAV is the basis for current transactions and these investments can be redeemed at NAV as of the measurement date. Therefore, management believes that these investments have a readily determinable fair value. The majority of the underlying securities held in these investments have observable Level 1 inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. #### **4. RISKS AND UNCERTAINTIES**

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **5. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Principal, trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants, and related income
- Net appreciation in fair value of investments
- Interest and dividend income
- Revenue recapture income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **6. TAX STATUS**

The Plan is based on a prototype plan which has received an opinion letter dated June 30, 2020 which stated the prototype plan is a qualified plan in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS, and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS**

The Plan paid certain recordkeeping and trustee fees to various service providers. Administrative fees were paid to Principal and TriStar Pension Consulting from Plan assets. These transactions qualify as exempt party-in-interest transactions under ERISA.

Plan investments include a pooled separate account issued by Principal. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are exempt party-in-interest transactions.
