Note 1 - Plan Description

The following description of Berlin Rosen LTD. 401k P/S Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of BerlinRosen, LLC (the "Company") with no service or age requirements. The entry date for eligible participants is on the first day of the month coinciding with or following the date of employment. The Plan was established on January 1, 2006, and subsequently restated on April 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and is responsible for the administration of the Plan. Reliance Trust Company (the "Trustee") functions as trustee and custodian. Automatic Data Processing, Inc. (ADP) functions as the investment manager and recordkeeper. The Plan pays investment management fees and trustee fees in accordance with the plan agreement.

Contributions

The Plan provides for employee salary deferral contributions a minimum and maximum of 1 and 90 percent, respectively, of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute a minimum and maximum of 1 up to 90 percent, respectively, of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2022 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2022. The Company remitted all lost earnings in September 2023.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2023. The Company remitted all lost earnings in October 2023.

The Plan provides for employer matching contributions of 100 percent of the first 4 percent of employees' deferred compensation, which is contributed each pay date.

The Company may make annual discretionary contributions. Participants who have completed 1,000 hours of service during the plan year and are employed on the last day of the plan year will be eligible to receive an allocation of the Company's discretionary contribution.

The employer matching contributions for the year ended December 31, 2023 amounted to \$1,339,613. There were no discretionary matching contributions made in 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their account balance investments into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the trustee or its affiliates; therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. In addition, the Company pays certain administrative fees on behalf of the Plan, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation

The Plan's investments are stated at fair value based on quoted market values. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 4 for additional information.

Transfer in Transit

Participant account balances are being transferred from ADP to Fidelity Management Trust Company, therefore the participant account balances are recorded as other assets - transfers in transit within the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation an of events up through and including August 15, 2024, which is the date the financial statements were available to be issued.

Effective January 1, 2024, the Plan transitioned plan assets from the custody of Reliance Trust Company to Fidelity Management Trust Company and adopted the Fidelity Pre-approved Defined Contribution Plan Basic Plan Document No. 17. Provisions of the Plan are substantially the same under the newly adopted preapproved plan.

Effective January 1, 2024, the Inkhouse 401(k) Plan; Derris LLC 401(k) Plan; and the Glen Echo Group, LLC 401(k) Profit Sharing Plan were merged into the Plan. Accordingly, all assets, participants, and their related account balances of \$11,164,339, \$4,683,110, and \$2,333,527, respectively, were transferred into the Plan during 2024.

Effective February 1, 2024, the Message Lab 401(k) Profit Sharing Plan & Trust was merged into the Plan. Accordingly, all assets, participants, and their related account balances of \$1,011,340 were transferred into the Plan during 2024.

Effective March 5, 2024, the M18 401(k) Plan was merged into the Plan. Accordingly, all assets, participants, and their related account balances of \$1,489,507 were transferred into the Plan during 2024.

Note 3 - Certified Information

Reliance Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities to be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan can access.

Note 4 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
