NOTE A – DESCRIPTION OF THE PLAN

The following brief description of the Community Health Care, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. *General*

The Plan was established effective January 1, 1996. The plan is a contributory tax deferred plan established under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of Community Health Care, Inc. (Company) are eligible to participate in the Plan. Employees become eligible after attaining the age of 19 and completing a minimum of six months of service as defined by the plan document.

The Trustees of the Plan are April Chumita, Michelle Moellendick and Dr. Brady Steineck. During 2024 the custodian of the Plan's assets transferred from Voya Retirement Insurance and Annuity Company to American Funds Plans. The Plan Administrator is Community Health Care, Inc.

2. *Contributions*

Participants may elect to contribute a percentage of their total compensation, subject to annual limitations established by the Internal Revenue Code. Community Health Care, Inc. makes matching contributions proportionate to the amount of the participants' elective deferrals. The Company contributes 100% of the first 3% and 50% of the next 2% of base compensation that a participant contributes to the plan, for a maximum matching contribution of 4%. The Company may also make a discretionary profit sharing contribution. All contributions are invested at the participants' direction. Participants can modify their deferral election four times each year, and may change their allocation of contributions or transfer money between investment options any time during the year.

3. *Vesting*

Each participant's contributions, safe harbor matching contributions and earnings are 100% vested immediately. The employer discretionary contributions and earnings are subject to the following vesting schedule.

4. *Notes Receivable from Participants*

Participants with a vested account balance of \$2,000 or more are permitted to borrow from their account. The minimum permitted loan amount is \$1,000. The maximum loan balance outstanding is limited to the lesser of \$50,000 or 50% of the participant's vested account balance. The interest rate is fixed, on the date of loan origination, equal to the prime interest rate. Payments are made through payroll deductions and loans generally must be paid back within five years. Loans for the purchase of a primary residence may be paid back over a longer period of time as determined by the Plan Administrator.

5. *Payment of Benefits*

A participant who has attained the age of 62 may elect to withdraw all or part of their account balances. A withdrawal can also be made prior to this time due to (a) employee death; (b) disability; (c) termination of employment; or (d) reasons of proven financial hardship.

6. *Forfeitures*

When participants terminate their employment with the Company, the unvested portion of their account balance will be forfeited upon the earlier of the participant incurring 5 consecutive one year breaks in service or the distribution of the entire vested portion of their account balance. Forfeitures will be used to reduce any employer contributions to the Plan. During 2024 participant forfeitures total \$19, of which all were used to reduce employer contributions. Unallocated forfeitures totaled \$0 and \$1,959 as of December 31, 2024 and 2023.

7. *Participant Accounts*

Each participant's account is increased or decreased, as appropriate, by the participant's contributions, Community Health Care, Inc. discretionary contributions, allocation of net investment earnings, loans, forfeitures, withdrawals and any expenses which may be charged to participant accounts.

8. *Administrative Expenses*

Generally, the administrative expenses of the Plan are paid by Community Health Care, Inc. Administrative fees charged when making loans from the Plan are deducted from Participants' account balances and certain asset-based fees are deducted from investment earnings prior to allocation of those earnings.

NOTE B –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. *Date of Management Review*

Subsequent events were evaluated through September 30, 2025 which is the date the financial statements were available to be issued.

2. *Basis of Presentation*

The financial statements of the plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

3. *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the reported amount of additions and deductions to net assets available for benefits during the reporting period. Accordingly actual results may differ from those estimates.

4. *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

5. *Payment of Benefits*

Benefits are recorded when paid.

6. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE C— FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets of identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. When no Level 1 inputs are available the Plan uses Level 2 inputs which are quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in markets that are not active and inputs other than quoted prices such as interest rates and yield curves. No level 3 inputs were used by the plan.

Level 1 Fair Value Measurements

The fair value of common stocks, corporate bonds and US Government securities, if any, is based on the closing price on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair value of pooled separate accounts is based on quoted net asset values of the shares held at the plan year end. The fair value of units of group annuity contract are provided by the trustee and used as a practical estimate of the fair value. The fair value is based upon the fair value of the underlying investments held by the fund less its liabilities.

NOTE D – GROUP ANNUITY CONTRACT

The Plan had a fully benefit responsive group annuity contract with an insurance company, which is called the Voya fixed account. The insurance company maintained the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The group annuity contract is included in the financial statements at contract value which approximates fair value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) layoffs, (3) Plan termination, (4) bankruptcy, (5) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 and 2023 was 0.0% and 1.45%, respectively. The actual average yield earned by the Plan for the group annuity contract is derived by averaging the Plan's quarterly interest rates. The average for 2024 and 2023 was 0.0% and 1.45%, respectively.

During 2024 the group annuity contract was no longer offered and all funds held in the investment were transferred to other investment options selected by the participants.

NOTE E – TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the form of the Plan is qualified under Section 401 of the IRC, and therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2012-6 and 2011-49, the Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore, believes the Plan is qualified and the related trust is tax-exempt.

NOTES TO THE FINANCIAL STATEMENTS**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE F – RELATED PARTY TRANSACTIONS

Certain Plan investments are units of participation in pooled separate accounts, mutual funds and unallocated accounts managed by Voya Retirement Insurance and Annuity Company and American Funds Plans. Voya and American Funds served as the custodian as defined by the Plan during parts of 2024 and 2023 and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid no fees for the investment management services of Voya and American Funds for 2024 or 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to alter, suspend or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the rights of all participants to the amounts credited to such participants' accounts at the date of termination are non-forfeitable. The record-keeper of the Plan would value the trust and the shares of all participants as of the termination date and, as soon as possible, the balance of the accounts would be distributed.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment contracts with an insurance company (Voya and American Funds). These investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment will occur in the near term and that such amounts could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefit.
