## INDEPENDENT AUDITOR'S REPORT

Note 1 - Description of Plan:

The following description of Grace Management Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all eligible employees of Grace Management Group, LLC (the Company) who have met certain eligibility requirements. Employees are eligible to participate in the Plan after age 18 and one year of service based on plan entry dates. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

b. Contributions

Each year, participants contribute to the Plan through pretax or after-tax Roth deferrals. Upon becoming eligible, participants are automatically enrolled in the Plan with a deferral of 4%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company will make a matching contribution at 100% up to 4% for each participant. The Company may also make discretionary non-elective contributions.

c. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) the Plan's earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately 100% vested in the elective employee deferrals, rollover contributions, qualified non-elective contributions and safe harbor matching contributions. Non-elective contributions are vested based on the following schedule based on 1,000 hours or more of annual service.

Note 1 - Description of Plan (Continued):

e. Payment of Benefits

Upon termination of service due to retirement, death or disability, a participant's account shall be fully vested and nonforfeitable and the participant (or beneficiary as applicable) may elect to receive a lump-sum payment equal to the value of the participant's account. Upon termination of service due to separation of service, a participant may elect to receive a lump-sum amount equal to the vested value of the participant's account.

f. Hardship Withdrawals

In-service withdrawals are available in certain limited circumstances. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS).

g. Investment Options

Upon enrollment in the Plan, participants may direct their investments into several investment options as listed in Schedule 1.

h. Forfeitures

The Plan provides for forfeited balances of non-vested accounts to be used for administrative expenses or to reduce future company contributions. At December 31, 2024, unallocated forfeiture accounts totaled \$391. There was no forfeiture balance as of December 31, 2023.

During the plan year ended December 31, 2024, \$4,329 were used from forfeited nonvested accounts to reduce Company matching contributions. There were \$9,113 of forfeitures during the year ended December 31, 2023, which were all used during the year ended December 31, 2023, to offset the employer match.

i. Administrative Expenses

The Plan's administrative expenses are paid by the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include distribution fees and certain administrative fees. Expenses relating to the purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administration fees of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Note 2 - Summary of Accounting Policies:

a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for certain investments in contracts.

Note 2 - Summary of Accounting Policies (Continued):

a. Basis of Accounting (continued)

Contract value is the relevant measure of the portion of the net assets available for benefit of a defined contribution plan attributable to certain investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the Plan.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, except for guaranteed interest accounts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

d. Payment of Benefits

Benefit payments to participants are recorded when paid.

Note 3 - Certified Investments:

Empower Annuity Insurance Company of America (EA) and Empower Trust Company, LLC (ET) (the Custodian), qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected in the accompanying financial statements and supplemental schedule.

During the year ended December 31, 2024, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$271,821 which includes appreciation of \$248,034 attributable to common collective trusts.

Note 4 - Fair Value Measurement:

FASB *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally prove the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets recorded at fair value on a recurring or nonrecurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interests in registered investment companies (mutual funds):* Valued at the closing price of shares held by the Plan at year end. Funds are traded on an active market.

Note 4 - Fair Value Measurement (Continued):

*Interest in common collective trusts:* Valued at net asset value of shares held by the Plan at year end, provided by the administrator of the fund. The net asset value is based on the value of the underlying assets of the fund minus its liabilities, and then divided by the number of shares outstanding. The net asset value's share price is quoted on a private market that is not actively traded; however, the share is based on underlying investments which are traded on an active market. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in the changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

Note 5 - Fully-benefit Responsive Investment Contracts:

The Plan is invested in a Guaranteed Interest Account (GIA) with EA and ET which is a fully benefit-responsive contract. EI Fixed Account - Series Class I, a guaranteed annuity account backed by the claims-paying ability of EA and ET. The principal and contractually specified minimum interest rate is guaranteed. These additional amounts are declared on a year-to-year basis by EA and ET.

Because the GIA meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIA. The GIA is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by EA and ET, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$54,954 and \$63,790 respectively. The crediting interest rate is based on an agreed upon formula with the issuer. Such interest rates are reviewed on a yearly basis for resetting. Interest rate for December 31, 2024 was 1.450%.

Note 5 - Fully-benefit Responsive Investment Contracts (Continued):

Certain events limit the Plan's ability to transact at contract value with EA and ET. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor events that cause a significant withdrawal from the plan, or (d) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The GIA does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 - Related Party Transactions:

Certain investments of the Plan are with EA and ET who serves as the Plan Custodian and therefore these qualify as party-in-interest transactions.

Note 7 - Plan Tax Status:

The Plan has adopted a prototype plan document, which has obtained an opinion letter from the Internal Revenue Service dated June 30, 2020 which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan was designed and is operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Plan Termination:

Although they have not expressed any intent to do so, the Company has the right in accordance with the Plan document to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 9 - Administrative Expenses:

The Plan paid administrative fees of \$24,241 for the year ended December 31, 2024.

Note 10 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11 - Subsequent Events:

The Plan administrator evaluated the existence of subsequent events through the date of the auditor's report. The Plan administrator determined that no events existed that require recording or disclosure in the accompanying financial statements as of the auditor's report date.
