Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed audits of the accompanying financial statements of UniGroup C.A. - the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of UniGroup C.A. Resources for Employees' Leisure Years Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UniGroup C.A. Resources for Employees' Leisure Years Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - 2024 Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Auditor's Report on the 2023 Financial Statements

The financial statements of UniGroup C.A. Resources for Employees' Leisure Years Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 10, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the UniGroup, C.A. Resources for Employees' Leisure Years Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of UniGroup, C.A. (the "Employer") who have attained age 21, other than those covered under a collective bargaining agreement, leased employees and non-resident aliens. Prior to October 1, 2023, seasonal and temporary employees had a 1,000-hour service requirement to participate in the Plan. Effective October 1, 2023, the Plan was amended to remove the service hours requirement for those employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Contributions

Participants may contribute up to 50% of eligible compensation in the form of pre-tax and after-tax ("roth") contributions, not to exceed Internal Revenue Code ("IRC") limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions and can contribute up to 100% eligible compensation, not to exceed IRC limits. Participants may also contribute amounts representing distributions from other qualified plans.

Under the provisions of the Plan, the Employer shall make matching contributions equal to 100% of the participant's deferral contributions not in excess of 3% of eligible compensation. Participants are eligible for matching contributions upon becoming eligible to make elective deferral contributions.

Under the provisions of the Plan, the Employer has the option to make discretionary profit-sharing contributions. Participants are eligible for discretionary profit-sharing contributions upon becoming eligible to make elective deferral contributions, completion of 1,000 hours of service during the plan year and be employed on the last day of the plan year. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions and employer matching and discretionary profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to two loans outstanding at any time. The loans are secured by the participant's vested account balance and bear interest at the prime rate, as defined by the plan administrator. Loan terms may not exceed five years, except for a loan for the purchase of a principal residence which may not exceed ten years. Principal and interest are paid ratably through payroll deductions or directly by the participant.

Vesting

Participants are immediately vested in their rollover, voluntary and employer discretionary profit-sharing contributions, plus actual earnings thereon. For participants hired before February 1, 2022, vesting in employer matching contributions is immediate. For those hired on or after February 1, 2022, vesting in employer matching contributions is based on a rate of 50% for each year of credit serviced. Participants are fully vested after two years of service or upon death, disability or attainment of normal retirement age of 65.

Payment of benefits

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$5,000 may elect to receive a lump-sum amount equal to the value of their account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, participant vested account balances greater than \$1,000 but less than \$5,000 will be made to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification. Participants with a vested balance of \$1,000 or less will receive a lump-sum payment upon termination.

Hardship withdrawals

Participants may elect to withdraw all or a portion of their elective deferral portion of their account if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

In-service withdrawals

Active participants who reach age 59 1/2 may withdraw all or part of their elective deferral portion of their account.

Forfeited accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$439 and \$1,775, respectively. These accounts are first used to pay plan expenses and then used to reduce employer contributions. During 2024, forfeited accounts of \$6,280 were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Contributions

Contributions from participants and from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

Payment of benefits

Benefit payments to participants are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net realized and unrealized appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits, the supplemental Schedule H Line 4i-Schedule of Assets (Held at End of Year), and the information related to investment activity reflected in the statement of changes in net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology includes:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Amounts are reported at cost, included accrued interest, which approximates fair values.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed Brokerage Accounts: Accounts primarily consist of interest-bearing cash, certificates of deposit (cash equivalents), corporate bonds, government securities (U.S.treasuries), marketable securities (common and preferred stock) and mutual and exchange traded funds. Corporate bonds are valued based on yields currently available on comparable securities of issuers with similar credit ratings. U.S. Treasuries are valued using pricing models maximizing the use of observable inputs for similar securities. Marketable securities are valued at the closing price reported on the active market on which the individual securities are traded. Mutual and exchange traded funds held by the Plan are funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual and exchange traded funds held by the Plan are deemed to be actively traded.

5. INVESTMENT CONTRACT

The Plan has a guaranteed investment contract with Fidelity. This contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

With traditional investment contracts, the Plan owns the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuer. The traditional investment contract held by the Plan is a guaranteed interest contract with defined maturity dates and is backed by the contract issuer's general account. The crediting rates are established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer.

1. The Plan's failure to qualify under Section 401(a) or 401(k) of the IRC.
2. The establishment of a defined contribution plan that competes with the Plan for employee contributions.
3. Any substantive modification of the portfolio or the administration of the portfolio that is not consented to by the wrap issuer.
4. Any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on the portfolio's cash flow.
5. Any communication given to unitholders by the plan sponsor, any other plan fiduciary or Fidelity that is designed to induce or influence unitholders not to invest in the portfolio or to transfer assets out of the portfolio.
6. Any transfer of assets from the portfolio directly into a competing investment option.

The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with the issuer or participants, is probable.

6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments, including interest-bearing cash, common/collective trust and mutual funds, are investment securities under a group annuity contract managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to an agreement between UniGroup C.A. and Fidelity. In situations where recordkeeping revenue received in connection with plan services exceeds agreed-upon compensation, Fidelity deposits amounts equal to such excess revenue in a suspense account in the Plan. Such amounts may be applied to pay Plan administrative expenses.

Certain Plan investments held were managed by Fidelity and Fidelity is the recordkeeper as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$12,681 for the year ended December 31, 2024. Fees paid by the plan for investment fees are reflected in net realized and unrealized appreciation in fair value of investments.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The Employer has adopted a non-standardized pre-approved profit-sharing plan sponsored by FMR, LLC. The non-standardized pre-approved profit-sharing plan has received a favorable opinion letter effective June 30, 2020 from the Internal Revenue Service (IRS) regarding the non-standardized pre-approved profit-sharing plan's qualified status. The Plan has been amended since receiving the opinion letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
