NOTE 1 – DESCRIPTION OF PLAN

The following description of the R&K Distributors, Inc. (“Company” and “Plan Sponsor”) 401(k) Deferred Compensation Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

GENERAL

The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended, which provides retirement, disability, and death benefits for eligible employees of the Company. Employees of the Company are eligible to participate in the Plan on the next entry date after completing six months of service and attainment of age twenty and one-half (20 ½). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

PLAN ADMINISTRATION

The Board of Directors of the Company appoints the Plan Administrator and the Plan Trustee. The Plan Trustee is the Company's President and is responsible for the governance of the Plan and monitoring the performance of the investments. The Plan Administrator is an employee of the Company. Employees of the Company may perform certain other administrative functions; however, such employees receive no compensation from the Plan.

The Plan’s third-party administrator is Texas Bank & Trust Company (“TB&T”). Administrative duties, such as preparation of the Form 5500, participant record keeping, compliance testing, and enrollment and transaction processing are done by TB&T. Plan assets are managed by Charles Schwab & Co., Inc.

CONTRIBUTIONS

Participants may elect to contribute pre-tax or after-tax amounts from eligible compensation, as defined by the Plan, not to exceed the limits of Internal Revenue Service (“IRS”) Code Section 401(k). In addition, participants that reach age 50 before the close of the plan year may make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. A matching contribution by the Company is discretionary for each Plan year. For the Plan year ended December 31, 2024, matching contributions were equal to 50% of the participant’s elective deferrals, including catch-up contributions, not to exceed two and one-quarter percent (2.25%) of the participant’s total compensation. Rollover contributions are permitted and remain in segregated, 100% vested, rollover accounts.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution and the Company matching contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting of Company contributions is as follows:

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Loans bear a reasonable rate of interest as determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid through payroll deductions.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or normal retirement age, a participant may elect to receive their vested benefit in a lump sum payment either in cash or as a direct rollover to a qualified individual retirement account or another tax-qualified plan. If the value of the participant's vested account balance is less than \$1,000, the form of distribution will be a lump sum distribution. Hardship and in-service distributions are permitted to be made only from accounts that are fully vested. A participant must be age 61 to qualify for an in-service distribution.

FORFEITURES

Forfeited non-vested amounts may be used by the Plan to pay administrative expenses and reduce employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested account balances. During the year ended December 31, 2024, there were no plan forfeitures used to pay Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

USE OF ESTIMATES

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustee determines the Plan's valuation policies utilizing information provided by investment advisors and the third-party administrator. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

CONTRIBUTIONS

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the participant compensation is earned.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions payable as of December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

The Company, at its sole discretion, may pay the administrative expenses (i.e. custodial fees, fund fees, loan fees, recordkeeping fees and other similar expenses) of the Plan and such expenses would be excluded from these financial statements. If such expenses are not paid by the Company, they are paid out of Plan assets. Investment-related expenses are included in net appreciation (depreciation) in the fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification Topic (“ASC”) 820, *Fair Value Measurements and Disclosures*, are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Money market funds:

The Plan has investments in money market funds which are valued at the per unit price as quoted by the financial institution. As of December 31, 2024 and 2023, the Plan had \$115,393 and \$552,068, respectively in money market funds. The money market funds are considered Level 1 investments.

Mutual funds:

The fair value of mutual funds are based on quoted net asset values of the shares as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. As of December 31, 2024 and 2023, the Plan had \$6,019,030 and \$5,428,760, respectively, invested in mutual funds. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The mutual funds are considered Level 1 investments.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the third-party administrator TB&T.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedules.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

TB&T is the third-party administrator as defined by the Plan and provides investment management services to the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of investments and administrative expense are shown separately as deductions from net assets on the statement of changes in net assets available for benefits.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 – TAX STATUS

The Plan Sponsor has adopted a prototype standardized profit-sharing plan with a cash or deferred arrangement which received an opinion letter from the IRS that the form of the Plan is acceptable under Section 401(a) of the IRC and is, therefore, not subject to tax under present income tax law. The Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

Subsequent events were evaluated through September 9, 2025, which is the date the financial statements were available to be issued.


