## 1. Description of Plan

The following description of the Wis-Pak, Inc. Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective September 1, 1988 and most recently restated January 1, 2021. All full-time employees of Wis-Pak, Inc. (the Company) who have completed at least one month of service and all part-time employees who have completed 12 consecutive months of service and worked at least 1,000 hours in said months are eligible to participate in the Plan. New participants, who have met the eligibility requirements, can enter the Plan and start making elective deferrals and receiving matching contribution amounts on the first day of each month. Participants who have completed six months of service are eligible for the Company discretionary profit sharing contribution on the first day of the first or seventh month of the plan year coinciding with or following the date on which this service requirement is met. Long-term part-time employees who meet eligibility requirements under SECURE 2.0 are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in the Plan's default investment option until changed by the participant. Employees are automatically enrolled as soon as administratively feasible. The Company makes matching contributions equal to 50% of employee contributions on the first 6% of each participant's eligible compensation. Additional company contributions may be contributed at the discretion of the Company's Board of Directors. The Company approved a discretionary profit sharing contribution equal to 3% of each participant's eligible compensation in 2024. A participant must also be employed by the Company on the last day of the plan year and have completed 1,000 hours of service in the plan year to be eligible to receive an allocation of the Company discretionary profit sharing contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, the Company's matching contributions, an allocation of the Company's discretionary profit sharing contribution based on eligible participant compensation and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's eligible compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their elective deferral contributions, rollover contributions and Company matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after one year of credited service and continues to vest in annual increments of 20% until 100% vested after five years of credited service. Employees become fully vested upon death, disablement or reaching the normal retirement age while employed with the Company.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan document. Upon termination of service, a participant will receive a lump sum payment if the participant's interest in the Plan does not exceed \$5,000. If the participant's vested interest in the Plan exceeds \$5,000, the participant may elect to receive a lump sum amount equal to the vested value of his or her account or installments over a period of time. The Plan also allows for withdrawals upon attainment of age 59½ and for hardship withdrawals if participants meet certain criteria as defined by the Plan.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,474 and \$50,225, respectively. These accounts may first be applied to the payment of the Plan's administrative expenses, if so directed by the Company. Any remaining forfeitures may be used to reduce the Company's contributions. Forfeitures of \$115,819 were used to pay administrative expenses and forfeitures of \$26,202 were used to reduce employer contributions during the 2024 plan year.

## Notes Receivable From Participants

Loans to participants are not allowed under the current plan document.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

## Transfers

The Company's majority owned subsidiary, WP Beverages, LLC, is the sponsor of a different 401(k) plan. If employees transfer or change status during the year, their account balances are transferred into or from this corresponding plan.

## Subsequent Events

Subsequent events were evaluated through August 5, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the plan was amended to be a safe harbor plan. The safe harbor matching contribution, which replaces the current employer matching contribution, is equal to 100% of employee contributions for the first 1% of plan eligible compensation plus 50% of employee contributions between 1% and 5% of plan eligible compensation. The safe harbor matching contribution is always fully vested. Additionally, the plan now includes an annual automatic contribution increase which increases employee deferral rates by 1% each year, up to a maximum of 15% of eligible compensation, unless the employee elects otherwise.

Effective January 21, 2025, participants aged 60-63 at the end of the plan year are eligible to make additional catch-up contributions as part of the SECURE 2.0 Act. Additionally, in 2025 the Plan's automatic distribution threshold increases to \$7,000.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the NAV of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

## 4. Concentrations

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the Plan had investments of \$46,425,858 and \$47,317,622, respectively, that were concentrated in two funds.

## 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by the trustee and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

## 8. Tax Status

The Plan adopted a pre-approved plan offered by Vanguard Fiduciary Trust Company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
