Report of Independent Auditors

To the Administrator of U.S. Associate Savings Advantage Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

Schedule H, line 4a – Schedule of Delinquent Participant Contributions as of December 31, 2024 and Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 ("supplemental schedules"), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. In our opinion



- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The U.S. Associate Savings Advantage Plan (the “Plan”) is a defined contribution plan which was established on July 1, 2006 by Mars, Incorporated (the “Company”) so that eligible U.S. employees (“Associates”) may accumulate funds for their future security. The Plan is administered by the U.S. Benefit Plans Committee (“USBPC”) and its delegates as established by the Board of Officers of the Company. Employer and participant contributions are placed in a trust fund. Fidelity Workplace Services LLC (“Fidelity”) is the record keeper and Fidelity Management Trust Company is the trustee. See [Note 3](#) for the information certified by the Fidelity Management Trust Company (the “Trustee”) as of and for the years ended December 31, 2024 and 2023. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

Eligibility

Associates of the Company and its U.S. participating subsidiaries (the “Employers”) are eligible for the Plan when they are hired by the Employer as full-time Associates or upon reaching their 91st day of continuous employment if they are part-time Associates. Individuals covered by a collective bargaining agreement are not eligible for the Plan. Effective March 31, 2023, Champion Petfoods (“Champion”) began participation in the Plan. Participants should refer to the Plan document for more complete information.

Plan Administration

The Plan is administered by the USBPC established by the Mars, Incorporated Board of Officers. The USBPC has delegated the daily administration and fiduciary responsibility to Mars Benefits.

Interest in U.S. Defined Contribution Plan Trust

The assets of the Plan are maintained, for investment purposes only, on a commingled basis with the assets of the U.S. Associate Savings Plan, the Mars Deferred Compensation Plan (“MDCP”) and the Mars Veterinary Health 401(k) Savings Plan (collectively, the “Plans”) in the U.S. Defined Contribution Plan Trust (the “Master Trust”). The Plans own a specific interest in the Master Trust assets. The portion of Master Trust net assets specific to each plan is based upon the participants’ account balance within each plan. Investment income for each fund is allocated to each plan based on gains (losses) of the participants’ accounts. Effective August 1, 2024, KIND 401(k) Savings Plan began participation in the Master Trust.

Change in Accounting Policy for Contributions

Effective January 1, 2024, the Plan changed its accounting policy to measure contributions from Plan participants and the related matching contributions from the Employer to when amounts were withheld from the Participant's compensation. Previously, the Plan accrued contributions as of the end of the plan year in the period in which such contributions applied. The Plan changed the accounting policy as it more closely aligns the recognition of assets with the actual flow of funds, which may not always coincide with the timing of cash flows or the actual withholding event. The change in accounting policy did not have a material impact on the financial statements of the Plan.

Contributions

Plan participants may elect to contribute up to 75% of their annual eligible earnings, as defined in the Plan document on a pre-tax, Roth, or after-tax basis (or any combination thereof). Pre-tax contributions (commonly referred to as 401(k) contributions) are placed in the Pre-Tax Account and Roth contributions are placed into a separate Roth account. After-tax contributions are placed in the After-Tax Account. In addition, participants who are age 50 or over by December 31 may elect to

contribute additional catch-up contributions to their Pre-Tax Accounts in accordance with the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit plans, excluding Roth contributions, or defined contribution plans (rollovers). Eligible associates who do not elect otherwise, are automatically enrolled in the Plan at a 2% contribution rate. Eligible associates who do not elect otherwise, are enrolled in an automatic 1% annual contribution increase, up to a maximum of 20%.

Employers contribute an amount equal to 50% of the first 6% of the amount of pre-tax and/or Roth contributions made by each participant (up to 3% of eligible earnings) into such participant's Matching Account.

NomNomNow and Champion contribute an amount equal to 100% of the amount of pre-tax and/or Roth contributions made by each participant (up to 4% of eligible earnings) into the participant's Matching Account.

In 2024 and 2023, the statutory limit of total annual contributions (employer and participant) to a participant's account may not exceed \$69,000 (\$76,500, if age 50 or older) and \$66,000 (\$73,500, if age 50 or older), respectively, or 100% of a participant's eligible earnings, whichever is less. All fund investment elections are participant directed and may be changed daily subject to trading rules as established by each fund. The assets of each fund are invested by the fund's investment manager.

Participant Accounts

The balance in the participant's account reflects the cumulative amount of participant and Employer contributions, the investment returns resulting from participant directed investments, payment of benefits, fees and in-service withdrawals and loans, when applicable.

Transfers in the Ordinary Course of Plan Operations

Transfers between the Plans in the ordinary course of Plan operations primarily relate to new organizational positions, rehired Associates by one of the Employers with an existing balance in another Company plan or transferred Associates to one of the Employers with an existing balance in another Company plan. Upon transfer, the Associate's prior plan account is merged into the active plan as soon as administratively practicable.

Vesting

Participants are 100% vested in all account balances.

Distributions and Withdrawals

Each participant's account balance in the Plan, consisting of Pre-Tax Contributions, Roth Contributions, After-Tax-Contributions, Matching Contributions, Rollover Contributions and investment gains and losses, generally remains in the Plan until a distribution is made. Active participants may request to withdraw, up to twice a year, any portion of their After-Tax Account or the Rollover Account, and, if applicable, the portion of the Mandatory Deferred Account that has been in their Unrestricted Deferred Sub-Account (as collectively defined in the Plan document), provided that the Unrestricted Deferred Sub-Account was transferred from the MDCP, for at least 24 months prior to the date of withdrawal. Upon reaching age 59-1/2 participants may request, once a year, a full or partial withdrawal from the Pre-Tax, Matching and Mandatory Deferred Accounts in addition to the pre-age 59-1/2 withdrawal. Retired and terminated participants with balances greater than \$7,000 may leave the balance in the Plan until age 73 at which time required minimum distributions must be paid. Prior to January 1, 2024, retired and terminated participants with balances greater than \$5,000 were able to leave the balance in the Plan until age 73 at which time required minimum distributions were paid. Partial distributions are allowed. Other options are a lump sum distribution, total or partial rollover, and fixed or lifetime installments.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (minus the highest outstanding loan balance in the immediate preceding one-year period) or 50% of their account balance. Loans are secured by the balance in the participant's account and bear interest at rates that equal the prime rate plus 1% as quoted by Reuters on the first business day of the month the loan is made. The rate is fixed for the period of the loan. Principal and interest are generally paid through payroll deductions. Participants may have two loans with no more than one Primary Residence loan outstanding at any time. All loans must be paid over a one to five-year period, unless the loan is for the purchase of a principal residence, in which case it may be repaid over a ten-year period. Interest rates were 4.25% to 9.50% for loans outstanding at December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). In the event of termination or partial termination of the Plan, which is presently not contemplated, participants would receive their vested account balances.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the participant contributions are withheld from compensation.

Investment Valuation in U.S. Defined Contribution Plan Trust

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Under the guidance of the Master Trust Committee, Mars Benefits determines the valuation policies using information provided by the Trustee for their respective periods, as described in [Note 1](#). See [Note 4](#) for further discussion of fair value measurements.

Income Recognition in U.S. Defined Contribution Plan Trust

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of the Master Trust investments consists of the realized gains (losses) and the unrealized appreciation (depreciation) of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable

included in the Plan's statement of net assets available for benefits at December 31, 2024 were \$36,762. These amounts were corrected timely under self-correction program in 2025. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in interest bearing cash, mutual funds and common collective trusts ("CCTs") through the Master Trust. Such investments are exposed to various risks such as interest rate, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Administrative Fees

Loan fees, purchase fees and redemption fees are paid by participants on an as-incurred basis. Fidelity investment advice fees are related to an optional service charged to participants based on a percentage of the participants' account balances. The percentage is tiered based on the balance in the participant's account. LCG Associates, Inc. ("LCG") advisory fees and Fidelity recordkeeping fees are flat fees that are evenly allocated to each participant's account.

The Company pays audit fees and other administrative expenses.

3. Information Certified by the Trustee

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the ERISA, the following information, the information in [Note 6](#) related to the Master Trust, the investment values in [Notes 4](#) and [5](#), excluding the fair value measurement leveling, and the supplemental schedule were derived from the information certified as to completeness and accuracy by the Trustee.

4. Fair Value Measurements

In accordance with the authoritative guidance on fair value measurements, the Plan discloses the fair value of its investments in a hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. The guidance provides a consistent definition of fair value which focuses on an exit price, the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no level 3 investments held during or as of the years ended December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Interest bearing cash: Government short-term investment funds ("STIFs") which invest primarily in U.S. government securities, repurchase agreements collateralized by U.S. government securities or money market funds.

Self-directed brokerage accounts: Participant-directed funds that are invested in mutual funds, common stock, certificates of deposit, bonds, rights/warrants and cash.

Mutual funds: Valued at the Net Asset Value ("NAV") of shares held by the Plan at year end.

Common collective trusts: Common collective trusts ("CCTs") are valued at the NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation

methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Details on investments held at the NAV as a practical expedient are included in [Note 5](#). Details on the Master Trust's fair value measurement levels and the Plan's interest in the Master Trust are included in [Note 6](#).

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated September 21, 2015 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plans' tax counsel believe that the Plan is designed, and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would not be sustained by examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

8. Party-in-Interest and Related Party Transactions

Fidelity, the Trustee, and LCG are considered parties-in-interest due to their roles as fiduciaries to the Plan. Administrative fees paid to Fidelity, investment activity related to the CCTs, administrative fees paid to LCG and notes receivable from participants are considered party-in-interest transactions.
