To the Designated Plan Administrator, Plan Sponsor Companies, Participants and Beneficiaries of the Wanner Engineering, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wanner Engineering, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Wanner Engineering, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan is a multiple employer defined contribution plan adopted by WEC, Inc. and J & J Technical Services, LLC (together, the "Companies") for employees, other than union or non-resident aliens, who become eligible to participate on the first entry date after completing one month of service and attaining age 21. Entry dates are January 1, April 1, July 1, and October 1. The Plan's assets are managed by Lincoln National Life Insurance Company ("Lincoln"). Lincoln is also the recordkeeper for the Plan. FuturePlan by Ascensus ("FuturePlan"), the Designated Plan Administrator, is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has an investment committee that determines the appropriateness of the Plan's investment offerings and monitors investment performance, and reports to the Companies.

[2] Contributions:

Participants may elect to make pre-tax or Roth deferral contributions of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Pre-tax and after-tax deferrals are not to exceed the amount allowable under Section 415 of the Internal Revenue Code ("IRC").

The Plan provides a safe harbor nonelective contribution, whereby, the Companies will make a nonelective contribution for each eligible participant in an amount equal to 3% of eligible participants' compensation, which is immediately vested when contributed. The Plan excludes highly compensated employees from the safe harbor nonelective contribution. Discretionary matching and discretionary nonelective contributions may be made at the option of the Plan committee. During the year ended December 31, 2024, the Companies contributed \$361,464 and \$104,200 of safe harbor nonelective contributions and discretionary nonelective contributions, respectively. Discretionary nonelective contributions are allocated at the Companies discretion. The Companies did not make any discretionary matching contributions for the Plan year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, increasing 1% annually to a maximum of 10%. Participants that are auto-enrolled have their contributions invested in the Vanguard Target Date Fund that coincides with their estimated retirement date, until changed by the participant.

[3] Participant accounts:

Each participant's account is credited with the participant's contribution and the Companies' safe harbor and discretionary contributions, as well as plan earnings and participants are charged with administrative expenses that are paid by the Plan. Plan earnings and administrative expenses are allocated based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[4] Vesting:

Participants are always 100% vested in their pre-tax salary reduction contributions, Roth contributions, rollover contributions, safe harbor nonelective contributions, and related earnings. Participants vest 20% each year beginning after two years of service in their discretionary employer contributions and related earnings. Upon termination of employment, any nonvested amount of employer-derived contributions is forfeited.

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, as defined. Interest rates on outstanding loan balances range from 4.25% to 9.50% as of December 31, 2024 and 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. Participants are only allowed two outstanding loans at a time. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

[6] Payment of benefits:

On termination of service due to death, disability or normal retirement, a participant or a participant's beneficiary may elect to receive a lump-sum amount equal to 100% of the participant's account balance. In addition, participants may obtain hardship withdrawals, as defined by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account. The Plan requires minimum distributions for participants between ages 70½ to 73 depending on the IRC.

The Companies operationally adopted certain provisions of the Secure 2.0 Act including distributing vested benefits of \$7,000 or less in a single lump-sum or installments as soon as practicable after the event occurs that entitles a participant to a distribution. Vested benefits that exceed \$7,000 are distributed either in a single lump-sum payment or installments over a period not more than the participant's life expectancy or may be left in the plan. For the Plan year ending December 31, 2023, the distribution threshold amount was \$5,000.

[7] Forfeitures:

Forfeited nonvested accounts may be used to reduce future contributions by the Companies and pay Plan expenses. During the year ended December 31, 2024, forfeitures of approximately \$10,600 were used to pay Plan expenses. Forfeited nonvested accounts available at December 31, 2024 and 2023 were \$7,607 and \$10,328, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[2] Subsequent events:

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

The Plan was amended effective January 1, 2025, whereby participants will be 100% vested in their discretionary employer nonelective contributions; vesting of discretionary employer matching contributions was not modified.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Lincoln. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid directly by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net realized/unrealized appreciation in value of investments.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Designated Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Lincoln National Life Insurance Company has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts – Valued at net asset value ("NAV"), as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. The pooled separate accounts are invested in mutual funds. Investments valued utilizing NAV as a practical expedient are excluded from the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Lincoln Financial Group Stable Value Account is a fully benefit-responsive guaranteed investment contract available as an investment option to plan participants. The investment contract is issued by Lincoln. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to the investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value but is not allowed to transfer funds from the contract to a competing fund.

The contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00% percent. The crediting rate is reviewed on an annual basis for resetting.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The issuer may terminate the contract under the following circumstances:

1. Any charges billed to the Companies have not been paid to Lincoln within 30 days; or
2. The Plan ceases to meet the requirements of the IRC sections specified by Lincoln for purchasers of the contract; or
3. At any time following the end of the second contract year, the contract owner account is less than \$25,000; or
4. There is no deposit activity for a 24 consecutive month period; or
5. The Companies fails to furnish requested information or other documentation; or
6. Lincoln discovers any misrepresentation of material information.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Ascensus LLC. On June 30, 2020, the Internal Revenue Service stated in an advisory letter that the Ascensus LLC Plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed or affiliated with Lincoln and therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to Lincoln were \$48,394 for the year ended December 31, 2024. The Plan also pays third-party administrator and investment advisory fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$58,252 for the year ended December 31, 2024.

NOTE H - NONEXEMPT PROHIBITED TRANSACTIONS

During the Plan year ended December 31, 2023, the Companies failed to remit certain participant contributions totaling \$80,936, timely to the Plan. The Companies remitted the contributions to Lincoln as of December 31, 2023, and contributed the related lost earnings in June 2024.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their contributions from the Companies.
