  - d. All minutes of the meetings of the administrative committee, or summaries of actions of recent meetings for which minutes have not yet been prepared.
  - e. Plan instruments, trust agreements, and amendments to such documents entered into during the year (including amendments made to comply with applicable laws), or insurance contracts.
  - f. All correspondence to and from regulatory agencies, including communications concerning compliance with laws and regulations.
  - g. Results of the assessment of risk that the financial statements may be materially misstated as a result of fraud.
5. We have no plans or intentions that may materially affect the carrying amounts or classifications of assets and liabilities.
6. We have identified all accounting estimates that could be material to the financial statements, including the key factors and significant assumptions underlying those estimates. We believe the methods, data, and significant assumptions used in developing the accounting estimates and the related disclosures are appropriate in the circumstances. These estimates include the fair values of Plan investments and derivative instruments and the classifications of Plan investments and derivative instruments within the fair value hierarchy, pursuant to and in accordance with FASB ASC 820, *Fair Value Measurements and Disclosures*.
7. Adequate provision has been made for adjustments and losses in collection of receivables. There were no investments in default and none are considered to be uncollectible.
8. The following have been properly recorded or disclosed in the financial statements, if applicable:

- a. Material liabilities or gain or loss contingencies that are required to be accrued or disclosed by FASB ASC 450, *Contingencies*.
  - b. Significant accounting estimates that are susceptible to changing materially as a result of an event or change in conditions that is reasonably possible of occurrence within one year from the financial statement date.
  - c. Concentrations that make the Plan vulnerable to the risk of a severe impact within one year from the financial statement date (including the nature and type of investments held by the Plan, or markets for which events could occur which would significantly disrupt normal finances within the next year).
  - d. Amendments to the Plan document during the year or subsequently.
9. All related parties and all related party relationships and transactions, and transactions with parties-in-interest (as defined in ERISA section 3(14)) and related amounts receivable or payable, including sales, purchases, loans, transfers, leasing arrangements and guarantees, have been disclosed to you, and have been appropriately accounted for and disclosed in the financial statements in accordance with the requirements of accounting principles generally accepted in the United States.
10. We have no knowledge of any fraud or suspected fraud affecting the Plan involving:
- a. Management, whether material or not.
  - b. Employees who have significant roles in internal control, whether material or not.
  - c. Others when the fraud could have a material effect on the financial statements.
11. We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan's financial statements received in communications from employees, former employees, participants, analysts, regulators, service providers, third party administrators, or others.
12. There have been no communications from regulatory agencies concerning noncompliance with or deficiencies in financial reporting practices that could have a material effect on the financial statements in the event of noncompliance.
13. We believe the effects of cybersecurity risks and actual breaches are properly accounted for and disclosed in the financial statements.
14. The Plan and trust established under the Plan are qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified Plan and trust. The

Plan sponsor has operated the Plan and trust in a manner that has not jeopardized this tax exempt status. The Plan has complied with fee disclosure requirements to participants under DOL Regulation Section 2550.404a-5, and has received the required disclosures from service providers under ERISA Section 408(b)(2). We understand that failure to comply could cause the Plan to enter into a prohibited transaction. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.

15. All required filings of Plan and trust documents have been filed with the appropriate agencies. The non-standardized pre-approved profit sharing plan adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the non-standardized pre-approved profit sharing plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.
16. There are no --
  - a. Nonexempt transactions with parties in interest, as defined in ERISA section 3(14) and related regulations, that were not disclosed in the supplemental schedules or financial statements.
  - b. Investments, loans, or leases in default or considered to be uncollectible that were not disclosed in the supplemental schedules.
  - c. Reportable transactions as defined in ERISA section 103(b)(3)(H) and related regulations that were not disclosed in the supplemental schedules.
  - d. Untimely remittances of participant contributions to trusts containing assets for the Plan, as determined by the Department of Labor's participant contribution regulation (29 C.F.R. Sec 2510.3-102), that were not properly disclosed in the supplemental schedules.
17. The Plan has complied with the fidelity bonding requirements of ERISA.
18. There are no violations of any laws or regulations (including ERISA, DOL and IRS) whose effects should be considered for disclosure in the financial statements or as a basis for reporting a

loss contingency, or other material liabilities or gain or loss contingencies that are required to be accrued or disclosed.

19. The Plan has satisfactory title to all owned assets. None of the Plan's assets were mortgaged, assigned, pledged, or encumbered by law in any other manner. No security agreements have been executed under the provisions of the Uniform Commercial Code, there are no liens or encumbrances on assets, and no assets have been pledged.
20. The Plan had no purchase commitments for investments at prices in excess of fair value at the date of the financial statements, no agreements to repurchase items previously sold, and no sales commitments at prices expected to result in losses on fulfillment.
21. All investments, other than participant loans reported at outstanding balances, are valued at fair value, as defined by FASB ASC 820. Quoted prices in active markets for identical investments are used to determine fair values, when available. All matters of judgment involved in the calculation and determination of the fair values of investments, and all related valuation methods and assumptions and financial statement disclosures, including the reporting of investments within the fair value hierarchy defined by ASC 820, are the responsibility of management. The valuation methods and assumptions used are reasonable and supportable, have been determined in compliance with ASC 820, and have been adequately disclosed in the financial statements for all periods presented.
22. The Plan has no direct or indirect interests in fully benefit-responsive investment contracts.
23. The Plan has made no investments during the year that violate the terms of the Plan or Trust Agreement.
24. The Plan has complied with all aspects of debt and other contractual agreements that would have a material effect on the Plan's financial statements in the event of noncompliance.
25. The form and content of the information included in the financial statements and supplemental schedule are presented in compliance with the DOL Rules and Regulations for Reporting and Disclosure under ERISA.
26. We have complied with the applicable reporting and disclosure requirements under ERISA relating to the Summary Plan Description, Summary of Material Modifications, and the Summary Annual Report, as applicable.
27. No events have occurred subsequent to the date of the Plan's financial statements and through the date of this letter that would require adjustments to, or disclosure in, the financial statements.

28. There are no present intentions to terminate the Plan.
29. We have disclosed to you all known actual or possible litigation, claims and assessments whose effects should be considered by management when preparing the financial statements. These matters have been accounted for and disclosed in conformity with accounting principles generally accepted in the United States. The Plan, Plan Administrator, or Plan Sponsor on behalf of the Plan has not consulted with or been represented by legal counsel, during the period audited to the date of this letter, regarding any litigation, claims, or assessments asserted or unasserted, or qualification matters relating to the Plan.
30. The Plan administrator has obtained certifications from Charles Schwab Trust Bank and Fidelity Management Trust Company stating that the 2024 information provided to the Plan administrator, as disclosed in the financial statement, is complete and accurate.
31. During the course of your audit, we have provided to you physical or electronic copies of various original documents. We understand that you are relying on such copies as audit evidence in your audit and represent that copies provided are an accurate and complete representation of the original documentation and that the copies have not been modified from their original version.
32. We have provided the most current Plan instrument for the period under audit, including all Plan amendments.
33. We acknowledge our responsibility to administer the Plan and determine that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.
34. We acknowledge that our election of the ERISA Section 103(a)(3)(C) audit does not affect our responsibility for the financial statements and for determining whether:
  - a. an ERISA Section 103(a)(3)(C) audit is permissible,
  - b. the investment information is prepared and certified by a qualified institution as described in 29 CFR 2520.103-8,
  - c. the certification meets the requirements in 29 CFR 2520.103-5, and
  - d. the certified investment information is appropriately measured, presented, and disclosed in accordance with Generally Accepted Accounting Principles.

## INDEPENDENT AUDITOR'S REPORT



**NOTE 1 – DESCRIPTION OF PLAN**

Tally Personnel 401(k) Profit Sharing Plan (the “Plan”) is a defined contribution retirement plan sponsored by Tally Personnel, LLC, for the benefit of eligible employees. The Plan was adopted effective January 1, 2015, most recently restated effective February 1, 2022, and further amended effective January 1, 2024 and October 16, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Plan was amended to add an eligible automatic contribution arrangement (EACA) with automatic deferral escalation, and to update vesting provisions. Effective October 16, 2024, the Plan was further amended in connection with the change in service providers from Charles Schwab Trust Bank to Fidelity Management Trust Company.

The following description of the Plan provides only general information. Participants should refer to the legal plan document and trust agreement for a more complete description of the Plan’s provisions.

Eligibility: All employees of the Company (except for certain collectively bargained, leased, or nonresident alien employees) are eligible to participate upon completion of at least one hour of service. Entry dates are the first day of the month following satisfaction of eligibility.

Contributions: Participants may contribute up to 100% of eligible compensation, on either a pre-tax or Roth 401(k) basis, subject to Internal Revenue Code limits. Catch-up contributions are permitted for participants age 50 and older. Participants may elect to start, increase, or reduce their elections to contribute to the Plan as soon as administratively feasible. Participants may suspend their elections at any time.

Effective January 1, 2024, newly eligible employees who did not make an affirmative deferral election were automatically enrolled under the Plan’s EACA. The initial default deferral rate is 1% of compensation, which automatically increases by 1% on each anniversary of a participant’s initial automatic enrollment, up to a maximum of 3% of compensation. Participants may affirmatively elect to change or opt out of the default. The Plan permits participants who are automatically enrolled to take a permissible withdrawal of their initial automatic contributions if requested within 60 days of the first automatic deferral.

The Company may make discretionary matching and/or nonelective contributions. For the 2024 plan year, the Company elected to provide a matching contribution equal to 50% of elective deferrals up to 6% of compensation. No profit-sharing contributions were made in 2024.

Participants are permitted to deposit into the Plan distributions received from other retirement plans or certain IRAs as rollover contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their elective deferrals, Roth contributions, and rollover contributions. Employer matching and nonelective contributions are subject to a vesting schedule. Matching and nonelective contributions vest on a graded schedule of 25% per year, reaching 100% after four years of service. For participants who terminated employment with a balance as of December 31, 2023, a separate 1–4 year graded vesting schedule continues to apply in accordance with the January 1, 2024 Plan amendment.

Payment of Benefits: Upon termination of employment, normal retirement, disability, or death, a participant or designated beneficiary may elect to receive their vested interest in the Plan as a single lump-sum payment in cash, a direct rollover distribution, or a combination of both. If a participant's vested account balance in the Plan exceeds \$5,000, the participant or designated beneficiary must consent to any distribution. If a participant's vested account balance is \$5,000 or less, the account will be distributed to the participant without consent as a lump-sum payment in cash.

Participants who have attained age 59½ may receive an in-service distribution from certain accounts prior to termination of employment. Hardship distributions are also available to participants to satisfy certain immediate and heavy financial needs. In addition, participants may receive a distribution from their rollover contribution account at any time.

Notes Receivable From Participants: Loans are made available to participants on a reasonably equivalent basis. Participants may borrow from their vested account balance a minimum loan amount of \$1,000 up to a maximum of the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months, or one-half the present value of their vested account balance. Loans are adequately secured and charged a commercially reasonable rate of interest. The term of the loan may not exceed five years unless the loan is for the purchase of a principal residence. Principal and interest are paid ratably through payroll reductions.

Forfeitures: If a participant's employment with the Company terminates and they receive a distribution of the entire vested portion of their account, they will forfeit the nonvested portion of their account. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,942 and \$1,848, respectively.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 19, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (as of December 31, 2024, and for the period from October 16, 2024 to December 31, 2024) and Charles Schwab Trust Bank (as of December 31, 2023, and for the period from January 1, 2024 to October 15, 2024).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3*: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Fund: Fair value is estimated to approximate the cost basis of the deposit account balance which is based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds shares of mutual funds managed by Fidelity Management Trust Company (Fidelity). Fidelity is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to Fidelity qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
