## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### (1) Description of the Plan

The following description of the Mountain Park Health Center Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General** – The Plan was originally effective on July 1, 1992. The Plan has been amended and restated throughout the years to comply with tax legislation. The Plan was last amended and restated effective January 1, 2020. The Plan is a 403(b) plan covering employees of Mountain Park Health Center (Employer). Employees become eligible for 403(b) deferrals on their date of hire. In order to receive the Employer contributions, an employee must satisfy the two years of service requirement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Pension Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective January 1, 2024, the Pension Committee approved a 3% eligible automatic contribution arrangement for all existing employees not already participating, and who did not have an existing salary deferral agreement on file indicating the employee's desire not to participate in the Plan.

Effective January 1, 2024, the Pension Committee approved an amendment to the Plan implementing a one year of service eligibility requirement and 2-year cliff vesting for employer matching contributions for employees hired on or after January 1, 2024.

**B. Contributions** – The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage or flat dollar amount, of their compensation contributed as pre-tax 403(b) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Each eligible participant will receive an Employer matching contribution of 50% of the employee's elective deferral contributions not to exceed 6% of the employee's eligible compensation. The Employer may, at its discretion, elect to make a qualified non-elective contribution to the Plan. There were no Employer qualified non-elective contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**C. Participant accounts** – Each participant's account is credited with the participant's contributions, the Employer matching contributions, an allocation of the Employer qualified non-elective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**D. Vesting** – Participants are immediately vested in their 403(b) deferrals and Employer contributions plus actual earnings or losses thereon. Effective January 1, 2024, the Plan added a 2-year cliff vesting for employer matching contributions for employees hired on or after January 1, 2024.

(1) **Description of the Plan (continued)**

- E. Benefit payments** – Upon termination of service, death, disability, or retirement, a participant will receive the value of the vested interest in their account as a lump sum distribution, in installments, or an annuity as elected by the participant. If a participant terminates employment and the participant's vested balance is less than \$5,000, the Plan Administrator will authorize a mandatory distribution to an IRA. The Plan allows for in-service distributions if a participant reaches age 59 ½, and hardship provisions subject to Plan provisions.
- F. Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The terms range up to five years or longer for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Participants may have up to two notes outstanding at a time. At December 31, 2024 and 2023, the interest rate on outstanding loans ranged from 4.25% to 9.50%.
- G. Plan loans** – Participants may borrow amounts from the Lincoln National Life Insurance Company (Lincoln), an insurance company of the Plan. The loan amount cannot be less than \$1,000. In no event can the amount of the loan, when added to the outstanding balance of all other loans from any of the Employer's plans, exceed the lesser of the following:
- (1) \$50,000 reduced by the excess (if any) of:
    - a. The highest outstanding balance of loans from any of the Employer's plans during the one year period ending on the day before the date on which the loan is to be made; over
    - b. The outstanding balance of loans from any of the Employer's plans on the date on which the loan is to be made;
  - (2) 50% of the present value of the vested accrued benefit under any of the Employer's plans

These loans are direct loans between the participant and Lincoln, and as such they are not treated as an asset of the Plan. The loans are secured by the balance in the participant's account. Loan terms are up to five years, except for loans to fund the purchase of a principal residence, for which the loan may be repaid over a reasonable period that may not exceed 20 years.

Outstanding loans between Plan participants and Lincoln totaled \$73,290 and \$109,615 as of December 31, 2024 and 2023, respectively, and thus related Plan balances are designated as collateral.

- H. Administrative expenses** – Plan participants pay costs associated with certain investment expenses such as fund withdrawal fees, which are deducted from the respective participant's account. Also, fees are paid by the account of the participant taking a loan. The Employer pays all other Plan administration costs. Investment management related expenses and fees related to the administration of notes receivable from participants are included in administrative expenses.
- I. Plan termination** – Although it has not expressed any intention to do so, the Employer has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, net assets of the Plan will be allocated in accordance with the terms of the Plan.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The accompanying financial statements are prepared using the accrual basis of accounting. Benefits are recorded when paid. The Plan was established in July 1, 1992 and was historically viewed as an amalgamation of individual annuity and custodial accounts.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Management's use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

**Investment valuation and income recognition** – The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and uncertainties** – The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

On April 2, 2025, President Trump signed the Executive Order, *Regulating Imports with a Reciprocal Tariff to Rectify Trade Practices that Contribute to Large and Persistent Annual United States Goods Trade Deficits* ("the April 2 EO"), to take action based on the results of certain investigations related to the causes of the U.S.'s large and persistent annual trade deficits in goods. Subsequent to the April 2 EO, there have been additional Executive Orders that have, among other actions, effectively suspended the enforcement of certain country-specific tariffs until specific dates, for all trading partners except for the People's Republic of China. The Plan Sponsor's currently assessing the potential impact of these actions. Additionally, as a result of the impact of these actions on the financial markets, the Plan's investment portfolio may experience significant volatility.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

**Payment of benefits** – Benefits are recorded when paid.

**Subsequent events** – The Plan's management has evaluated subsequent events through August 4, 2025, which is the date the financial statements of the Plan were available to be issued.

### (3) Fair value measurement

The fair value measurement framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds at TIAA:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan at TIAA are deemed to be actively traded.

*Mutual Funds at Lincoln:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan at Lincoln are not actively traded.

*Self-Directed Brokerage Accounts:* The self-directed brokerage accounts primarily consist of common stocks, mutual funds, and cash. Common stocks are stated at fair value, which is based on the closing price reported on the active market which the common stock is traded.

### (3) Fair value measurement (continued)

*Pooled Separate Account:* Valued at the net asset value (NAV) of units as determined by TIAA and CREF. NAV is a readily determinable fair value and is the basis for current transactions. The pooled separate accounts had no unfunded commitments as of December 31, 2024 and 2023 and could be redeemed daily with no redemption notice period or other redemption restrictions.

*Investment Contracts with Insurance Companies:* The TIAA Traditional Annuity is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer (see Note 5). In determining the reasonableness of the methodology, the Pension Committee evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate). The Lincoln Fixed Account is valued at the NAV of units as determined by Lincoln, which is a practical expedient for estimating the fair value of this investment. The Lincoln Fixed Account had no unfunded commitments as of December 31, 2024 and 2023 and could be redeemed daily with no redemption notice period or other redemption restrictions.

### **(5) Investment contracts with insurance companies**

In 2013, the Plan entered into a fully benefit-responsive guaranteed investment contract with TIAA (insurance company). TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.50%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Plan management believes that no such events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan also holds non-benefit-responsive contracts with TIAA and Lincoln. Each participant maintains individual annuity contracts with the insurance companies. As part of the contracts, the insurance companies maintain a portion of the contributions in a fixed account. These accounts are credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by the insurance companies. These accounts are included in the financial statements at fair value because they are non-fully benefit responsive. There are no reserves against fair value for credit risk of the contract issuers or otherwise.

### **(6) Plan tax status**

The Plan has adopted a prototype plan and received an opinion letter from the IRS dated August 7, 2017, stating that the prototype plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Management has not obtained an individual determination letter for the Plan. The prototype plan has been amended since receipt of the opinion letter. Management and the Plan Administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified, and the related trust remains tax-exempt at December 31, 2024. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

**(7) Party in interest transactions**

The Plan investments are managed by TIAA and Lincoln National Life Insurance Company, the insurance companies of the Plan. Therefore, these investment transactions qualify as party-in-interest transactions. Fees paid to these insurance companies for recordkeeping and administrative services totaled \$57,347 for the year ended December 31, 2024.
