Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following brief description of the Schupan & Sons, Inc. Profit Sharing and 401(k) Savings Plan (the Plan) is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan available to qualifying employees of Schupan & Sons, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### ***Eligibility***

Employees are eligible to participate in the Plan immediately upon hire. In order to be eligible for matching contributions, an employee must have completed one year of service, which is equal to 1,000 hours worked during the year. Employees are eligible the first day of the quarter following when the requirement is met.

#### ***Contributions***

Participants may contribute the maximum percentage allowable, to the extent such percentage does not result in their contributions exceeding the annual dollar limits established by law. The Plan includes an auto enrollment feature of 6% of pre-tax compensation. This feature may be waived by the participant. Participants may contribute amounts representing rollover from other qualified plans and make Roth contributions on an after-tax basis. The Plan also allows for catch-up contributions for those aged 50 and over during the Plan year, subject to certain limitations.

The Company may make matching contributions to the Plan as determined by its management. In 2024 and 2023, management elected to match 100% of the first \$1,500 of the participant's contribution and 21% of the remaining contributions.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The Company's contributions become fully vested after three years of service with no vesting in the first two years. Participant accounts become fully vested in the event of death or permanent physical or mental disability.

### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one outstanding note at any given time. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. Loans ranged from 5.25% to 9.50% at December 31, 2024. The notes are repaid ratably through weekly payroll deductions over a period of five years or less unless used to acquire a principal residence, which may be repaid over a reasonable period of time.

### ***Contribution Receivable***

Participant contributions and any related discretionary employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Other discretionary employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Payment of Benefits***

Upon termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. In-service distributions and hardship withdrawals, as defined by the Plan, may be made in accordance with the provisions specified in the Plan.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan, as well as distribution fees, are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were approximately \$130,000 and \$100,000, respectively. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$30,000 and \$235, respectively. Forfeitures may be used first to pay administrative expenses, with the remainder allocated to participants. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$93,000 and \$51,000, respectively, were used to pay administrative expenses. No funds were allocated to participant accounts in either year.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

### *Risks and Uncertainties*

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### *Subsequent Events*

Subsequent events have been evaluated by management through September 12, 2025, the date these financial statements were available to be issued.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

## **3. Fair Value Measurements**

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the

fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets in active markets.

*Level 2* - This level consists of inputs to the valuation methodology that include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

*Level 3* - This level consists of inputs to the valuation methodology that are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

*Money Market Fund* - The money market fund is valued at the net asset value (NAV) of shares held by the Plan at year-end and determined based on the value of the underlying investments of the fund. The money market fund seeks to maintain a \$1.00 NAV.

*Mutual Funds* - Mutual funds are valued at daily closing prices, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Segregated Accounts* - Segregated accounts are underlying investments consisting of mutual funds, money market funds, and common stock; see the valuation methodology for money market and mutual funds above. Common stock is valued at the closing price reported on stock exchanges.

### 4. Information Certified by the Trustee

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivables from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Greenleaf Trust, a qualified institution.

### 5. Segregated Accounts

Participants, as defined by the Plan, may establish segregated accounts in which to invest their contributions. The segregated account balances are comprised of the following investment balances:

### 6. Related Party and Party-in-Interest Transactions

Greenleaf Trust is the trustee, as defined by the Plan, and, therefore, fees paid to Greenleaf Trust qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Plan made direct payments to the trustee of approximately \$133,000 and \$100,000 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations. Notes receivable from participants also qualify as party-in-interest transactions.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### 8. Tax Status

The Company adopted the Greenleaf Trust Non-Standardized Defined Contribution Pre-Approved Plan. Greenleaf Trust obtained an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
