Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the A2MAC1, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Description of Plan

The following description of A2MAC1, LLC 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan, as amended and restated, is a defined contribution plan covering all eligible employees, as defined in the Plan document, of A2MAC1, LLC (the Company and Plan Administrator) who have six months of service and have attained age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's earnings (losses) based on participant account balances. Participants direct the investment of all contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the vested value of the participant's account.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or a percentage of their vested account balance as further defined in the Plan documents. Terms of the loan are based on the terms of the individual promissory note. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through payroll deductions.

Contributions

Participants may elect to make pre-tax and Roth deferrals from compensation as defined in the Plan document. Participants over age 50 may defer catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Plan provides a matching contribution equal to 100% of each participant's deferrals up to 3%.

Each year, the Company may elect to contribute a discretionary profit sharing contribution to those participants who are employed on the last day of the Plan year. The contribution is allocated based upon percentages of total eligible wages. For the years ended December 31, 2024 and 2023, there were no discretionary profit sharing contributions made to the Plan.

Payment of Benefits

The Plan generally provides that upon retirement, death, disability, or termination, participants are entitled to receive the vested value of their account by lump sum, partial, installment, or annuity payment. Upon meeting certain other qualifications, participants may also be eligible for in-service distributions and hardship distributions.

Note 1 – Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. All company contributions and related earnings (losses) vest ratably, becoming fully vested after six years of service.

Forfeitures

Forfeitures may be used to offset plan expenses or to reduce Company contributions. Unused forfeitures are allocated to Plan participants, as further defined in the Plan document. Unallocated forfeitures at December 31, 2024 and 2023 were \$16,663 and \$19,520, respectively.

Partial Termination

During 2024, the Company shut down its U.S. production operations but retained its sales and administrative staff. As a result, the Plan experienced a partial plan termination as defined by ERISA. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan's participants are terminated because of an action taken by a plan sponsor. All participants affected by the shutdown became fully vested in their account balance at the date of the partial plan termination.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA.

Administrative Expenses

Certain expenses are paid by the Plan, as described in the Plan document. The Company paid for other costs of administering the Plan. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There have been no changes in the valuation methods used. The Plan's investments are held by Mid Atlantic Trust Company, the Plan's Trustee.

Investment Valuation and Income Recognition (continued)

Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed-income securities. Shares held in mutual funds are valued at net asset value.

Government money market funds invest 99.5% or more of their total assets in extremely liquid investments such as cash and government securities. The Plan's investment in the money market fund is valued at fair value using the amortized cost method as permitted by Rule 2a-7 under the Investment Company Act of 1940.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and dividends and interest for the year then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

Note 4 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 5 – Income Tax Status

The Internal Revenue Service ruled on August 31, 2020, that the Non-standardized Pre-Approved Profit Sharing Plan with CODA (the prototype plan of Paychex, Inc. upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan has since been amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
