### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Farm Bureau 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Basis for Opinion

### 1. Plan Description

---

The following brief description of the Farm Bureau 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Iowa Farm Bureau Federation and affiliated companies (the Plan Sponsor), including FBL Financial Group, Inc. (FBL) and Farm Bureau Property & Casualty Insurance Company, as well as several unaffiliated organizations; the Arizona Farm Bureau Federation, the New Mexico Farm & Livestock Bureau, the Minnesota Farm Bureau Federation, the South Dakota Farm Bureau Federation, the Utah Farm Bureau Federation, the Kansas Farm Bureau and its affiliated company, and the Nebraska Farm Bureau Federation and its affiliated company (collectively, the Companies).

Employees are eligible to make salary deferral contributions and receive employer matching contributions and employer non-elective contributions the first day after attaining age 21 and completing one month of service. Participants under certain companies must complete one year of service to be eligible for employer matching contributions and one or two years of service to be eligible for employer non-elective contributions. Participants under certain participating companies may also receive discretionary employer non-elective contributions only if they are employed on the last day of the Plan year.

#### **Contributions**

##### Participant

Participants may make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 50% of their eligible annual compensation as defined by the Plan, up to the maximum dollar limits allowable by law. Participants may also rollover balances from other qualified plans into their account. Participants of certain companies are automatically enrolled with an initial 4% (3% prior to January 1, 2024) to 6% salary deferral contribution and their salary deferral contribution will increase by 1% up to 10% on the month following the participant's anniversary date. At any time, a participant may elect not to contribute or may increase or decrease their deferral rate to any rate allowed under Plan provisions. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

##### Employer

The employer matching contributions in the Plan are determined based on the participant's elected salary deferral and ranges from a total of 3% to 6% of eligible compensation. Certain participating companies make non-elective contributions at a range of 2% to 20% of eligible compensation. Certain participating companies make a discretionary non-elective contribution from 2.75% to 5.75% of eligible compensation, depending on the participant's combination of age plus years of service.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions, allocations of Plan earnings or losses and administrative expenses. Participant accounts may also include other deposits and withdrawals, as applicable. The employer matching contributions are credited to participant accounts based upon the participant's elected salary deferral. Employer non-elective and discretionary non-elective contributions are credited based on the participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Delaware Charter Guarantee & Trust Company, conducting business as Principal Trust Company (Principal).

### *Vesting*

Participants are immediately vested in their contributions. Employer matching, non-elective, and discretionary non-elective vesting schedules vary by Company and range from immediately vested to fully vested after six years of service (four years of service effective January 1, 2025).

### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate. The term of the note is limited to five years (ten years if used to purchase a principal residence) and all principal and interest payments must be made through payroll deductions. Effective January 1, 2024, participants may not have more than two notes outstanding at any point in time.

### *Payment of Benefits*

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump-sum, partial payments, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$1,000 and \$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement plan designated by the plan administrator in the event the participant does not elect a payout option. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows for in-service distributions for participants who have reached the age of 59 ½. Participants may also receive hardship distributions, as defined by the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their employer contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$195,135 and \$80,672, respectively. During 2024 and 2023, \$73,180 and \$272,047, respectively, of forfeited amounts were used to reduce employer contributions.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting - Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments, except for fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investments advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in fully benefit-responsive contracts through group annuity contracts (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Expenses***

Administrative and operating expenses of the Plan are paid through an annual per participant charge that is spread out over twelve months.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 31, 2025. See "Vesting" section in Note 1 for a description of a subsequent event.

### **3. Information Certified by Principal and Farm Bureau Life Insurance Company**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, the trustee of the Plan, and Farm Bureau Life Insurance Company (Farm Bureau Life), the custodian of the group annuity contracts, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common Collective Trusts:* Common collective trusts are valued at the Net Asset Value (NAV) based on the market value of its underlying investments. These trusts invest in collective trust funds as well as a variety of pooled separate accounts and mutual funds. The fair value of mutual funds are publicly quoted pricing inputs (level 1). The NAV of the common collective trusts is not publicly quoted but is available to current investors via the Plan's website or when Plan participants access their account values. The NAV is the basis for current transactions and the common collective trusts can be redeemed at NAV as of the measurement date. Therefore, the Company believes that this investment has a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with U.S. GAAP for investment companies. Because it is valued similarly to mutual funds, the Company believes the common collective trusts should be a Level 1 asset to allow for consistent disclosure. Unfunded commitments typically are found in private equity funds and therefore are not applicable to common collective trusts.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account:* The self-directed brokerage account includes investments in publicly traded securities for which holding detail and pricing are publicly available. The securities are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Group Annuity Contracts

---

Group annuity contracts consist of an Asset Builder Group Annuity (the "Asset Builder Annuity") and a Group Flexible Premium Deferred Annuity (the "Flexible Premium Annuity") offered by Farm Bureau Life, a wholly-owned subsidiary of FBL. The group annuity contracts have no set maturity date and are backed by the full faith and credit of Farm Bureau Life. The minimum crediting rate is 3.0% for the Flexible Premium Annuity and 1.0% for the Asset Builder Annuity. Interest crediting rates are reviewed and determined by Farm Bureau Life. The Flexible Premium Annuity is closed to new contributions, including transfers.

As the group annuity contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contracts. Contract value, as reported to the Plan by Farm Bureau Life, represents contributions made under the contract, plus interest credited at a rate determined by the issuer, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Income Tax Status

---

The Plan received a determination letter from the Internal Revenue Service (IRS) dated August 30, 2013, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Subsequent to this determination by the IRS, the Plan was amended and restated, and the IRS ceased issuing determination letters for plan restatements for individually designed plans. In lieu of receiving determination letters from the IRS, the Plan has received opinion letters from legal counsel with each plan restatement stating that the Plan complies in form with ERISA's requirements and satisfied in form the tax qualification requirements of Section 401(a) of the Code. The most recent opinion letter from legal counsel is dated June 2, 2023. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

### 8. Related Party Transactions

---

Certain assets of the Plan are held and managed by Principal and Farm Bureau Life. Principal is the trustee and a custodian of the Plan and Farm Bureau Life is the custodian of the group annuity contracts; therefore, these transactions qualify as party-in interest. These transactions are exempt from the prohibited transactions rules under ERISA.
