INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Cybersoft 401(K) Profit Sharing Plan is sponsored and administered by Cybersoft Technologies, Inc. (“the Company” or “Plan Administrator”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a single-employer, defined contribution plan covering all eligible employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – All employees become eligible to participate in the Plan as of the first day of the month coinciding with or next following date upon the completion of six months of employment with the Company.

Contributions - Eligible employees have the option to contribute pre-tax elective deferrals and/or Roth elective deferral contributions. A participant’s contribution may not exceed the annual limit established by the Internal Revenue Code (“IRC”) at the beginning of such taxable year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as well.

The Company makes matching contributions on behalf of participants at the rate identified in the table in the Vesting section of Note 1 up to the first 3% of each participant’s eligible earnings. Participants are eligible for matching contributions upon completion of 1,000 hours of service in the applicable plan year and be employed by the Company on the last day of the Plan year.

Effective April 2020 the Company suspended the employer matching contribution due to the current economic condition affected the Company’s business, which was reinstated from January 1, 2022.

Participant Accounts – Each participant in the Plan determines the allocation of his or her contributions and related employer match, if applicable, among various investments funds. Each participant may choose to deposit all contributions in one fund or split the investment in any whole percentage as he or she may designate among the investment options.

Rollover contributions – The Plan accepts direct and indirect rollover of eligible rollover distributions from qualified plans and IRAs, irrespective of whether such employee has met the age and service requirements. An eligible employee who has not yet met any of the eligibility requirements of the Plan will be deemed a Participant only with respect to amounts, if any, in his rollover contribution account. During the years ended December 31, 2024 and 2023 ,total rollovers or of \$0 and \$23,872 were contributed in the Plan.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer non-elective profit sharing and matching contributions are vested based on the following:

Forfeitures –The non-vested balance in a participant’s account is forfeited upon termination of service. Forfeitures may be used to pay administrative expenses and to reduce future Company contributions as described in Section 6(d) of Basic Plan Document. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$48 and \$0 respectively. No non-vested forfeitures amount were used to pay the Plan expenses during the year.

Notes Receivable from Participants – Participants may borrow from their fund accounts the lesser of \$50,000 or one half of their vested account balance with a minimum loan requirement of \$1,000. Loan terms have a maximum term of five years, except for loans used to acquire a dwelling unit that, within a reasonable time, will be used as the principal residence. Such loans are secured by the participant’s vested account balance and bear interest at the rate of 8.50% to 9.5%. Loans can be refinanced once each Plan Year. Principal and interest are paid ratably through payroll deductions.

Plan Termination – The Company intends to continue the Plan indefinitely for the benefit of its employees but reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination or partial termination of the Plan, the rights of all affected participants and the amounts allocated to each participant’s account would be fully vested.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Payment of Benefits – Upon separation of service due to death, disability, retirement, or termination of employment, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In case of death, benefits must be distributed to designated beneficiary by December 31 of the calendar year containing the fifth anniversary of the participant death.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company. Loan administration fees are charged directly to the participant’s account and are included in administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”) using the accrual method of accounting, except for benefit payments, which are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan’s gains or losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants is measured at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based on the terms of the Plan document.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of Benefits – Benefits to participants are recorded when paid.

Operating Expenses – All expenses of maintaining the Plan are paid by the Company or adjusted from forfeitures.

Subsequent Events – The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were to be issued.

Recently Issued Accounting Pronouncement – In August 2018, the FASB issued Accounting Standards Update (ASU) No. 2018-13, Fair Value Measurement (Topic 820) Disclosure Framework – Changes to the Disclosure Requirements for Fair Value Measure. ASU 2018-13 eliminates disclosures FASB felt relied too heavily on subjective information that may have been misinterpreted and strengthens remaining disclosures to provide investors with increased transparency for the estimates and assumptions used in valuation. The amendments for fair value measurement disclosures are effective for all entities for fiscal years, and interim periods within those fiscal years, beginning after Dec. 15, 2019.

NOTE 3 – TRUSTEE AND CUSTODIAN

The Company serves as the Plan administrator. The Plan participant records are maintained by PAi Trust Company, Inc. and effective September 15, 2023 PAi Trust Company, Inc. merged with Ascensus Trust Company, who serves as the Plan Trustee. The Plan Trustee is to manage the investments of the Plan and held Plan investment assets.

NOTE 4 – INVESTMENT AND RELATED INVESTMENT INCOME CERTIFIED BY PLAN ASSET CUSTODIAN

Information as of December 31, 2024 and the related investment income for the year then ended has been certified to be complete and accurate by Ascensus Trust, as permitted by 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 – TAX STATUS

The Plan received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the Plan

NOTE 5 – TAX STATUS (continued)

administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value.

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6 – FAIR VALUE MEASUREMENTS (continued)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds and ETFs: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Similar to a mutual fund, an exchange-traded fund contains a basket of investments that can include stocks and bonds. An ETF usually tracks an underlying index such as the S&P 500 but can follow an industry, sector, commodities, or even currency. An exchange-traded fund's price can rise and fall just like other investments. These products trade throughout the day just as a stock would trade.

NOTE 7 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – RELATED PARTY TRANSACTIONS

Certain Plan investments are mutual funds or exchange traded funds (ETF) managed by Ascensus Trust, is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are permissible under the provisions of ERISA.
