Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Mountain Vista Health Park Pension and Savings 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mountain Vista Health Park Pension and Savings 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) Plan Description

The following description of Mountain Vista Health Park ("Company") Pension and Savings 403(b) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all eligible employees of the Company. The eligibility requirements for nonelective contributions are attaining age eighteen and completing one year of service. Once these requirements are satisfied, the plan entry dates are January 1 and July 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

Participants elect to make contributions up to \$23,000 of their eligible compensation, as defined by the Plan. The Company may make a discretionary nonelective contribution to the Plan each year.

(c) Participant Accounts

Each participant's account is credited with the employee's contribution, the employer's contributions, and Plan earnings. Allocation of Plan earnings is based upon actual earnings of the investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions and earnings thereon. Participants are 100% vested in employer's nonelective contributions plus earnings thereon after 3 years of service, attaining age 55, becoming disabled, or at death.

(e) Payment of Benefits

Participants may elect to receive all or a portion of their vested account after they have terminated service, attained age 59 1/2, become disabled, or have sustained an immediate financial hardship as defined by the Plan. Benefits are recorded when paid.

(1) Plan Description, Continued

(f) Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Participants may have two loans outstanding at a time.

(g) Forfeitures

Upon termination of service of a participant, the non-vested portion of the participant's account may be used to reduce future employer contributions or to pay administrative expenses. Non-vested forfeitures used to reduce employer contributions for the years ended December 31, 2024 and 2023, were \$1,713 and \$0, respectively. Unallocated forfeitures at December 31, 2024 and 2023, were \$388 and \$1,675, respectively.

(h) Administrative Expenses

Administrative expenses associated with the Plan are paid by both the Company and the Plan.

(i) Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options, as defined by the Plan. Participants may change their allocation on a daily basis.

(j) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(2) Summary of Significant Accounting Policies, Continued

(b) Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of Plan assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions to and deductions from Plan assets. Actual results could vary from the estimates that were used.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully-benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and trust company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Benefits Payable

There were no benefits payable as of December 31, 2024 and 2023.

(e) Certified Statements

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company ("American United").

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

(4) Investment Contract with Insurance Company

The Plan invests in a fixed account through benefit-responsive group annuity contract with American United Life Insurance Company. This is a single group annuity contract with a fixed rate of interest. The fixed account is backed by the issuing insurance company's general account which invests primarily in bonds, commercial, agricultural and real estate mortgages, real estate and corporate equities.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract value of the American United investment contract at December 31, 2024 and 2023, was \$568,711 and \$610,057, respectively. Contract value, as reported to the Plan by American United, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(5) Tax Status

The Plan adopted a standardized form of a volume submitter plan sponsored by USI Consulting Group. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to the plan's qualified status, dated March 31, 2017. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related Party Transactions

At December 31, 2024 and 2023, plan assets included investments in funds managed by American United. American United is the current custodian of the plan and, as such, transactions with the custodian qualify as party-in-interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative services for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

(8) Nonexempt Transactions

During the years ended December 31, 2024, the Company failed to remit employee contributions to the Plan within the required time period as stated by the United States Department of Labor (DOL). The following table summarizes the late contributions.
