# **Encore Holdings, LLC 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023**

## **1. Description of Plan**

The following description of Encore Holdings, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established January 1, 2010, as restated October 9, 2023. The Plan covers all employees, excluding nonresident aliens and leased employees, who have completed three months of service and are twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

### **Contributions**

Each year, participants may contribute up to up to 90% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The "Company" may elect to make a discretionary matching contribution, which was 50% of the first 6% of eligible compensation. The Company may also make discretionary nonelective contributions based upon a percentage of eligible participant compensation, as determined by the Company. Discretionary non-elective contributions are allocated to eligible participants based upon the ratio of the participant's compensation to total eligible compensation of all eligible participants. During the year ended December 31, 2024, the Company did not make discretionary non-elective contributions to the Plan.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a money market fund as investment options for participants. Plan management determines funds to be included in the Plan's investment portfolio and monitors its investment performance.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary non-elective contributions, of the Plan's earnings and administrative expenses that are paid by the Plan. Allocations are based on participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions, including rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contribution portion of their accounts is based on years of credited service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service. A participant is required to provide 1,000 hours of service during the Plan year to be credited with the year of vesting.

### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Notes must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of primary residence. Participants may have one loan outstanding at any time. The notes are secured by the balances in the participant accounts. The loan interest rates, determined monthly, are set at the reasonable rates as determined by the plan administrator based on prevailing local interest rates, as defined. Principal and interest are paid ratably through monthly payroll deductions. Participant notes are recorded at their unpaid principal balance plus accrued interest.

## **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to termination or attainment of age 59 1/2, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the Plan administrator will direct the trustee to distribute any vested balance over \$1,000 to an individual retirement account established by the Plan administrator. If a terminated participant's vested balance is less than or equal to \$1,000, the Plan Administrator will direct the trustee to distribute the account balance in a lump sum distribution directly to the participant. In addition, the Plan allows for hardship distributions if certain criteria are met.

## **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$113 and \$99,427, respectively. These accounts will be used to reduce future employer matching contributions or to pay plan administrative expenses. During 2024, employer matching contributions were reduced by \$178,667, from forfeited nonvested accounts, in accordance with plan provisions.

## **2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized gains and losses.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant does not make note repayments and the Plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Excess Contributions Payable**

The Plan failed IRC Section 402(g) Annual Deferral Limit test for the years ended December 31, 2024 and 2023. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions payable liabilities with corresponding reductions to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in the following plan years.

### **Payment of Benefits**

Benefits are recorded when paid.

## Administrative Expenses

Certain administrative expenses incurred in operation of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to processing of distributions are charged directly to the participant accounts and are included in administrative expenses. Administrative expenses also include certain investment management fees. Other investment-related expenses are included in net appreciation in fair value of investments and are not readily determinable.

## Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through October 1, 2025, the date when the financial statements were available to be issued. Based on that evaluation, management has determined that the following subsequent events have occurred that require recognition or disclosure in the financial statements.

The Board of Directors of Encore Holdings, LLC, the plan sponsor, has approved resolutions that effective January 1, 2025, the Plan shall permit contributions and loan repayments from the participants in Kistler O'Brien Fire (KOB) 401(k) Plan and Fireline Corporation 401(k) Plan. The companies that sponsored these plans were acquired by Encore Holdings, LLC in October 2023 and in January 2025, respectively. The assets of these plans will be merged into Encore Holdings, LLC 401(k) Plan during 2025.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Money Market Fund:* Valued at the daily closing market prices in the active markets in which securities are traded.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Transfers from Another Plan**

During 2024, the remaining assets of AllState Fire Equipment, Inc. Profit Sharing Plan & Trust were merged into the Plan. The total amount of \$65,545 is reflected as transfer from another plan on the statement of changes in net assets available for benefits.

**5. Information Certified by Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**6. Party-in-Interest Transactions**

**Investments**

Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**8. Tax Status**

The Plan adopted the pre-approved plan offered by FMR LLC. The pre-approved plan received an Internal Revenue Service (IRS) Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. At December 31, 2024 and 2023, five and two investments, respectively, represented a concentration of greater than 10% of the Plan's net assets available for benefits.

**10. Delinquent Participant Contributions**

During the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances of \$3,584 were identified on the Schedule of Delinquent Participant Contributions. The 2023 untimely remittances were corrected in 2024 and the Company has compensated participants for lost earnings resulting from the delay in contributions.
