## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees  
FirstBanc of Alabama, Incorporated 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of FirstBanc of Alabama, Incorporated 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## **1. DESCRIPTION OF PLAN**

The following description of FirstBanc of Alabama, Incorporated 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan was adopted effective January 1, 1987, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established as an employee stock ownership plan with 401(k) provisions. As of July 1, 2018, the Plan was designated as a 401(k) Plan with the ESOP accounts under the Plan frozen at current levels with no further contributions or other credits made other than investment earnings. Individuals who were not a participant on June 30, 2018, are not entitled to share in the ESOP accounts.

### **Plan Administration**

The Plan Administrator and two trustees are appointed by the Board of Directors of FirstBanc of Alabama, Incorporated. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the custodians) are responsible for receiving contributions and income, maintaining custody of Plan assets including the mutual funds and fixed annuity fund, and payment of loans and benefits to participants.

### **Eligibility**

The Plan is a defined contribution plan covering all full-time employees of FirstBanc of Alabama and Subsidiary, (the Company or Plan Sponsor) under the provisions of Section 401(k) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The investments of the Plan are participant directed. Employees become eligible to participate in the Plan upon the attainment of age 18 and completion of 1,000 hours of service during a Plan year.

### **Contributions**

Each year, participants may contribute their total compensation up to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor contributes a safe harbor matching contribution equal to 100% of the matched employee contributions that are not in excess of 3% of the participant's eligible compensation, plus 50% of the amount of the participant's eligible compensation that exceeds 3% but not in excess of 5%. The Plan Sponsor may make additional matching contributions that are not in excess of 10% of the participant's compensation. Effective January 1, 2019, the matching contribution is calculated and deposited on a payroll-by-payroll basis, with a true up feature for an additional contribution calculated on an annual basis over the aggregate of the amounts contributed. Contributions are subject to certain IRS limitations. With respect to the employer's nonelective contribution, only participants who have completed a year of service during the Plan year and are actively employed on the last day of the Plan year are eligible to share in the discretionary contribution for the year.

**Forfeitures**

All amounts forfeited by participants during any Plan year are used to pay safe harbor contributions and any yearly Plan expenses, and are reallocated at the end of the plan year.

**Funding Policy**

The Plan is designed to invest primarily in Company stock for those who were participants prior to June 30, 2018. Other investments are permitted.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contributions, and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Loan periods may not exceed five years unless proceeds are used to purchase a primary dwelling. No more than any one loan may be made to a participant in a 12-month period, and no more than two loans may be outstanding for a participant. Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of time. A distribution of a participant's benefit may be made in cash, Company stock, or both.

**Voting Rights**

The trustees shall vote for all Company stock held by it as part of the Plan assets.

**Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Plan Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Plan Sponsor can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. As noted in the Payment of Benefits section, the Plan Sponsor buys shares at their current value from terminated participants prior to distribution. Therefore, the put option provision is not currently being used.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

The investments are reported at fair value, except for the group annuity contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investment in mutual funds is valued at fair value. These accounts are valued based on published values in active markets.

The common shares of the Company were valued at fair value on December 31, 2024 and 2023. Fair value is determined by an annual independent appraisal. Investment income is allocated based on participant's compensation. Purchases and sales of securities have not occurred since the ESOP was frozen in 2018.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan pays some or all expenses, which primarily include fees for the investment advisor, third-party administrator, and program and administrative fees for recordkeeping services.

**Subsequent Events**

Management has evaluated subsequent events and their potential effects on these financial statements through September 18, 2025, the report issuance date.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Observable inputs such as quoted prices in active markets;

Level 2 – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and

Level 3 – Unobservable inputs, in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value and contract value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Values are reported at fair value of identical assets traded on an active market. Values are share prices of mutual funds that are received, reviewed and recorded by the recordkeeper.

*Common stock:* The fair value of the Company stock is determined annually by an independent appraisal. The stated value meets the requirements as expressed in Section 3(18)(B) of ERISA for adequate consideration, which is the fair value of the asset as determined in good faith by the trustees or named fiduciary pursuant to the terms of the Plan and in accordance with regulations promulgated by the Secretary of Labor. The Plan requires the Company to have a valuation performed on a yearly basis and is subject to change from year to year.

Total investment assets at fair value, classified within Level 3, were \$4,860,408 as of December 31, 2024, which consisted of FirstBanc of Alabama, Inc. common stock. Such amounts were 47% of total investment assets on the statement of net assets available for benefits at fair value as of December 31, 2024.

Total investment assets at fair value, classified within Level 3, were \$4,628,960 as of December 31, 2023, which consisted of FirstBanc of Alabama, Inc. common stock. Such amounts were 50% of total investment assets on the statement of net assets available for benefits at fair value as of December 31, 2023.

## **5. TAX STATUS**

The Plan has received a determination letter from the IRS dated April 14, 2015, stating that the Plan is qualified under the IRS, and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRS; therefore, the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be substantiated upon examination by the IRS. The Plan has determined that it does not have any positions at December 31, 2024 and 2023, that it would be unable to substantiate.

## **6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and a guaranteed interest contract managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such employees receive compensation from the Plan. Administrative expenses are paid directly by the Plan unless paid by the Company.

**8. UNCERTAINTIES**

The Plan invests in various investment securities and common stock of the Plan Sponsor. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. GUARANTEED INVESTMENT CONTRACT**

The Plan entered into a fully benefit-responsive group annuity contract (FBRIC) with Empower Annuity Insurance Company (Empower Annuity) formerly, Great-West Life & Annuity Insurance Company. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed quarterly for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria, and is, therefore, reported at contract value. Contract value is the relevant measurement for FBRIC's because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial

Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.
