Opinion

FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

Note A - Plan Description

The following brief description of the Alatrade Foods Holdings, Inc. (the Company) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General. Alatrade Foods Holdings Inc. established the Plan as of January 1, 2020 to be an employee stock ownership plan covering eligible employees of the Company and its affiliates. Employees are eligible to participate in the Plan once they have completed six months of service with at least one hour of service in each month. Participants enter the Plan on the January 1 or July 1 following satisfaction of requirements. Vesting is 100% after three years of service with the vesting computation period beginning January 1, 2020. Contributions from the Employer are deposited with the Custodian in such amounts in cash as are necessary for the Plan to make its regularly scheduled principal and interest payments on its stock purchase loans. The amount of the contribution complies with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees do not contribute to the Plan. The Plan is subject to the provisions of ERISA.

The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code.

On June 28, 2021, the Plan purchased 1,000,000 shares of the Company’s common stock with a loan of \$148,954,369 and cash of \$10,345,000. The stock was purchased at a price of \$159.30 per share. The common stock is held in a trust established under the Plan.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- a. the accounts of employees with rights to allocated common stock (allocated), and
- b. common stock not yet allocated to employees (unallocated).

Participant’s Accounts. The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of the Plan year with an allocation of shares of the Company’s common stock released by the Trustee from the unallocated account. Allocations are based on a participant’s eligible compensation relative to total eligible compensation. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance.

Note A - Plan Description - Continued

Payment of Benefits. Distributions on account of death, disability or retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service commence in the fifth plan year following the separation from service and may be made in five annual installments. The amount to be distributed is based on the immediately preceding valuation date. Distributions are made in cash or, if the participant elects, in the form of Company common stock.

Voting Rights. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is required to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Vesting. If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on the total years of service with the Company. Participants vest 100-percent after 3 years of service.

Put Option. Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that participants have the ability to ultimately obtain cash for their shares.

Diversification. Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution, unless eligible for floor price protection, in which case, shares are distributed. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeitures. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. No forfeitures were available to be allocated at December 31, 2024 and 2023.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note B - Summary of Significant Accounting Policies - Continued

Date of Management's Review

Management evaluated subsequent events through June 13, 2025, the date of the auditors' report, which is the date the financial statements were available to be issued and concluded no events or transactions occurred during that period requiring recognition or disclosure in the financial statements.

Financial Statement Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and the changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains or losses on investments bought and sold as well as held during the year.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated). Shares are released from collateral and become allocated in the period in which debt service is paid.

Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Note B - Summary of Significant Accounting Policies - Continued

Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in the net assets available for plan benefits.

Note D - Fair Value Measurements

FASB ASC Section 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices

Note D - Fair Value Measurements - Continued

that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Common Stock - Valued by an independent appraiser. The appraisal was based on a combination of the market and income valuation techniques. Unobservable inputs include EBITDA, Net Income, Weighted average cost of capital, Discount Rate, Discount for lack of marketability, Public comparables, Revenue multiples and EBITDA multiples.

Money Market Funds - Valued at the daily closing price as reported by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Company contributes such amounts as are necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its stock purchase loan and to pay benefits to Plan participants. The Company contributed \$6,499,133 for 2024 and \$6,388,836 for 2023.

Note F - Tax Status

The Plan adopted an individually designed plan document as of January 1, 2020. A determination letter has not been received as of the date of these financial statements as to IRS approval of the Plan. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Company believes the Plan is currently designed and operated in compliance with the document and the applicable requirements of the Code and, therefore, the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023 there were no uncertain positions that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS audits in progress. Net assets available for benefits reported on these financial statements agree to net assets reported on Form 5500, Annual Return/Report of Employee Benefit Plan, for 2024 and 2023.

Note G - Related Party and Party in Interest Transactions

The Plan invests in Company common stock and has indebtedness to the Company. These are related party and party-in-interest transactions. As described in Note A, the Company pays substantially all plan expenses. The Plan has several service providers. Such providers are parties in interest under ERISA.

Note H – Loan Payable

In 2021, the Plan entered into a \$148,954,369 loan agreement with the Company. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of current year payments divided by the total of current year and all future years’ principal and interest payments. This resulted in 29,997 shares being released and allocated for each of the years ended December 31, 2024 and 2023.

This agreement provides for the loan to be repaid over 30 years with an interest rate of 2.08%. The scheduled amortization of the loan for the next five years is as follows:

Note I – Company Dividends

No dividends were paid in 2024 or 2023.

Note J – Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Trustee would pay all liabilities and expenses of the ESOP and sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.
