### Note 1 - Description of the Plan

The accompanying financial statements are for the Marathon Petroleum Short Term Disability Plan for Specified Employees (the “Plan” or the “STD Plan”), which is a short-term disability plan sponsored by Marathon Petroleum Company LP (the “Company”). The Plan’s assets are held in the Marathon Petroleum Short Term Disability Welfare Benefit Trust (the “Master Trust”) with Frost National Bank (“Frost” or the “Trustee”) acting as the trustee.

The following description of the Plan provides only general information. Participants should refer to the applicable formal plan documents for more complete information. The Plan is subject to, and complies with, the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is a welfare benefit plan available to certain regular full-time employees of the Company and its participating affiliates in the states of California and Washington. For those employees in California and Washington, the Plan is available immediately upon hire. The purpose of the Plan is to provide short-term disability pay to eligible employees suffering a short-term illness or injury and who are unable to work for a period of time. The Plan is solely funded by employer contributions that are determined annually by the plan administrator based upon claim payments.

Eligible participants are entitled to coverage based on appropriate weeks of base salary as determined by the number of years of service and whether the injury is occupational versus non-occupational. Benefits are paid by the Company to the participant through the Company’s payroll and reimbursed by the Trustee. Payments of benefits under the Plan are reduced by any benefits a participant may be entitled to under any applicable workers’ compensation law and/or other federal or state disability income payment.

#### Plan Termination

In the event of termination of the Plan, the Trustee, in accordance with the Master Trust agreement, will apply all the remaining assets of the Master Trust in a uniform and nondiscriminatory manner toward the provision of benefits for the participants.

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments in the Master Trust consist of a short-term investment fund that invests in cash and government securities which are valued using a market approach and are considered level 1 assets. The Plan’s interests in the Master Trust are based on allocated contributions and interest income less actual distributions and allocated expenses. During the year ended December 31, 2024, the Master Trust’s investments (including investments bought, sold and held during the period) did not experience any material gains or losses, since all investments were held in a short-term investment fund, which allow for daily deposits and withdrawals. Interest income is recorded as earned. All investment information and investment income disclosed in the accompanying financial statements was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Frost as permitted by 29 CFR 2520.103-8 of the Department of Labor rules under ERISA. Refer to Note 3 for further discussion on the Master Trust’s investment in the short-term investment fund.

#### Benefit Payments

Benefit payments to participants are recorded upon distribution.

## Notes to the Financial Statements

### Administrative Expenses

The Plan's agreement allows for the payment of administrative expenses by either the Plan or the Company. During the year ended December 31, 2024, all administrative and professional expenses, except trustee fees, were paid by the Company.

### Subsequent Events

We have evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. There are no significant subsequent events requiring disclosure.

### Note 3 - Marathon Petroleum Short Term Disability Welfare Benefit Trust

The Plan has an undivided interest in the Master Trust. The Plan's percentage interest in the Master Trust at December 31, 2024 and 2023 is 100%. Investments and other assets and liabilities of the Master Trust are as follows:

Claims that have been processed and approved for payment by the Plan at year-end and claims incurred but not reported are recorded as benefit obligations, but are not considered liabilities. Therefore, these claims are not presented as liabilities or claims paid in the accompanying financial statements, but are recorded on the Form 5500 as benefit claims payable.

### Note 6 - Related-Party & Party-in-Interest Transactions

All Master Trust investments are invested in a short-term investment fund managed by Invesco. Therefore, these transactions do not qualify as party-in-interest transactions.

All expenses, except for certain trustee fees, were paid by the Company, and personnel and facilities of the Company have been used by the Plan at no charge for the year ended December 31, 2024.

### Note 7 - Risks and Uncertainties

The Master Trust invests in investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### Note 8 - Tax Status

The Master Trust funding the Plan has not received an exemption letter from the IRS stating that the Master Trust is tax-exempt under Section 501(a) of the Internal Revenue Code (the "Code") as a Voluntary Employees' Beneficiary Association; therefore, the Master Trust is a taxable trust. As an employee welfare benefit plan and related taxable trust, the Plan and the Master Trust are required to operate in conformity with the Code and ERISA. The plan administrator believes the Plan and the Master Trust are operating in conformity with the Code and ERISA.

Management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
