Notes to Financial Statements

December 31, 2024

1. Plan Description

The following description of Jeffrey Chain, L.P. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored covering substantially all full-time employees of Jeffrey Chain, L.P. (the “Plan Sponsor”) who have completed one month of qualifying service and are 18 years of age or older. Eligible employees may enter the Plan on the first day of each month after meeting eligibility requirements. Effective September 1, 2024, the Plan was amended to add Renold AquicCo, Inc. as a participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Contributions

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

Prior to September 1, 2024, the Plan Sponsor was required to make matching contributions equal to 50% of the first 6% of compensation participants contributes to the Plan. Effective September 1, 2024, the Plan was amended to change the Plan Sponsor matching contributions to be discretionary based on the Plan Sponsor’s election for each participating employer. The Plan Sponsor elected to continue making matching contributions equal to 50% of the first 6% of compensation participants of Jeffrey Chain, L.P. contribute to the Plan for the remainder of 2024. The Plan Sponsor elected to make matching contributions equal to 100% of the first 4% of compensation participants of Renold AcquicCo, Inc. contribute to the Plan for the remainder of 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation, increasing each August 1 by 1% up to maximum deferral rate of 10%.

Receivables, if any, from the Plan Sponsor for contributions are unsecured.

1. Plan Description (continued)

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions, whether participant contributions or Plan Sponsor contributions, plus the related earnings on these contributions.

Notes Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over an increased reasonable period of time as determined at the time the loan was made. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are invested in funds offered by Principal Trust Company (Principal), which are reported at fair value, under a group annuity contract in either Principal's stable value fund account or various pooled separate accounts. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are netted in net realized and unrealized appreciation in the fair value of investments.

Excess Contributions Payable

Amounts payable to participants totaling \$11,203 and \$5,240 as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS, are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Subsequent Events

Plan management has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Principal Life Insurance Company that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income from stable value fund, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

The Plan had one investment, the Principal Lifetime 2030 Fund, representing 29% and 33% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts: Valued daily using the net asset value (NAV) as a practical expedient to estimate fair value. The NAV is generally based on units of the underlying investments held by the pooled separate account less its liabilities, as provided by Principal.

Stable value fund: Valued daily using the NAV of units of the stable value fund. The NAV, as provided by the fund's trustee, Principal Global Investors Trust Company, is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2024, contributions totaling \$7,086 were not remitted within the required time period. As of September 22, 2025, the Plan Sponsor is in the process of correcting these delinquent contributions, including remitting the associated lost earnings to the Plan.
