For information included in the supplemental schedule that agreed to or is derived from the certified investment information, I compared such information to the related certified investment information.

## NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. PLAN DESCRIPTION

The following description of the Sears Contract, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a single employer defined contribution plan covering substantially all full and part-time employees of Sears Contract, Inc. (the "Company"). All employees of the Company are eligible to participate in the Plan upon reaching 20 years of age and completion of one year of continuous service of at least 1,000 hours. Upon meeting the eligibility requirements, employees may enroll in the Plan on the first day of the Plan year or the first day of the seventh month. The Plan was amended and restated as of January 1, 2015. The Plan was amended effective January 1, 2019 to allow Roth deferrals.

The Plan was amended and restated in accordance with Cycle 3 Restatement effective January 1, 2022, in order to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 and other legal requirements.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investments offerings and monitors investment performance.

Contributions – Participants may voluntarily contribute a portion of their pretax base compensation, as defined by the Plan, not to exceed \$23,000 and \$22,500 in 2024 and 2023 respectively, subject to certain discrimination tests prescribed by the Internal Revenue Code ("IRC"). Participants may also contribute after tax (Roth) contributions. Participants age 50 and over may elect to defer additional amounts ("catch-up contributions") to the Plan. The Plan allows safe harbor matching contributions equal to 100% of the first 3% of salary deferrals and 50% of the next 2% of salary deferrals. Safe harbor matching contributions for the years ended December 31, 2024 and 2023 totaled \$299,621 and \$291,661, respectively. The Company may provide a discretionary matching contribution for participants that have completed one hour of service during the Plan year and is employed on the last day of the Plan year. The Company made a discretionary matching contributions for the years ended December 31, 2024 and 2023 equal to \$99,997 and \$0, respectively. The Company may decide to make additional profit-sharing contributions to the Plan, although the Company is not required to do so. There were no profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023. Contributions

are subject to certain Internal Revenue Service (“IRS”) limitations. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts – Each participant's account is credited with the participant's contributions and company matching contributions, as well as allocations of the Company's profit-sharing contribution, if any, and Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments – Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. With the safe harbor election, participants are 100% vested in the Company's matching contributions. The portion of the participant's account related to Company discretionary matching contributions and profit-sharing contributions prior to the safe harbor election vest based on years of continuous service. Participants vest on a graduated basis starting at 20% after completing two years of service and 100% upon completion of six years of service.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various forms of annuities, as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The normal retirement age is 65 or later as elected by the participant upon reaching the normal retirement age. A participant is eligible for early retirement upon reaching age 55 with six years of service. In-service distributions are allowed after reaching age 59 ½ or in the event of disability or financial hardship contingent upon satisfying certain conditions in the Plan document.

Forfeitures - Benefit payments to terminated employees partially vested in the Plan include their vested portion of employer contributions. Forfeitures may be used to reduce future employer non-elective contributions to the Plan and pay Plan expenses. For the years ended December 31, 2024 and 2023, forfeitures used were \$0 and the forfeited non-vested account balance as of December 31, 2024 and 2023 was \$0.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Contributions - Contributions from participants are recorded as they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant contributions are due.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Administrative Expenses - Administrative expenses of the Plan are paid by the Plan or by the Company, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. INVESTMENTS (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends, for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan).

### 4. FAIR VALUE MEASUREMENTS

Fair Value Measurements in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023:

Money Market: Valued at net asset value of short-term securities held in the fund, which is generally \$1 per share.

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as exempt party-in-interest transactions.

## 6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

## 7. FEDERAL INCOME TAX STATUS

The Plan is structured and follows a prototype non-standardized profit-sharing plan that has obtained from the IRS an opinion letter dated June 30, 2020, specifying that the form of the adoption agreement and the basic plan document satisfy, as of the date of the opinion letter, code Section 401. The Plan has been amended since receiving the opinion letter; however, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 9. QUALIFIED NON-ELECTIVE CONTRIBUTION

During 2023, the Company identified some missed deferrals. The Company also calculated the missed employer match and made the necessary corrections through a qualified non-elective contribution equal to \$55,422.

## 10. SUBSEQUENT EVENTS

For the year-ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 18, 2025 the date of financial statement issuance.
