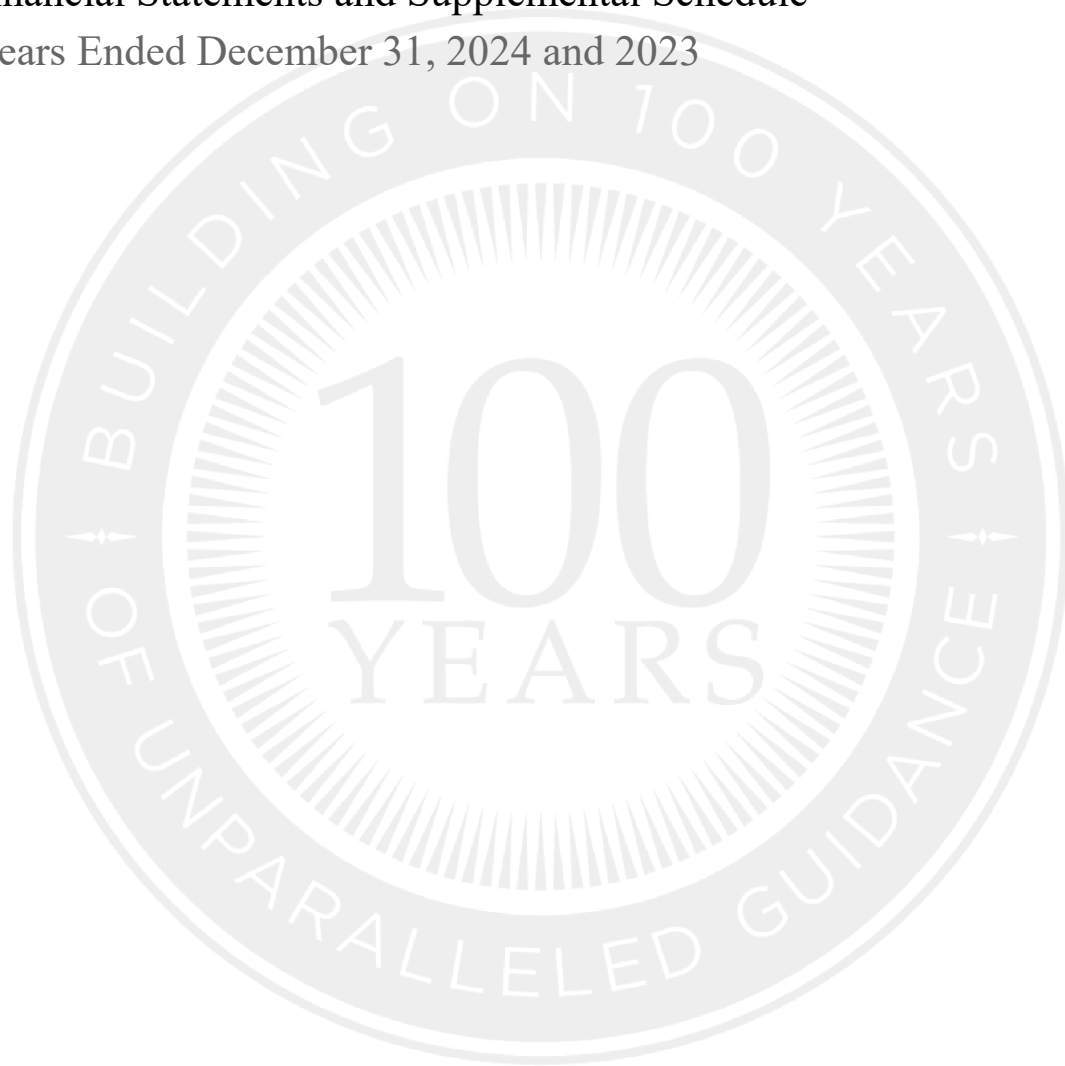

Independent Auditor's Report

To the Plan Administrator of the Fairfield County Bank Incentive Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements Fairfield County Bank Incentive Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

Notes to Financial Statements

Years Ended December 31, 2024 and 2023

1. PLAN DESCRIPTION

The following description of the Fairfield County Bank Incentive Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a voluntary, participant-directed defined contribution plan sponsored by Fairfield County Bank (the “Bank”) and includes the employees of the Bank and Fairfield County Bank Insurance Services, Inc. (“FCBIS”), a subsidiary of the Bank. Effective December 1, 2024, the Bank sold FCBIS. Effective December 2, 2024, participants who were employees of FCBIS and terminated as a result of the sale became 100% vested in their account balance. In general, all employees of the Bank and FCBIS who have completed one month of service are eligible for participation in the Plan. Eligible employees are automatically enrolled into the Plan as soon as administratively feasible after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On April 1, 2022, Empower Annuity Insurance Company of America (“EAICA”), formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (“Empower”) acquired the full-service retirement business of Prudential Financial, Inc. In connection with the transaction, Prudential Retirement Insurance and Annuity Company (“Prudential”) and Prudential Bank & Trust, FSB were acquired by Empower. On October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed Empower Annuity Insurance Company. Effective March 31, 2023, Prudential Bank & Trust, FSB merged into Empower Trust Company, LLC, an Empower affiliate, and all services performed by Prudential Bank & Trust, FSB will be assumed by Empower Trust Company, LLC.

Under the terms of a trust agreement, Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, the “Trustees”), a division of Empower has been empowered to perform such trust and administrative services as may be necessary to carry out the purposes of the Plan. However, the Plan Trustees do not have any discretionary authority concerning the investment of the trust fund or the payment of distributions to participants. The Trustees manage funds on behalf of the Plan. The Trustees of the Plan holds the Plan’s investment assets and executes transactions relating to such assets. The investments were reported to the Plan by the Trustees as having been determined through the use of fair values for all assets with the exception of the guaranteed income fund reported at contract value.

Participant Contributions

Participants may elect to contribute any whole percentage of their pre-tax earnings (as defined), or Roth after-tax contributions, up to the maximum amount allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Employer Contributions

The Bank makes matching contributions to plan participants equal to 50% of a participant's contributions up to and including 6% of the participant's compensation as defined in the Plan. The Participant contributions and the Bank's matching contributions are based on participant's eligible compensation, as defined in Plan documents.

At its discretion, the Bank may also make an additional nonelective contribution to the Plan that is not based on participant contributions. Participants must meet the eligibility requirements to participate in the Plan, as previously described, and be employed on the last day of the Plan year to receive nonelective contributions. Employees of FCBIS are not eligible to receive employer nonelective contributions. The additional discretionary contributions are allocated to individual participants based on a percentage of the participant's compensation earned while a participant during the Plan year, plus the same percentage of any compensation in excess of the "wage base" for the Plan year. The wage base is the amount of compensation for which social security benefits would be provided to participants under the Social Security Act for the applicable Plan year.

The Bank's matching and discretionary contributions are allocated to the investment funds in the same proportion elected by the participant with respect to his or her own contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures attributable to both participant matching contributions and discretionary contributions are used to offset future employer contributions or pay plan expenses. In 2024 and 2023, forfeitures of \$15,398 and \$23,174, respectively, were used to offset employer contributions and plan expenses. As of December 31, 2024 and 2023, forfeitures available to offset employer contributions totaled \$41,509 and \$7,956, respectively.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balances, with a maximum note amount of \$50,000. Participants may have three notes outstanding at any time, subject to a minimum note amount of \$1,000. Notes generally have a five-year term, but may be prepaid in full at any time. The note receivable interest rate is fixed upon origination and equals the prime rate as listed in the Wall Street Journal on the first day of the quarter plus 1%. The range of interest rates on the notes receivable from participants outstanding at December 31, 2024 was 4.25% to 9.50%.

Principal and interest is paid ratably through periodic payroll deductions or directly by the participant to the Trustees. The loans are secured by the balance in the participant's accounts.

Distributions

Contributions may not be withdrawn from the Plan prior to the termination of the participant's employment with the Bank. The Plan provides for in-service distributions at age 59½ and distributions upon termination, retirement, total disability or death, subject to specified conditions. The form of payment for participants is a single lump sum or installments for required minimum distributions.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants begin to vest in the Bank's matching and additional nonelective contributions after they have completed two years of service, with ratable vesting each year thereafter and full vesting after 5 years of service. Participants will be 100% vested in matching and additional nonelective contributions if employment on or after normal retirement age or if employment is terminated on account of death or disability.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan is administered by an officer of the Bank, appointed by the Bank's Board of Directors.

Investment Valuation and Income Recognition

Investments are reported at fair value, (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by its Trustees and investment advisors. See Note 7 for a discussion of fair value measurements.

The Plan's investment in the Guaranteed Income Fund issued by Empower Annuity Insurance Company, which is a fully-benefit responsive investment contract, is reported at contract value based on information reported by the Trustee.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Bank are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Bank and are excluded from these financial statements. Loan origination and annual loan maintenance fees were charged to the individual participant. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, qualified institutions.

The Trustees also certified the information included in the Schedule of Assets (Held at End of Year).

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions, all participants would become fully vested in their accounts and benefits would be payable under the terms of the Plan.

5. TAX STATUS

The Plan has received a favorable tax determination letter from the Internal Revenue Service dated September 16, 2022, indicating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”) and was therefore exempt from federal income taxes. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to December 31, 2021.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value (“NAV”) of units held by the Plan at year end. The pooled separate accounts are priced daily, and participants transact at that price. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. GUARANTEED INCOME FUND

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company. Empower maintains the contributions in a general account.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a semiannually basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Prudential Guaranteed Income Fund is considered to be a fully benefit-responsive investment contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The concept of fair value does not apply to this insurance company issued general account backed product even upon a discontinuance of the contract as participants would receive the contract price. Additionally, there are no specific securities in the general account that back the liabilities of the annuity contract so there is no look-through to the underlying assets to determine fair value. The Plan owns a promise to pay interest at crediting rates, which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. The contract value represents contributions plus interest, less participant withdrawals. Interest is credited using a single portfolio rate approach, which is applied to all contributions made regardless of the timing of those contributions.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

9. RELATED PARTY TRANSACTIONS

Empower Trust Company, LLC is the Trustee of the Plan and Empower Retirement, LLC is the record keeper for the Plan. The annuity contract was issued to the Plan by Empower Annuity Insurance Company. Therefore, transactions with these entities qualify as party-in-interest transactions. Fees paid to these entities amounted to \$39,443 and \$40,663 for 2024 and 2023, respectively. Investment-related fees reduce the investment return of the investments and are included in the net appreciation of investments. Notes receivable from participants also qualify as party-in-interest transactions.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued. The Plan changed its trustee from Empower Trust Company, LLC to State Street Bank & Trust Company, and its record keeper from Empower Retirement, LLC to Transamerica Retirement Solutions, LLC effective October 1, 2025.
