Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DS Containers, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters—Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following description of DS Containers, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan, as most recently restated January 1, 2022, is a contributory, defined contribution plan maintained for the benefit of all eligible employees of DS Containers, Inc. (the Sponsor). The Sponsor is the Plan Administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

John Hancock Life Insurance Company (U.S.A.) (John Hancock) is the custodian and recordkeeper of the Plan.

Eligibility: Employees become eligible to participate in participant-directed contributions to the Plan and receive discretionary Sponsor matching contributions, if any, upon reaching 21 years of age and after completing one month of service. For purposes of being eligible to make participant-directed contributions, the Plan provides for quarterly entry dates on January 1, April 1, July 1 and October 1 after meeting eligibility requirements. These employees are also eligible to receive discretionary Sponsor non-matching contributions, if any, upon reaching 21 years of age, completing 1,000 hours of service and being employed by the Sponsor on the last day of the year.

The Plan's investments are 100% participant directed.

Contributions: Contributions from Plan participants and the matching contributions from the Sponsor are recorded in the year in which the employee contributions are withheld from compensation. The Plan provides for the following contributions, which are to be maintained in separate accounts and subject to certain limitations:

Participant-directed contributions: Each year, participants may contribute to the Plan pretax eligible compensation, as defined in the Plan, up to the maximum amount allowed by the Internal Revenue Code (IRC), limited to \$23,000 in 2024. Participants may also make Roth, after-tax contributions. Participants who are age 50 and older are additionally able to make maximum catch-up contributions of \$7,500 in 2024.

Discretionary Sponsor matching contributions: The Sponsor may, at its discretion, contribute an amount equal to a percentage of each participant's eligible salary deferral contributions (excluding Roth deferrals). The discretionary Sponsor matching contributions for 2024 were allocated on the basis of 75% of each participant's eligible elective deferrals not to exceed 6% of eligible compensation (as defined in the Plan).

Discretionary Sponsor non-matching contributions: The Sponsor may also, at its discretion, contribute non-matching contributions to participants. The amount to be contributed by the Sponsor is at the discretion of the Sponsor. No discretionary Sponsor non-matching contributions were made for 2024.

Participant-rollover contributions: The Plan provides for rollover contributions to be made by the participant from amounts distributed or transferred from another qualified deferred compensation plan.

Note 1. Plan Description (Continued)

Participants' accounts: Each participant's account is credited with participant-directed; discretionary Sponsor matching, if any; discretionary Sponsor non-matching, if any; and participant's rollover contributions, and plan earnings (losses). Allocations are based on the participant's earnings (losses) or account balances, as defined. Allocation of administrative expenses of the Plan is based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Participants' contributions are credited to their respective accounts, as directed, as soon as practicable, after receipt. Investment income is allocated daily.

Vesting: Participants are immediately vested in their participant-directed and participant-rollover contribution accounts and earnings thereon. Eligible participants receive discretionary Sponsor matching and discretionary Sponsor non-matching contributions and vest 25% after one year of service and an additional 25% is vested each year thereafter until the participant is full vested after four years of credited service. In the event of death or disability, participants become fully vested.

Forfeitures: Participants are automatically fully vested upon normal retirement, death or permanent disability. In the event of termination of employment before full vesting, the non-vested portion is determined as of the earlier of the last day of the plan year in which the Plan Administrator distributes the participant's entire vested interest or the last day of the plan year of the fifth consecutive break in service. The amount of the participant's accounts forfeited will be reinstated providing the participant resumes employment prior to incurring a break in service (as defined). Amounts forfeited during the year are first used to restore any prior forfeiture in the event of a former participant's return to employment, and any amounts remaining are used to pay administrative expenses of the Plan or used to reduce future contributions by the Sponsor. At December 31, 2024 and 2023, forfeited amounts approximated \$6,000 and \$17,000, respectively. During the year ended December 31, 2024, non-vested forfeited accounts approximated \$6,000, and approximately \$17,000 of forfeitures were used to pay administrative expenses.

Participant investment options: Upon enrollment in the Plan, a participant may direct the account balance to be invested in selected pooled separate accounts as made available and determined by the Plan's Trustee. Participants are allowed to change their investment options on a daily basis.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the vested account balance or \$50,000, reduced by the participant's highest outstanding loan balance in the previous 12 months even if all or a portion of this amount has been repaid. A participant may have no more than two loans outstanding at any given time. All loans are secured by the vested balance in the participant's accounts and bear interest at a reasonable fixed rate of interest as determined by the Plan Administrator, based on the prevailing interest rates at the time the loan was funded. Principal and interest are paid periodically through biweekly payroll deductions.

Payment of benefits: Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability or termination of employment. Benefits are payable in a lump sum or by other methods as described in the Plan's literature. In-service withdrawals are allowed by the Plan upon attainment of age 59½ from all of the participant's accounts, by determination that a financial hardship, as defined, has been incurred from the participant's deferral accounts and at any time from the participant's rollover account.

At December 31, 2024, there were no amounts owed to former participants whose employment had been terminated and who requested payouts of their account balances.

Note 1. Plan Description (Continued)

Administrative costs: The majority of administrative costs of the Plan are paid for by the Plan with the remainder paid by the Sponsor.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Income recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Valuation of notes receivable from participants: Notes receivable from participants are measured at their unpaid principal plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of benefits: Benefit payments to participants are recorded when paid.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent events: The Sponsor has evaluated subsequent events for potential recognition and/or disclosure through August 7, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 3. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of pooled separate accounts: Valued at the net asset value (NAV) of shares held by the pooled separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV for the pooled separate account is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain fair value instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that are measured at NAV per share (or its equivalent) are not classified in the fair value hierarchy. The Plan's investment in shares of pooled separate accounts is measured at NAV and, accordingly, such amounts, \$26,485,218 and \$21,267,381 at December 31, 2024 and 2023, respectively, are not included in the fair value hierarchy.

A redemption period is the period when the Plan changes or removes funds in the Plan and the Sponsor sends a notice to the participants which includes the date the fund will be removed, the date the new fund will be available and the date at which the money will be moved from the old account fund to the new account fund.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan's Trustee evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 4. Information Certified and Provided by John Hancock, the Custodian

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information certified and provided to the Plan Administrator by the custodian related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets and income:

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Sponsor may determine.

Note 7. Income Tax Status

Effective January 1, 2022, the Plan has adopted a nonstandardized pre-approved plan of Administrative Retirement Services, Inc. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is currently operating in compliance with applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Related-Party Transactions

Certain Plan investments are managed by John Hancock and, therefore, these transactions qualify as party-in-interest. Furthermore, John Hancock provides Plan administrative services to the Plan.

Certain investment advisory and administrative expenses are paid by the Plan. Total investment advisory expenses paid to Herbst Financial Advisors, Inc. by the Plan for the year ended December 31, 2024, were \$30,000. Total administrative expenses paid to John Hancock and Administrative Retirement Services, Inc. by the Plan for the year ended December 31, 2024, were \$57,579 and \$7,500, respectively. In addition, certain administrative functions are performed by the Plan's Trustee or employees of the Sponsor for which no compensation is received from the Plan.

Certain other administrative expenses are paid by the Sponsor on behalf of the Plan. These amounts are not material to the financial statements and are not included in these financial statements.

Note 9. Risks and Uncertainties

The Plan provides options for investment in various securities. These investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits at December 31, 2024.
