1. **Description of Plan**

The following description of the RaceTrac, Inc. 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Organization – RaceTrac, Inc. (“Employer”) adopted and established a profit-sharing plan and trust effective January 1, 1981. Energy Dispatch, LLC, and Metroplex Energy, Inc., related companies, are Affiliated Sponsors of the Plan.

Effective January 1, 2002, 2006, 2009, 2014, and 2022, the Plan was amended and restated to maintain qualification under Sections 401(a) and 401(k) of the Internal Revenue Code of 1986. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility of Participants – All employees of RaceTrac, Inc. and the Affiliated Sponsors with thirty days of service are permitted to enter the Plan on the first day of the month on or next following the date that eligibility is met.

Employers' Contributions - Participating employers make safe harbor contributions that match participant contributions. Employer matching contributions are dollar for dollar up to 3% of a participant's compensation contributed and \$.50 for each dollar of a participant's compensation contributed in excess of 3% but not in excess of 5%. Employer contributions for 2024 and 2023 were matching contributions for the benefit of employees making elective contributions to the Plan.

Participants' Accounts - Individual accounts are maintained for each of the Plan's participants which reflect the participant's share of the Plan's income, expenses, and employers' and employees' contributions. Participant account balances, arising from both employer and employee contributions under the Internal Revenue Service Code Section 401(k) feature, are credited with income, expenses, gains and losses occurring in the investments, which participants select, from the date the contributions enter the accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits from Employer Contributions on Death, Retirement or Disability - Participants become eligible for benefits on their early, normal or deferred retirement dates, death or the Plan Committee's determination of disability, and payment shall occur not later than 90 days after receipt from the participant of the required distribution election form. Benefits are payable in cash or in kind, as determined by the Plan Committee in its sole discretion. The method of distribution of a participant's account is generally in a single lump sum. Participants are eligible for early retirement at age 55 with 15 years of credited service. The normal retirement date is age 65 or the fifth anniversary of participation in the Plan, whichever is later.

1. **Description of Plan – (Continued)**

Plan Termination – Although the Employers intend for the Plan to be permanent, the Employers have the right to terminate the Plan at any time subject to the provisions of ERISA. Should the Plan be terminated, each Participant’s account will be fully vested and nonforfeitable.

Employee Contributions – The Plan has an Internal Revenue Service Code Section 401(k) feature which permits participants to make elective compensation reduction contributions or after-tax Roth 401(k) contributions to the Plan ranging from 1% to 100% of compensation. Participants age 50 or older may make catch-up contributions as a percentage of compensation or as a dollar limit. In addition, employee participants may defer up to 100% of their bonus paid pursuant to the Annual Incentive Compensation bonus arrangement. Participants may increase or decrease the percentage of compensation contributed to the Plan at any time. Rollover contributions from qualified plans may be accepted into the Plan at the discretion of the Plan’s Committee. Participants are 100% vested in their employee contributions and increases or decreases earned or lost by the investment of their funds.

Vesting - Plan participants are immediately vested in any employer Safe Harbor Matching Contributions. For other employer contributions prior to the 2002 plan year, plan participants receive a year of credit toward vesting for each year with 1,000 hours of employment. Upon completion of three years of service, an employee becomes 100% vested in account balances arising from employer contributions (cliff vesting), other than Safe Harbor Matching Contributions. If an employee leaves prior to three years of service for reasons other than retirement, disability or death, the non-Safe Harbor matching Contributions from the employer are forfeited; however, funds contributed or rolled over by the employee are paid to the employee along with any “safe harbor matching contributions” and “qualified non-elective contribution” account balances arising from employer contributions and any increases or decreases, earned or lost, by the investment of these funds.

Payments of Benefits – Generally, distribution of participant accounts following termination of employment, retirement, death or disability of the participant is in a lump sum as soon as administratively feasible after receipt from the beneficiary of the required distribution forms. However, participants with account balances of \$1,000 or less may be distributed without receipt of a distribution election form from the participant.

Forfeitures - Participants who incur a termination of employment, but who are not 100% vested, forfeit the non-vested portion of their accounts arising from employer contributions, if they receive a distribution from the Plan prior to incurring a five-year break in service. A participant who rejoins an employer before incurring a five-year break in service and before receiving a distribution of the entire balance of their vested account balance obtains credit for previously forfeited account balances.

At December 31, 2024 and 2023, forfeited nonvested accounts were not significant.

1. **Description of Plan - (Continued)**

Notes Receivable from Participants – Participants may borrow a portion of their accounts. Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses – Certain expenses of maintaining the Plan, such as accounting and recordkeeping fees, are paid by the Employer at no cost to Plan participants and are therefore excluded from these financial statements.

2. **Summary of Significant Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments are carried at fair market values determined by reported values in active markets. Increases and decreases in fair market value of investments and realized gains and losses from investments are reflected in the financial statements as net appreciation or depreciation of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review - Subsequent events were evaluated through August 25, 2025, which is the date the financial statements were issued. Management has determined that no subsequent event disclosures are required.

Estimates - The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates in determining assets, liabilities, revenues and expenses. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are reported when paid.

4. **Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs are quoted prices in active markets for identical assets or liabilities and are considered the most reliable evidence of fair value; Level 2 inputs are observable prices that are not quoted on active exchanges; and Level 3 inputs are unobservable assumptions used for determining fair value and are considered the least reliable inputs for measuring fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and 3 inputs are only used when Level 1 inputs are not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair value of equities is based on the closing price reported on the active market where the individual securities are traded. Other assets consist of cash and money market funds that are valued based on quoted net asset values of the shares as reported by the fund.

5. **Party-in-Interest**

State Street Bank and Trust Company serves as custodian of the Plan and qualifies as a party-in-interest to the Plan.

8. **Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

8. **Tax Status – (Continued)**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress and the plan administrator believes that the Plan has no uncertain tax positions.
