We have performed audits of the accompanying financial statements of Rocket Industrial Employee's 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

### Note 1: Description of Plan

The following description of the Rocket Industrial Employee's 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Rocket Industrial, Inc (the "Employer"), except for union employees, non-resident aliens, and certain other classes of employees as defined in the plan document. An employee becomes eligible to participate in the Plan on the first entry date (first day of each month) following one month of service and attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Secure 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Contributions

Participants are allowed to contribute pretax compensation, as defined in the Plan, or Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible pretax compensation and their contributions invested in a designated fund until changed by the participant. Automatically enrolled participants will have their deferral percentage increased annually by 1% until a deferral rate of 15% is reached.

The Employer may make a discretionary matching contribution. During 2024, the Employer matched 50% of the first 6% of eligible compensation that a participant contributed to the Plan. These contributions are credited to eligible participants who have one year of service or complete 1,000 hours of service during the plan year. Rollovers are not matched. Catch-up contributions are matched. The Employer made discretionary matching contributions of \$368,345 for the year ended December 31, 2024.

#### **Contributions** (Continued)

The Employer may also make a discretionary profit sharing contribution as determined annually by the Employer. These contributions are allocated on a pro-rata basis as a uniform percentage of participant eligible compensation on the last day of the plan year. These contributions are credited to eligible participants who have completed 501 hours of service and are employed on the last day of the plan year. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's discretionary matching contributions, and allocations of the Employer's discretionary profit sharing contribution and plan earnings (losses), and charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Employer's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year and become fully vested after five years of service, or upon normal retirement age of 65, disability, or death.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a maximum of one loan with a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1.00%. The interest rates of existing loans range from 5.75% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, in partial withdrawals, or in equal installment payments if the participant's balance exceeds \$7,000. If the participant's balance does not exceed \$7,000, it will be distributed immediately following severance of employment in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary, matching, and profit sharing accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer's discretionary matching and discretionary profit sharing contributions. Forfeitures shall be used to reinstate previously forfeited account balances of participants, if any, to reduce Employer contributions, or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, unused forfeitures from nonvested accounts were \$2,221 and \$6, respectively. Forfeitures of \$11,315 were used to pay plan expenses during the year ended December 31, 2024.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. The Plan pays certain administrative and investment management fees. Fees related to the administration of benefits paid to participants and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### **Subsequent Events**

The Employer has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, due from broker, non-interest-bearing cash, and due to broker at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N A ("Alerus"), the Trustee of the Plan.

### Note 5: Party-In-Interest Transactions

Certain plan investments are managed by Alerus, the Trustee as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions.

Global Retirement Partners, LLC provides investment advisory services to the Plan which qualify as party-in-interest transactions.

Notes receivable from participants qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

### **Note 7: Tax Status**

The employer adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the non-standardized plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
