NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Danzer Group 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Danzer North America, Inc.; Danzer Lumber North America, Inc.; Danzer Forestland, Inc.; Danzer Veneer America, Inc.; (collectively, Company) who have attained the age of 18 and have completed one thousand (1,000) hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The service requirement for participation in the Plan includes automatic enrollment of all new hires who have attained an age of 18 and completed one year of service, or 1,000 hours. The initial deferral percentage for automatic enrollments is set at 3% of compensation with annual increases of 1% of compensation to a maximum contribution level of 8% of compensation. The BlackRock Lifepath Index funds are the default investments for automatic enrollments. Contributions are remitted to a specific BlackRock Lifepath Index Fund based upon the participant's birth year.

Contributions - Each year, participants may contribute a portion of compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment election for future contributions or the percentage(s) invested in each of these options, or transfer funds among these options on any business day. The Company's matching contribution is an amount equal to 100% of the first 3%, plus 50% of the next 2% of a participant's contributions to the Plan.

Participants' Accounts - Each participant's account is credited with the participant's contribution, Company contributions, and their pro rata share of Plan earnings or losses and administrative expenses based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. In addition, all amounts credited to a participant's account at the time of death, disability or retirement (as disability and retirement are defined in the Plan) are fully vested and nonforfeitable. Vesting in the Company's contribution portion of participant accounts is based on years of continuous service. Participants vest in the safe-harbor and discretionary contributions 20% per year of service and are 100% vested in these contributions upon completion of five years of service.

Notes Receivable from Participants - Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000. Notes are required to be repaid, through payroll deductions, within five years, except those notes used in the purchase of a primary residence. The notes are secured by the balance in the participants' accounts and bear interest at a rate commensurate with the local prevailing prime lending rate plus 1% at the time of the note.

Payment of Benefits - On termination of service due to retirement, disability, death or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic cash payments or a rollover to another qualified plan. Hardship distributions may also be granted in accordance with the guidelines of ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Forfeitures - Forfeitures of terminated participants' nonvested accounts are allocated in the following manner: (a) restore prior forfeitures to qualifying participants, if any, (b) offset Plan expenses and (c) reduce subsequent Company contributions. At December 31, 2024 and 2023, the Plan had forfeitures of approximately \$26,000 and \$17,000, respectively, to be used to offset future Company contributions or to pay for Plan expenses. There were no forfeitures utilized during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statements of changes in net assets available for benefits and the related notices to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are recorded at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses along with quarterly fees and benefit payment charges. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through September 15, 2025, the date that the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) topic Fair Value Measurements are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (i) quoted prices for similar assets or liabilities in active markets; (ii) quoted prices for identical or similar assets or liabilities in inactive markets; (iii) inputs other than quoted prices that are observable for the asset or liability or (iv) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuities - Prices/unit values for Variable Annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

Common/Collective Trust - Common/collective trusts include a stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that the securities liquidations will be carried out in an orderly business manner.

NOTE 4 - CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC (Empower), the trustee of the Plan.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual and stable value funds and trusts managed by Putnam Fiduciary Trust Company (Putnam). Putnam is a component of Empower, the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

NOTE 7 - TAX STATUS

The Plan adopted a prototype Nonstandardized Profit Sharing Plan (Prototype) with a cash or deferral arrangement. The IRS has determined and informed the Company by a letter dated November 14, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
