INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 - Description of Plan

The following description of the BWC 401(k) Savings Plan, (the “Plan”) formerly the Contanda LLC Savings Plan and prior to that the Westway Group, LLC Savings Plan, provides only general information. Participants should refer to the plan agreement for more complete information. BWC Terminal Holdings, LLC, (the “Company”), formerly Contanda LLC, adopted the Westway Group LLC Savings Plan on June 1, 2009. On November 1, 2016 the Plan’s name was changed to the Contanda LLC Savings Plan. In July 2020, the Company merged with BWC Terminals, Inc. and the Company changed its name to BWC Terminal Holdings LLC. As a result of this merger, the BWC Terminals, Inc. plan, the BWC Terminals, Inc. 401(k) Plan, (the “Merged Plan”) was merged into to the Plan (see Note 10) effective January 1, 2021 and the Plan’s name was changed to BWC 401(k) Savings Plan.

General

The Plan is a defined contribution plan covering eligible employees of the Company and the related participating employers and who have elected to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participating employees may contribute, through salary deferrals, a maximum of 50% of their annual compensation to their 401(k) accounts. Participants who have attained age 50 before the end of Plan year and have contributed the maximum amount permitted as a basic deferral for such year are eligible to make catch-up contributions. Participants may also contribute amounts representing distribution from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmably elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contribution investment in a designated balance fund until changed by the participant.

The Company matches 100% of the first 6% of eligible deferrals. Prior to May 1, 2018, the Company made fixed quarterly Portable Retirement Contributions (“PRC”) which are calculated as a percentage of quarterly compensation ranging from 0% to 6% based on years of service and eligibility qualifications and the Company also made fixed long service contributions for eligible employees as provided in the plan document. Effective May 1, 2018, the plan changed the PRC from a fixed contribution to a discretionary contribution and no longer makes long service contributions. The employer may elect each period whether to make these PRC discretionary contributions and the amount for each. For 2024, they elected to continue the previous contributions for eligible employees and the maximum contribution per person is \$10,000. Total employer contributions were \$3,805,369 for the year ended December 31, 2024.

Note 1 - Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the contributions they make to the Plan including salary deferrals and rollover contributions, plus actual earnings thereon. Participants are 100% vested in the Company's matching and PRC portions of their accounts plus actual earnings thereon after two and three years of service, respectively. Additionally, eligible employees who have reached the normal retirement age of 60 become 100% vested.

Benefit Payments

Upon retirement, death, disability, or termination of service, participants may elect to receive the vested portion of their account either in a lump-sum distribution or in periodic payments. The Plan allows for withdrawals on account of financial hardship to the extent that they do not exceed the immediate and heavy financial needs of the requesting participant. Limitations on withdrawals are outlined in the plan document.

In-Service Withdrawals

In certain circumstances, a participant may take distributions prior to retirement age under the "hardship withdrawal" rules. These funds are taxable distributions and are subject to a 10% income tax withholding rate unless the participant elects out of withholding.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of 50% of their vested account or \$50,000. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. At December 31, 2024 and 2023, interest rates on outstanding loans ranged from 4.25% to 9.50%.

Note 1 - Description of Plan (continued)

Forfeitures

At December 31, 2024 and 2023, the forfeited non-vested portion of terminated participants' account balances totaled \$58,935 and \$148,122, respectively. During 2024, \$158,946 of forfeitures was used to reduce the employer match and \$35,307 was used to reduce Plan expenses.

Investment Options

Upon enrollment in the Plan, participants may direct employee and employer contributions applicable to their account in investments offered by the plan which consist of mutual funds, a common collective trust fund and money market accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America. Benefit payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan's assets are invested in mutual funds and a collective trust fund. Shares of mutual funds are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. The collective trust fund is reported at fair value using the net asset value per share (or its equivalent) as a practical expedient.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment manager fees are netted against Plan investment income and are not separately reflected. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as

administrative expenses and are expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. In addition, employees and owners of the Company perform certain administrative functions. No such employee or owner receives any compensation for these services.

Benefit Payments

Benefits are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through September 23, 2025 which is the date the financial statements were available to be issued.

Note 3 – Tax Status

The pre-approved plan sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan document adopted by the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress.

Note 4 - Information Certified by the Trustee (Unaudited)

At December 31, 2024 and 2023, the Plan's investments were held by Fidelity Management Trust Company (Fidelity) (the "Trustee"). The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's financial statements and supplemental schedule include unaudited information that was prepared by the Trustee who has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Notes receivable from participants, as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Net appreciation (depreciation) in fair value of investments and interest and dividends as shown in the Statement of Net Assets Available for Benefits for the year ended December 31, 2024
- Information contained in the Schedule of Assets Held for Investments at December 31, 2024, as shown on the attached schedule.

Investments as presented on the statement of changes in net assets available for benefits for the year ended December 31, 2024 includes a realized gain of \$1,124,915.

Investments are all stated at fair market value and all are participant-directed except for \$58,935 and \$148,122 of forfeiture funds included in the Galliard Stable Return Fund C as of December 31, 2024 and 2023, respectively.

Note 5 – Related Party and Party in Interest Transactions

Certain plan investments held during the year were shares of mutual funds managed by the plan trustee or one of its affiliates, and therefore these transactions qualify as party-in interest transactions. Fees paid by the Plan to Fidelity Investments Institutional and other service providers for recordkeeping and other services amounted to \$67,833 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6- Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the hierarchy are described as follows:

- Level 1- Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date,
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3 inputs that are unobservable inputs for the asset or liability

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

Collective trust fund: Reported at fair value using net asset value per share (or its equivalent) as a practical expedient and not classified in the hierarchy in accordance with Accounting Standards Codification Subtopic 820-10. The net asset value of the fund is calculated daily, and units of the fund are issued and redeemed at the current net asset value.

The plan has no assets valued at level two or three under the fair value hierarchy.

Note 8 – Investment in Collective Trust Fund

The Plan invests in the Galliard Stable Return Fund C, a collective trust fund (the “Fund”) which seeks to provide investors with a moderate level of stable income without principal volatility. The Fund invests 100% of its assets in the Galliard Stable Return Fund Core, a collective trust fund (the “Core Fund”) which invests its assets in investment contracts and security backed contracts. Risks for these contracts include credit risks of the contract issuer, liquidity limitation risks due to the absence of an actively traded secondary market, and interest rate risk. There are no participant redemption restrictions for this investment, however if the Plan initiates a full redemption of the collective trust fund, the issuer reserves the right to require 12 months’ notification in order to ensure that the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 or 2023.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
