Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Raynor Garage Door 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective March 1, 1992. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective April 1, 2021. The Plan was originally established by the Company for all full-time nonunion employees of Raynor Mfg. Co. (the Company). Effective April 1, 2021, the Plan was amended to merge in the Raynor Mfg. Co. Bargaining Unit Employees' Retirement and 401(k) Savings Plan into the Raynor Mfg. Co. 401(k) Profit Sharing Plan and changed the name of the Plan to the Raynor Garage Door 401(k) Retirement Savings Plan. Therefore the Plan now includes all union and nonunion employees of Raynor Mfg. Co. as of April 2, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For the purpose of this Plan, for the period of January 1, 2021 – April 1, 2021 a trust known as the Raynor Manufacturing Company Employees Retirement and 401(k) Plan (the Trust) was created to receive all contributions and to pay all benefits under the Plan. For the purpose of this Plan, a trust known as the Raynor Garage Door 401(k) Retirement Savings Trust has been created to receive all contributions and to pay all benefits under the Plan.

The Company appoints a retirement plan committee which is responsible for the oversight of the Plan. The retirement plan committee determines the appropriateness of the Plan's investment offerings, monitors investments performance, and reports to the Plan Sponsor Board of Directors.

Empower Trust Company LLC has been named the Corporate trustee of the Plan by the Company and is responsible for the holding, investing, and disposal of all trust assets.

Eligibility

Participation in the Plan is extended to any individual who is in the service and employ of Raynor Manufacturing Company, excluding Directors of the Company not otherwise employed by it, employees of The Raynor Door Authorities Limited Partnership, Pro Door

Systems, Raynor Canada Corp., and other persons retained to perform independent professional or other services. Such individuals will become a participant in the Plan upon completion of 60 days of service with the Company and attainment of the age 18. Participants may enter the Plan immediately after meeting the eligibility requirements.

Contributions

The Plan permits voluntary contributions by participants at an amount between 1% and 50% of their compensation contributed as pre-tax, after-tax, or roth contributions, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from the other qualified benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions (Continued)

Effective July 31, 2015, The Plan began automatic enrollment for new hires as well as current employees that were not already participating in the Plan at a 4% deferral with annual increases of 1% each year up to a maximum of 10%. Employees deferring less than 4% prior to the effective date were subject to the 4% automatic enrollment while all employees deferring between 4% and 9% are subject to the annual 1% increase with a 30-day opt-out period. The 1% auto increase is effective each January 1st.

The Company may, at its discretion, elect to make a qualified matching contribution to the Plan. For the years ended December 31, 2024 and 2023, the Company matching contribution for nonunion employees was 50% of participant deferrals to a maximum of 4% of participant deferrals. The Company matching contribution for union employees is set based on the collective bargaining agreement entered into between the Company and the union. The collective bargaining agreement established the Company's match contribution at 20% of the employee's deferral contribution through March 2028. Matching contributions are invested in the same option as participant contributions at the participant's discretion.

The Company elected to not make discretionary profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023. Profit sharing contributions are invested in the same investment options as participant contributions at the participant's discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching and profit sharing contributions (if any), and an allocation of Plan earnings and is reduced for certain fees. Allocations are based on participant account balances. Certain transaction fees are charged against participant accounts, based on services requested by that participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus earnings. Participants' interests in their share of the Company's matching or profit sharing contributions vest in accordance with the following schedule based on years of service (a year of service is 1,000 hours during the period beginning on the date an employee first performs an hour of service and each anniversary period thereof):

<u>Years of Service</u>	<u>Vested Percent</u>
Less than 1	0 %
1 but Less than 2	33
2 but Less than 3	66
3 or More	100

If an active participant dies prior to attaining normal retirement age, the participant's vesting percentage shall be 100%. Full vesting also occurs upon attainment of normal retirement age or termination of employment due to disability.

Vesting (Continued)

All participants from the Raynor Mfg. Co. Bargaining Unit Plan were credited with their existing vesting service upon the merger of assets into the Raynor Garage Door 401(k) Retirement Savings Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

Forfeitures from less than 100% vested accounts are used to offset Company discretionary contributions and to pay for administrative expenses. Forfeited nonvested accounts used to offset Company contributions or to reduce administrative expenses were \$33,362 and \$14,880 for the years ended December 31, 2024 and 2023, respectively. Forfeited nonvested accounts available to offset future Company contributions or to reduce the administrative expenses were \$46 and \$42 at December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are shared by the Plan and the Company. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Empower Trust Company, LLC, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access;

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Fund – Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Trust Company LLC., the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are paid by Plan assets to a third-party provider and asset fees and participant incurred fees are paid with Plan assets to the recordkeeper. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
