INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
KC 1, Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the KC 1, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures

in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the KC 1, Inc. Retirement Savings Plan (the "Plan"), formerly known as Kids Count, Inc. Retirement Savings Plan prior to a November 21, 2024 amendment that retroactively renamed the Plan effective January 1, 2023, is provided for general information purposes only. Plan participants should refer to the plan document or summary plan description for more complete information.

General - The Plan, established May 1, 2006 and amended and restated effective April 1, 2021, is a contributory, defined contribution plan established to provide benefits upon retirement or permanent disability to eligible participating employees of KC 1, Inc. (formerly Kids Count, Inc.) and Family Psychological Associates, LTD (the "Companies") or to their beneficiaries upon death of the participant. The Plan is administered by the Companies and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - The Plan is available to all employees of the Companies who meet the eligibility requirements. Eligible employees are those who have attained the age of 21 and completed three months of service. Employees become eligible beginning on the first day of the month that coincides with the date that they meet the eligibility requirements.

Contributions - Participants may elect to contribute a portion of their pretax compensation each year to the Plan via salary deferrals, subject to certain limitations under the Internal Revenue Code. Employee contributions are recorded in the period during which payroll deductions are withheld from the Plan participants' earnings.

The Companies match, under a safe harbor provision, 100% of the first 3% plus 50% of the next 2% of each participant's deferred compensation. The Companies may also make discretionary nonelective contributions based on a percentage of compensation. There were no nonelective contributions for the year ended December 31, 2024 or 2023.

Participant Accounts - Each participant's account is credited with participant contributions, employer contributions and an allocation of investment income (loss) of the elected investment fund(s). Allocations of fund earnings to the participant accounts are based upon the ratio of each participant's account balance to the total of all participant account balances in the fund. The benefit to which a participant is entitled is the value of the participant's vested account.

Investment Options - Participants may direct their contributions and employer contributions into various investment options and may change their investment options at any time.

Vesting - Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Discretionary nonelective employer contributions plus actual earnings thereon vest in accordance with the following schedule:

Participants are 100% vested in the event of total disability, death or upon reaching retirement age.

Payment of Benefits - On termination of service or upon attainment of age 59½, and subject to certain restrictions, a participant may elect to receive an amount equal to, or less than, the value of the participant's vested interest in his or her account in the form of a lump-sum payment, subject to tax withholding requirements; a qualified rollover; or installment payments. The Plan further provides for hardship withdrawals except that account balances resulting from certain types of contributions are not eligible. Benefits are reflected when they have been approved for payment and are paid by the Plan.

Forfeitures - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account related to employer contributions may be utilized to reduce administrative expenses of the Plan or reduce future contributions from the Companies. Forfeitures were not significant for the years ended December 31, 2024 or 2023. Available forfeitures were \$9,691 and \$5,575 at December 31, 2024 and 2023, respectively.

Administrative Expenses - The administrative expenses of the Plan are paid by the Companies.

Basis of Accounting - The accompanying financial statements of the Plan are presented on the accrual basis of accounting using accounting principles generally accepted in the United States (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and disclosure of

contingent assets and liabilities, if any, at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. Interest, dividends and capital gain distributions are recorded as earned. Purchases and sales of securities are reflected on a trade-date basis. Any gain or loss on sales of securities is based on the specific cost of the securities sold.

The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains and losses and the net unrealized appreciation or depreciation on those investments in the statement of changes in assets available for benefits.

The Plan's group annuity contract is reported at contract value, which is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract (see Note 5).

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The pooled separate accounts are invested in mutual funds, which are valued using publicly quoted pricing inputs. The fair value of the underlying investments are used to determine the net asset value (NAV) of the pooled separate accounts. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and the pooled separate accounts can be redeemed at NAV

as of the measurement date. Therefore, the pooled separate accounts have a readily determinable fair value (level 1).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Plan assets include various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and the statements of changes in assets available for benefits.

Notes Receivable from Participants - The Plan administrator may authorize a loan to a participant for an amount not to exceed the lesser of 50% of the vested balance of the participant's account or \$50,000 from their account. Loans must be at least \$1,000 and are secured by the vested balance in the participant's account. Notes receivable documenting the loans bear interest at a rate similar to the rate charged for a loan made under similar circumstances by persons in the business of lending money. The notes are generally required to be repaid over a five-year period in equal installments; however, the term may be extended if the intended use of the funds is to acquire a principal residence. There were \$63,726 and \$92,590 in notes receivable from participants at December 31, 2024 and 2023, respectively. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 3.25% to 8.25%.

Subsequent Events - Management has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued.

2. CERTIFIED FINANCIAL INFORMATION

Empower Annuity Insurance Company of America (Empower), the custodian, has certified that the following data included in the financial statements as of and for the years ended December 31, 2024 and 2023 is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of assets available for benefits.
- Investment activity and interest income on notes receivable as shown in the statements of changes in assets available for benefits.

- The schedule of assets held for investment purposes as shown on the accompanying supplemental schedule.

3. TAX STATUS

The Plan is in the form of a non-standardized, pre-approved plan for which the sponsoring organization obtained a letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the Plan is acceptable for use by employers under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Companies believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for tax years before December 31, 2021.

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Companies reserve the right under the Plan to discontinue contributions at any time and to terminate the Plan. Any termination of the Plan cannot adversely affect the vested benefits accrued by the participants prior to the date of termination. The participants' interests in the Plan as of the date of the termination become fully vested and nonforfeitable.

5. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive group annuity contract with Mass Mutual Life Insurance Company (Mass Mutual), which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Mass Mutual is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Mass Mutual. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy

of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The group annuity contract does not permit Mass Mutual to terminate the agreement prior to the scheduled maturity date.

6. RECONCILIATION OF THE FINANCIAL STATEMENTS TO FORM 5500

Neither the Companies nor the employees of the Companies involved in administering the Plan receive any compensation from the Plan.
