2. **Normal Retirement Date:** Age 62 or the fifth anniversary of plan participation if later.
3. **Early Retirement Date:** None.
4. **Average Compensation:** The average of total compensation during the 3, or lesser-completed, consecutive plan years of participation in which the member is most highly paid.
5. **Normal Retirement Benefit:**

For Lloyd Ambinder: The sum of the Accrued Benefit as of December 31, 2006 and a benefit formula of 3.75% of Average Compensation multiplied by the participant's years of plan participation after January 1, 2007 to a maximum of 35 years.

For Charles Virginia: The sum of the Accrued Benefit as of December 31, 2006 and a benefit formula of 4.20% of Average Compensation multiplied by the participant's years of plan participation after January 1, 2007 to a maximum of 35 years.

For all other participants: The sum of the Accrued Benefit as of December 31, 2006 and a benefit formula of 0.50% of Average Compensation multiplied by the participant's years of plan participation after January 1, 2007 to a maximum of 35 years.

The vested portion of this benefit is then reduced by the actuarial equivalent of the vested portion of the participant's account balance attributable to employer contributions in the Virginia and Ambinder, LLP 401(k) Profit Sharing Plan.
6. **Early Retirement Benefit:** The plan does not provide an early retirement benefit.
7. **Accrued Benefit:** Same as Normal Retirement Benefit.
8. **Standard Form of Retirement Benefit:** Life Annuity. If the Participant is married the benefit must be converted to an actuarially equivalent Joint and Survivor Annuity, unless elected otherwise with spousal consent. Other forms of benefit are available on an actuarially equivalent basis.
9. **Disability Benefit:** Upon retirement due to Total and Permanent Disability, the Actuarial Equivalent of Accrued Benefit is payable.
10. **Death Benefits:** Upon death prior to retirement, actuarial present value of Accrued Benefit is payable (in the form of a Pre-Retirement Survivor Annuity unless elected otherwise with Spousal Consent).
11. **Termination of Employment:** Upon termination of employment prior to retirement, death, or disability, the vested Accrued Benefit is payable at Normal Retirement Date.
12. **Vesting:** Vested in the accrued benefit based on years of service. 0% for less than 1 year, 20% after two years, increasing by 20% per year to 100% after 6 years. A year of vesting service is credited for each Plan Year in which an employee completes at least 1,000 hours of service. Years of Service prior to age 18 are excluded.

SCHEDULE SB, LINE 24 – CHANGE IN ACTUARIAL ASSUMPTIONS

The pre-retirement actuarial equivalence rate used to project the vested portion of participants' account balances attributable to employer contributions in the Virginia and Ambinder, LLP 401(k) Profit Sharing Plan was changed from 3.66% as of December 31, 2023 to 4.15% as of December 31, 2024, to reflect the 30-year Treasury Security Rate applicable as of the respective valuation dates.

The assumed post-retirement actuarial equivalence rate was changed from 3.66% as of December 31, 2023 to 4.15% as of December 31, 2024 to better reflect anticipated 30-year Treasury Security Rates.

The changes in assumption do not result in a significant decrease in the plan's funding shortfall, as defined in section 430(h)(5)(B)(ii) of the Code.
