- A) Eligibility - All employees are eligible to participate on their date of hire.
- B) Benefit Formula - 10% of Average Annual Compensation per year of participation (to a maximum of 25 years) for the President of the Employer.
- 2% of Average Annual Compensation per year of participation (to a maximum of 25 years) for all others.

C) Accrued Benefit - The participant's Normal Retirement Benefit earned to date.

D) Termination of Employment - In the event of termination of employment, a participant shall have a nonforfeitable interest in the Accrued Benefit based upon his years of service to date of termination and compensation in effect at such date; such vested percentage is as follows:

6 or more	100%

E) Death Benefit -

Should a participant die prior to retirement, the beneficiary will receive the actuarially determined reserve plus the death benefit provided by any insurance policy on the participant's life less any cash value at date of death. If no option has been elected as of the date of death, the beneficiary has the right to determine the time and manner of payments. Should a participant die after his retirement, the beneficiary shall receive any remaining amounts payable under the payment option in effect.

SCHEDULE 6

I. Actuarial Cost Method

Unit Credit Funding Method - Under this method, the benefit accrual for the current year is funded by contributing the present value equivalent of the amount needed at normal retirement date to fund the benefit.
